# **Cuncolim's toxic waste sparks** fear of health hazard

Locals demand legal action against industrial units responsible for dumping hazardous material; call for an urgent site inspection and clean-up operation

MARGAO: Alarmed over the hazardous waste found dumped into the open at the Cuncolim Industrial Estate, the residents of Cuncolim fear significant environmental and health repercussions due to alleged blatant negligence by industrial units and relevant authorities particularly with the onset of the

Expressing grave concern, Cuncolim resident and activist Aviraj Dessai, who brought the issue to public attention, said, "Toxic waste is lying completely exposed, with rainwater washing through it. The exposed waste, reportedly generated by some units operating within the estate, has sparked fears of water contamination, soil degradation, and public health hazards. Dessai has urged immediate action by the Goa State Pollution Control Board (GSPCB) and other regulatory agencies.

"Every year, it's the same story. Waste mismanagement, zero enforcement, and the public pay the price," said Priya Naik, a resident.

# Tilting vessel poses threat to marine

MARGAO: The Cavelossim Village Panchayat has called for immediate intervention after spotting a vessel tilting dangerously in the Mobor-Betul channel, warning that it could sink and pose a serious risk to the marine ecosystem and coastal activity.

In a letter dated May 26, addressed to the South Goa Collector, Deputy Collector, and Captain of Ports, the panchayat stated that the vessel appears to be connected to an ONGC research-related activity and is now listing in a manner that demands urgent at-

The fear of a maritime incident has grown stronger in light of worsening weather conditions. "In Kochi, a boat has already capsized due to bad weather," Vaz noted, expressing concern that heavy rains in Goa could lead to a similar situation if the listing vessel is not dealt with in time.

The situation is especially critical given that this is the final week of the fishing season, which officially ends on May 31. Many boats are still venturing out or returning to shore, making the Mobor-Betul channel a key passage. The presence of the stranded vessel in this stretch raises serious safety concerns.

## South Goa District Hospital preps up to enforce Covid precautionary measures

#### Sewage water discharge at Navelim triggers fresh concerns

**MARGAO:** The onset of the monsoon has once again highlighted the issue of sewage water being discharged into roadside gutters at Mandopa, Navelim, triggering renewed concerns over pollution of the Sal tributary.

During a site visit, Navelim resident and High Court Public Interest Litigation (PIL) petitioner Professor Antonio Alvares pointed to a concealed pipe releasing dark water into an uncovered gutter. "This was exposed only because the gutter was left open. Otherwise, this method of releasing sewage into roadside drains appears to be widely used." he said.

Mocking the setup as a form of advanced engineering, Alvares remarked, "The ancient technology used here is clearly superior to the Japanese JICA model. This pipe discharges sewage into drains that ultimately pollute the Sal. This so-called infrastructure is being replicated elsewhere."

He claimed the practice is widespread, including in Margao where most drains are covered. "Unless the Margao Municipal Council physically inspects every outlet from each home and commercial establishment, this will continue." he warned

#### Margao council directs 12 applicants to follow up with sewerage corp

MARGAO: Residents of 12 households near the Old Model High School expressed frustration after being told by the Margao Municipal Council (MMC) to follow up with the sewerage corporation regarding their sewage connection applications, instead of a solution.

A hearing was held be-fore MMC Chief Officer Melvyn Vas, where residents were served notices for allegedly failing to connect their homes to the sewage system and discharging wastewater into drains. However, the residents complain they are being unfairly targeted, as

no sewage pipeline exists in their locality to facilitate such connections.

The civic body's notices accuse homeowners of releasing wastewater into storm water drains, which pollutes nearby fields and Salpem Lake in Navelim. The residents, however, have described these accusations as unjustified and irrational.

Speaking to reporters after the hearing, local resident Anthony Pereira said the MMC asked them to follow up with the Sewerage Department regarding their pending connection applications.

"We have been served notices by the MMC, but instead of addressing our

concerns, the civic body is directing us to the sewerage corporation," he said.

Pereira added that their applications have been pending for over a month, with officials informing them orally that no sewage pipeline exists in the area to provide connections.

"If that's the case, why are we being targeted? The authorities should first install the sewage pipeline. We are ready to connect, but until then, issuing notices without a solution is unfair," he urged.

The residents are calling on the MMC and sewerage corporation to coordinate and resolve the infrastructure gap before taking pu-

#### NH 66 expansion: Chinchinim locals await meeting with Gadkari

MARGAO: Residents of Chinchinim, especially those from the Danddevaddo area, continue to await an appointment with Union Minister for Road Transport and Highways, Nitin Gadkari, to voice their long-pending concerns regarding the proposed expansion of NH 66.

The proposed expansion spans a 6.5 km stretch between Cuncolim and Navelim. Locals fear that hundreds of trees lining both sides of the road will be felled to make way for the widened highway, severely impacting the environment and disrupting their daily lives.

### Chinchinim, Sirlim, Sarzora locals hit by frequent power cuts

**Demand urgent measures** to resolve the issue



MARGAO: Raising serious concerns over the frequent power outages, the residents Chinchinim-Deussua, Dramapur-Sirlim and Sarzora village panchayats have complained that these persistent disruptions have significantly impacted their dai-

ly lives and essential services. Representatives from the three village panchayats recently met with the Executive Engineer at Aquem-Margao, demanding urgent and effective measures to resolve the issue.

Chinchinim-Deussua sarpanch Frank Viegas said that constant power failures have become a major problem for the residents. "These outages are not only affecting homes and businesses, but also hampering essential services. The situation becomes worse during monsoon, when electrical faults are frequent," he said.

Emphasising the need for additional manpower, especially at night, Viegas called for a dedicated vehicle and ladder for emergency repairs, and stressed the importance of regular tree trimming to prevent

damage to power lines. He pointed out that the electricity department section at Chinchinim, which caters to a large area, including Chinchinim-Deussua, Dramapur, Sirlim, and Sarzora, puts

an immense burden on limit-

ed staff and resources.

Dramapur-Sirlim deputy sarpanch Avita Vaz highlighted the difficulties faced by villagers during power cuts, particularly at night. "The outages are a major inconvenience, especially when there are no staffers available during the night to respond to complaints. This leads to long delays in restoring power supply, which affects the livelihood of residents," she said.

Vaz urged the electricity department to strengthen its night shift team and assign a dedicated service vehicle to Dramapur.

"Improving response time and reducing the pressure on the current team is essential." she added. Both panchayats are united in their demand for better infrastructure and faster response mechanisms. Villagers hope that the department will act swiftly to prevent the situation from worsening, particularly during monsoon.

# Abrupt end to housie at Raia football final leaves enthusiasts enraged

Spectators allege discriminatory enforcement by authorities; claim housie is a vital fundraising tool for clubs as it helps them cover basic costs and organise tournaments

MARGAO: A housie organised during the inter-village football final at Raia Ground was abruptly stopped on Sunday after a police team, along with the Joint Mamlatdar, arrived at the venue and enforced a ban, leaving players, organisers, and spectators dismayed.

The incident sparked outrage among football enthusiasts and local club members, who alleged disby authorities. They point-

ed out that similar housie games had recently taken place at other football events in Salcete without any interference.

Accusing the authorities of targeting grassroots football efforts unfairly, he said, "This is not an isolated issue. There seems to be a pattern of discrimination and unnecessary restrictions imposed on local sports events." Colaco alleged that such actions are damaging the morale of organisers and dampening the spirit of the game.

Colaco appealed to Chief Minister Pramod Sawant to step in and direct officials to allow clubs to conduct housie during football tour-

naments, especially when they play a crucial role in sustaining local sports infrastructure.

"The government must recognise the importance of community-driven events. If clubs aren't supported or allowed to raise their own funds, football at the village level will suffer," Colaco concluded.

The incident has once again reignited the debate over how local sporting bodies are treated and the need for consistent policies to support grassroots sports in Goa.
