Usgao panch slams meat complex over foul stench

PONDA: Usgao-Ganiem Panch Manisha Usgaonkar has raised strong objections to the persistent foul odour in areas surrounding the Goa Meat Complex, alleging that improper disposal of waste from buffalo slaughter is to blame. Usgaonkar, who is also a Congress leader, criticised the government's failure to address the stench problem, despite exporting meat produced at the complex. "The government is exporting meat, but locals are forced to live with the stench from improperly disposed animal waste," she said. She also questioned the silence of certain organisations that previously targeted the Congress government over cow slaughter. "Where are the protests now?" she asked, referring to past demonstrations involving saffron flags and accusations of the Congress being an anti-Hindu government. Usgaonkar further highlighted that despite a shortage of beef for Goan consumers, the government is reportedly slaughtering 300 buffaloes per day for export, primarily to Iraq and Iran.

Agonda resident declared dead at Balli Primarv Health Centre

The body has been sent to the South Goa District Hospital morgue, Margao, for medico-legal procedures. Cuncolim PSI Tejeskumar Naik is investigating.

House damaged in tree crash near Nessai railway gate



MPA resumes operations after 60-hour suspension due to cyclone alert

VASCO: The Mormugao Port Authority (MPA) resumed its port operations on Saturday after a suspension for almost 60 hours, following a cyclone formation alert issued earlier this week. The MPA Operations were halted in response to a cyclone formation reported by the India Meteorological Department (IMD) along the North Karnataka and Goa coast on May 21. In line with safety protocols, the MPA had issued a circular directing all ocean-going vessels to sail out to sea and comply with the standard operating procedure (SOP) to ensure port and navigation safety. In view of the prevailing weather conditions and in the interest of port and navigation safety, the MPA ceased all port operations.

Advocacy meet to step up vector-borne disease prevention

MARGAO: With the monsoon season beginning, the Primary Health Centre (PHC) at Loutolim convened an advocacy meeting to strengthen community-level action against vector-borne diseases such as dengue, malaria and chikungunya. The meeting was chaired by PHC Health Officer Dr Vinesh Gaunkar and brought together representatives from various village panchavats in the area. Among those present were Rachol Sarpanch Joseph Vaz, former Camurlim Sarpanch Basilio Fernandes, panchayat secretaries and others. The PHC's sanitary inspector provided a detailed presentation on the dangers of mosquito bites and the importance of preventing breeding through timely action.

six months later, there has been no action from the police. Her vehicle is still at the station, while the accused took his vehicle home the very same day. This, despite the fact that he claimed to be a government officer and said nothing would happen to him," she added.

"What are we to understand from this? This is not an isolated case. In Pernem. a molestation case involving a Dalit girl was registered only after public outcrybecause the accused was a government servant. The victim should have been helped immediately. Instead, she had to approach the Mahila Congress or an NGO. Why is it that victims must seek external intervention for justice? Is she not a citizen with rights?"
