Early monsoon wreaks havoc across the country

Mumbai sees earliest monsoon onset in 75 years; Aqua Line station inundated; red alert issued in Karnataka, NDRF teams deployed; relief camps opened in Kerala

PTI, MUMBAI: One person died in a lightning strike, while 48 people were rescued from inundated areas as heavy rains battered several places in Maharashtra, including Mumbai, on Monday, the office of Chief Minister Devendra Fadnis said.

"Pune, Satara, Solapur, Raigad, Mumbai and MMR (Mumbai Metropolitan Region) have received heavy rainfall. Daund received 117 mm of rain in 24 hours, Baramati 104.75 mm, while 63.25 mm was recorded in Indapur," the statement said.

It said 25 houses partially collapsed in Baramati, while seven persons trapped in flooded areas were rescued. "70 to 80 families have been shifted to safer places. Mobile services that were disrupted yesterday are now being restored," the CM's Office said.

Two persons were rescued from an inundated spot in Indapur in Pune district. A team of the National Disaster Response Force (NDRF) has been deployed in Phaltan in Satara district, which received 163.5 mm of rain.

"Thirty citizens were stranded near Dudhebavi village. They have been provided with accommodation and food facilities," it said.

In Solapur, which received 67.75 mm of rain in 24 hours, six citizens were

trapped in floods in Malshiras taluka, the CMO said. They have been shifted to a safer place. Efforts are underway to rescue three people trapped in the Bhima river bed in Pandharpur, it said.

One person died after being struck by lightning in Raigad district, while the Mahad to Raigad Fort road has been closed due to heavy rains.

as due to ongoing highway construction works. Meanwhile, fishing boats that had ventured out early in the season are returning to the New Mangalore Port due to unfavourable sea conditions.

NORMAL LIFE DISRUPTED IN KARNATAKA

Heavy monsoon rain in Karnataka, lashing over the coastal belt for the third consecutive day on Monday severely disrupting normal life in Dakshina Kannada

district, prompting authorities to issue a red alert and deploy disaster response teams.

The red alert for coastal Karnataka will remain in force for the next five days, the IMD said.

Several parts of Mangaluru city reported waterlogging and traffic snarls as the drainage systems failed to cope with the downpour.

According to officials, minor incidents of landslides were reported from hilly regions across the district.

Major incidents of waterlogging have been reported from Kottara junction, Malemar, Mahaveera circle in Mangaluru city, while smaller inundation have been reported from Urva, Matadakani, Kudroli, Kodialbail(west) in the city.

Thokkuttu, Goodinabali, Marakada, Panamburu and adjoining places were also

waterlogged.

Dakshina Kannada's acting Deputy Commissioner Anand K, said that all Anganwadi centres in the district were closed on Monday due to incessant rainfall. The India Meteorological Department (IMD) has forecast continued heavy rain over the next 48 hours across the coastal region.

According to the district administration, rainfall figures over the past 24 hours crossed 150 mm in multiple areas, with Sullia's Bellare recording the highest at 200.5 mm, followed by Bantwal's Sarapady and Puttur's Belandur with 190 mm each.

In view of the worsening conditions, one team of the National Disaster Response Force (NDRF) has been stationed in Puttur, while two State Disaster Response Force (SDRF)

teams have been deployed in Mangaluru and Subrahmanya. Officials have been directed to remain on high alert.

4 LIVES LOST, 29 HOUSES DESTROYED IN KERALA

Meanwhile in Kerala, Heavy downpours continued to wreak havoc in Kerala on Monday, forcing people to shift to relief camps and safer locations in many places.

According to the Chief Minister's Office, the intense monsoon has claimed four lives in the state so far.

As many as 29 houses were destroyed and 868 houses partially damaged across Kerala, the CMO said.

Five relief camps were opened in Wayanad district and one each in Idukki and Kozhikode districts, it added.

As the southwest mon-

soon intensified two days after its early onset in the state, almost all districts experienced heavy downpours and strong winds, disrupting power supply, inundating homes in low-lying areas, and causing traffic disruptions.

As per reports from across the state, incessant rains have caused widespread uprooting of trees, affecting villages, towns, and high ranges, while swollen water bodies threatened residents in several districts.

While uprooted trees fell upon railway tracks, partially impacting the movement of trains on some routes, waterlogging caused traffic snarls on inland village paths and city roads alike.

Rail traffic was partially affected due to trees falling in various places, and the traffic was restored after

removing the obstructions, authorities said.

Trees fell in various sections, including Guruvayur-Punkunnam, Ernakulam South-Ernakulam Town, and Ambalappuzha-Alappuzha, as well as in Tiruvalla Yard, a railway statement said.

With intense rains continuing, a number of tribal families from Puzhamkuni hamlet in Wayanad's Sultan Bathy were moved to relief camps,

district authorities said on Monday.

Australian Certificate of Education to offer curriculum in Indian schools from 2025

NEW DELHI: The Association of Indian Universities (AIU) has granted foreign board equivalence to the Western Australian Certificate of Education (WACE), paving the way for the curriculum to be formally introduced in Indian schools, according to officials. WACE is a globally recognised senior secondary curriculum from the Australian government. The School Curriculum and Standards Authority (SCSA), a statutory body of the Government of Western Australia, administers the WACE programme. With over 37 years of delivery across over 16 countries, including Singapore, China, Japan, and Malaysia, WACE is known for its future-ready curriculum that emphasizes academic depth, skills development, and global university pathways.

UP: Man tricks cops by using fake release order to get his truck back

BHADOHI: case has been registered against a man who got his truck released from a police station by showing an alleged fake release order along with the fake signature of a mine inspector, the police said on Monday. The accused, identified as Siddhant Pal, a native of Jaravan Pahara village in Mirzapur district, sent the release order allegedly issued by the mining department to the District Magistrate's office (mining section) for confirmation. Based on the complaint by the head clerk, a case was registered against Pal under Sections 318(4) (cheating), 319(2) (impersonation), 336(3) (forgery), 338 (forgery of valuable security, will, etc.), 340(2) (forged document or electronic record and using it as genuine) of the BNS on Sunday, Aurai Police Station SHO Ram Sarikh Gautam said.

3 militants arrested in Manipur for extortion

PTI, IMPHAL: Security forces have arrested three militants, belonging to various proscribed outfits, in Manipur for allegedly being involved in extortion activities, police said on Monday. One cadre of the banned United National Liberation Front (Pambei) was apprehended from Moirang Sandra Road in Bishnupur district on Saturday, a senior officer said.

The militant was accused of being directly involved in demanding money from local businessmen and several government institutions in the district and also in Imphal, he said.

UNLF (Pambei) had signed a peace pact with the Centre in November 2023, but its members have been arrested for "extortion and other criminal activities", the officer said.

Covid's new variant has only viral fever symptoms, no need to panic: Delhi health minister

PTI, NEW DELHI: Delhi Health Minister Pankaj Singh on Monday said Covid caused by the new variant has only shown symptoms of viral fever so far, and urged people not to panic. He said the government has sent a health advisory to hospitals telling them to be prepared for any eventuality, but it was just a precautionary step and not a sign of alarm. "We have advised hospitals to be ready with beds, oxygen, essential medicines, and equipment - just in case. This is part of standard preparedness, not because the situation is serious," he said.

"There is no need to worry. Covid caused by the new variant is similar to a normal viral illness. The patients who have come in so far are experiencing mild symptoms like fever cough and cold," Singh told PTI.



The minister reassured people that Delhi government hospitals, doctors, and medical staff are fully equipped and ready to respond if needed.

"There is no cause for concern. Everything is in place. The advisory was issued so that we are prepared, not because there is any emergency," Singh added.

The health department reported 104 active COVID-19 cases in the city on

Monday. INSCOG data showed NB.1.8.1 and LF.7 variants of Covid have been detected in India.

As of May 2025, the World Health Organization (WHO) classifies LF.7 and NB.1.8 subvariants as Variants Under Monitoring, not as Variants of Concern or Variants of Interest. But these are the variants that are reportedly driving the rise in Covid cases in China and parts of Asia.

NIA arrests CRPF personnel for spying for Pakistan

PTI, NEW DELHI: The National Investigation Agency (NIA) has arrested a CRPF personnel for allegedly spying for Pakistan, officials said on Monday. The accused, Moti Ram Jat, was actively involved in espionage activity and had been sharing classified information related to national security with the Pakistan intelligence officers (PIOs) since 2023, they said.

Jat, an assistant sub-inspector with the Central Reserve Police Force (CRPF), was receiving funds from the PIOs through various conduits, officials said.

The anti-terror agency has arrested Jat from Delhi and is interrogating him, they said.

Meanwhile, the CRPF said it has dismissed him from the service.

Jat came under the scanner in the course of close monitoring of his social media activity by the CRPF, in coordination with the central agencies, during which he was found to have "acted in violation of established norms and protocols," according to a statement issued by the CRPF.

He was handed over to the NIA for further inquiry, it said.

"Concurrently, the individual has been dismissed from service with effect from 21.05.2025, under the relevant provisions of the Constitution of India read with the CRPF Rules," the statement said.

Jat was produced before a special court here which has remanded him to the NIA custody till June 6.
