# **GOVT SIMPLIFIES BIFURCATION** OF HOUSE NUMBERS IN VILLAGES

Applications to be processed within fortnight and to include NOCs for water and electricity connections for new assessee

PANJIM: The Directorate of Panchavats on Wednesday issued a circular simplifying the process of issuance of bifurcation of house numbers to existing dwelling houses in village panchayats jurisdiction.

Such application will be disposed within 15 days from date of receipt along with issuance of NOC for water connection and electricity connection in the name of new assessee.

Addressing post-cabinet briefing, Chief Minister Pramod Sawant said that the purpose of issuance of house number to such applicant is to give separate identity to the portion of dwelling house and is merely fiscal in nature for taxation purpose which does not confer upon him any title of the property/ portion of the dwelling house, he clarified.

The village panchayats will only insist for application from co-occupier appli-

### **BIFURCATION DOES NOT CONFER PROPERTY TITLE: CM**

Chief Minister Pramod Sawant clarified that this bifurcation is for fiscal purposes only and does not confer property title. Village panchayats will require an application in Form 'A' from the co-occupier, along with a dimensioned sketch of their occupied portion

### **REQUIRED DOCUMENTS**

Existing house tax copy; death certificate of the original assessee (if applicable); the applicant's birth certificate or proof of linkage (e.g., bank passbook, ration card); Form 'A'; sketch of the occupied portion; and Form I & XIV

The applicant will have to submit following documents such as house tax copy of existing house number; death certificate of father, mother or origi-

nal house tax assessee, as the case may be; birth certificate of applicant or any other document showing linkage with the original house tax assessee/house number such as bank pass book, ration card etc; Form 'A'; sketch of portion of house under occupation of the applicant and Form I &

bifurcation house number will contain the original house number with suffixes as /A', /B' etc.

The portion to which bifurcation house number is issued shall be necessarily a contiguous portion of the existing dwelling house recorded in Form 7 (Assessment Register) & Form 8 (Demand and Collection Register, having separate arrangements kitchen within the same house. The Village Panchayat will also carry out inspection of the house to ensure that particulars furnished by the applicant are correct.

The new process will be implemented from Monday, June 2 and will be free of cost, the Chief Minister

Separate house tax and garbage tax will be levied for the newly bifurcated house numbers, Sawant said, adding that similar circular will also be issued by the Directorate of Urban Development for issuance of bifurcation of house numbers to existing dwelling houses situated in the municipal limits in near

The residents believe that the increased nuisance is due to visitors discarding garbage and waste food into the river.

Furthermore, they observed that the construction of the new Panchayat Ghar does not align with the approved plan and have requested the local body to direct the contractor to adhere to the original design.

# Minor's dad, pillion rider held in Mapusa fatal hit-and-run case

MAPUSA: The Mapusa Police have arrested Shabbir Kassim Shaikh (48), father of a 16-year-old boy and Reehaan Shaikh (18), the pillion rider allegedly involved in the fatal hit-and-run case at Peddem, Mapusa.

The minor who was riding the two-wheeler fatally knocked down a 12-yearold Akanshaya Boro while she was crossing the road near Camarkhajan, Mapusa on Tuesday late evening. The girl succumbed to her injuries at the North Goa District Hospital, Mapusa.

Both the minor (Child in Conflict with Law - CCL) and Reehan fled the scene after the collision without informing the police or providing any medical aid to the victim. They also attempted to conceal the

damaged vehicle, informed police. A report against the minor will be sent to the Juvenile Justice Board, police

Later, the police arrested the father for giving the two-wheeler to the minor, who did not possess a valid driving licence.

Despite being fully aware that the CCL was unlicensed, Shabbir allowed his minor son to ride the

two-wheeler on a major public road, posing a serious threat to public safety. Pillion rider Reehaan also knew the minor was not licenced but still accompanied him.

The Mapusa Police registered a case under BNS 2023 and Motor Vehicle

The case has been forwarded to the Judicial Magistrate First Class (IMFC). Mapusa, and further investigation is ongoing.

Meanwhile, the Goa Police have appealed to all citizens to refrain from allowing unlicenced minors to operate motor vehicles. # Dilapidated Shivaji Fort at Farmagudi requires urgent attention

Entrance wall has developed cracks, and sections of the side walls are collapsing; Rs 100 cr reconstruction plan proposed

PONDA: The historic Shivaji Fort at Farmagudi lies in a dilapidated state and is awaiting urgent government intervention. The entrance wall has developed cracks, and sections of the side walls have been collapsing during the monsoon over the past two years.

Concrete benches and tiled flooring too have deteriorated significantly due to prolonged neglect.

The fort is situated in a prime location overlooking the National Highway (NH) at Farmagudi and contributes to the area's scenic beauty. Despite previous promises by the government to restore the fort during annual State-level Shiv Jayanti celebrations, no major renovation work has yet materialised.

Locals have expressed concern over overgrown bushes and trees, which not only mar



the fort's appearance but also pose a danger to tourists due to the potential threat of venomous reptiles.

Of the 25 concrete benches installed at the site, most are now damaged, with crumbling concrete and exposed ironwork creating hazards for visitors.

The plan is to demolish the existing structure and build a new one at an estimated cost of Rs 100 crore. Once the tender is floated and the work order is issued, construction will begin," he confirmed.
