Bihar native dies due to electrocution at Marcel

PONDA: Thirty-year-old Rakesh Paswan, a native of Bihar died due to electrocution at his rented room in Deulwada, Marcel. Paswan was declared dead upon arrival at Betki Primary Health Centre.

The body has been preserved at South Goa District Hospital (SGDH), Margao, for medico-legal procedures. Mardol Police have registered a case of unnatural death, and PSI Vinod Salunke is conducting investigations.

Family of four injured in Cuncolim accident

MARGAO: A family comprising of a husband, wife, and their two children riding a scooter, sustained injuries after being hit by a truck at Navaband. Cuncolim. The Cuncolim Police confirmed that all injured individuals received medical treatment and registered an offense against the driver under Bharatiya Nyaya Sanhita 2023. Police Constable Vinod Kankonkar filed a complaint, stating that the accused, Pavankumar from Nandangadda Karwar, Karnataka, allegedly drove his truck in a rash and negligent manner, thereby endangering human life. The incident occurred while the vehicle was proceeding from Balli towards Margao. On reaching near a restaurant in Nayaband, Cuncolim, the driver reportedly lost control, veered to the extreme right side of the road, and collided with the oncoming scooter.

The scooter was being driven by Harish Naik, a native of Karwar, Karnataka, currently residing at Tisk, Ponda,. His wife and two sons were pillion riding on the scooter. The impact of the collision was such that all occupants of the scooter fell onto the roadside and sustained injuries. Further investigation is on.

Gogol resident arrested for threatening his wife with a firearm

MARGAO: The Fatorda Police arrested a man for allegedly threatening his wife with a firearm. According to a complaint lodged with the Fatorda Police, on May 27, at 10 am in Gogol, Margao, the complainant's husband, Runaksh Gaonkar of Gogol, verbally abused her and threatened her life with a firearm. Based on her complaint, the Fatorda police registered an offence under Bharatiya Nyaya Sanhita, 2023, and the Arms Act. During the subsequent inquiry, the police visited the residence of the accused. On searching the premises, they discovered a locally-made firearm in a dismantled state along with 14 bullets concealed under the bed of the accused. Gaonkar was arrested and has been remanded in 5 days police custody by Judicial Magistrate First Class (JMFC), Margao. Further investigation is on.

Complaint against security guard for criminal breach of trust

MARGAO: Sanjay Gajanan Terade from Thane, Maharashtra filed a complaint with the Colva Police stating that Prashanth, a security guard at the Colva Beach Resort, took his vehicle for washing and absconded, thereby committing criminal breach of trust. The police registered an offence under Bharatiya Nyaya Sanhita 2023, and the matter is under investigation.

Betul woman found dead at her residence

MARGAO: Thirty-year-old Annie Simoes from Betul, Quepem, was found hanging at her residence, Cuncolim Police reported.

Cuncolim PSI Aditya Sawant visited the scene and found Simoes' body hanging from the roof with a cotton cloth. The ambulance staff declared her dead. The police conducted the panchanama and sent the body

to South Goa District Hospital for legal procedures. PSI Sawant is investigating.

Painter dies after falling into pit at Dabolim flyover site

VASCO: In a tragic incident Maruti Jadhav (40), a painter from Dabolim died after he along with his two-wheeler fell into an excavated pit near Vales Junction, Dabolim on Wednesday night. The incident occurred when Jadhav, who was returning on a two-wheeler accidentally fell into a pit dug up for the ongoing flyover construction work at Dabolim. Jadhav received severe injuries in the fall and was rescued from the pit by the locals. He was immediately rushed to the Sub-District Hospital at Chicalim, where he was declared brought dead by the doctors. On receiving the information, the Vasco Police rushed to the site and conducted investigations.

One arrested for assaulting youth at Baina

VASCO: The Mormugao Police arrested a man for allegedly assaulting a youth with a wooden rafter, causing grievous injuries to his head in a rented room at Baina. The police gave the name of the victim as Rahul Kumar Majhe (20), a native of Bihar and presently residing at Baina. The assault took place in a rented room on Sunday night. The accused, identified as Rahul Kumar Sahni, also from Bihar and residing at Baina allegedly attacked Majhe and hit a wooden rafter on his head causing injuries. The victim sustained serious head injuries and has been admitted to the Goa Medical College and Hospital, Bambolim, where he is currently undergoing treatment. The Mormugao Police have registered a case against Sahni under Bharatiya Nyaya Sanhita, 2023. The accused has been remanded in four days police custody. PSI Stanley Gomes is conducting investigation under the guidance of Mormugao PI Sherif Jacques and overall guidance of Mormugao DySP Gurudas Kadam.

Calls grow for stray dog shelters in Ponda as roadside feeding continues

PONDA: In the wake of last month's fatal stray dog attack on a child at Durgabhat, Ponda, local councillors and panchayat members have raised awareness about the dangers posed by feeding stray dogs on main roads. However, despite these efforts, some residents continue to offer food to strays along busy thoroughfares, increasing the risk of accidents for commuters.

Curti-Khandepar Sarpanch Nilkant Naik recently appealed to residents during a gram sabha to refrain from feeding dogs on footpaths and roads, especially avoiding raw meat which can trigger aggressive behaviour in dogs. Nevertheless, some individuals have ignored these warnings and con-



tinue to feed strays on public roads.

> In response, the Ponda Municipal Council (PMC) has proposed setting up a dog shelter behind the PMC crematorium in the Bandora community.

Viraj Sapre of Ponda acknowledged the need for stray dogs to receive regular food but stressed that the responsibility lies with

the PMC and panchayats in Ponda Taluka to establish a dedicated shelter at the earliest. "Stray dogs chase people on the road when they remain hungry," he said.

Sapre pointed out that the Ponda Sub District Hospital has recorded an average of around 80 dog bite cases each month over several years. He

urged the PMC and all 19 panchayats in the taluka to construct shelters so dog lovers can show compassion in a safe and structured manner.

"Whenever stray dogs don't have food on the road, they chase commuters and pedestrians and often bite them," he said. He also highlighted the problem of raw meat waste being dumped on roadsides, which is making the dogs more aggressive. "Proper disposal of chicken and meat waste is essential to prevent dog bite cases," he added.

Sapre further noted that there are 18 stray dogs and puppies in his own residential building. He called for effective sterilisation measures to control the stray dog population.
