

# AIFF upholds Churchill Bros' appeal, no need to return I-League trophy

### Inter Kashi set to move to Court of Arbitration for Sport again

**MARGAO:** The Appeals Committee of All India Football Federation (AIFF) headed by Hon Justice (Retd) Rajesh Tandon on Saturday upheld the protests lodged by I-League clubs Churchill Brothers, Namdhari FC and Real Kashmir against Inter Kashi for fielding an ineligible foreign player Mario Barco in their I-League 2024-25 championship.

Following the order of the AIFF Appeals Committee, the Churchill Brothers have been awarded two additional points, Namdhari FC have secured three additional points and Real Kashmir have secured a superior match result.

Inter Kashi lose four points for now, besides altering the goal difference. Consequently, Inter Kashi's appeal in the Namdhari FC dispute in the Court of Arbitration for Sport (CAS) will not change the championship's fate.

Justice Tandon and AK Tripathi, District Judge and Priyanka Mishra, lawyer and member, have unanimously ruled that the AIFF Competition Committee's decision to reject Inter Kashi's request to re-register Mario Barco, who had opted out due to injury, was correct.

The AIFF League Committee had presented a letter dated February 15, 2025 overruling the Competition Committee's decision. As the letter had not

## AMENDMENTS TO REGULATIONS ON STATUS AND TRANSFER OF PLAYERS

**PTI, NEW DELHI:** The AIFF on Saturday announced a set of amendments to its regulations on the status and transfer of players, which will come into effect from June 1. The AIFF said it focuses on enhancing player welfare, supporting women's football and youth football more effectively, and improving regulatory transparency. "A standout feature of the updated regulations is the increased attention to the rights and well-being of female players," the sports body said. The AIFF said it has "introduced provisions addressing menstrual health, allowing female players to take leave from training during the onset of their menstrual cycle." "Expanded clauses now also cover pregnancy, adoption, and family leave for both players and coaches, aiming to create a more inclusive environment for women in the sport." "The amendments also introduce structural reforms in player transfers and youth development. New limitations on the number and duration of player loan deals have been set to ensure fairness." "To safeguard young talent, the AIFF has revised its regulations concerning the registration of minors at academies, emphasising child protection in accordance with FIFA standards."

Meanwhile, I-League club Inter Kashi is set to knock on the doors of the Court of Arbitration for Sport (CAS) for a second time after the All India Football Federation upheld the appeal of Namdhari FC, Real Kashmir and Churchill Brothers against the Varanasi-based club over re-registration of Mario Barco.

Inter Kashi said they would appeal against the judgement at CAS -- the highest court to adjudicate sports disputes internationally -- where an appeal by club is pending.

"Inter Kashi will now appeal the decision at the Court of Arbitration for Sport. While it is unfortunate that Inter Kashi has to approach CAS yet again for a truly free and fair hearing of the matter, it seems to be the new reality of Indian football," Inter Kashi said in statement and posted it on X.

"The club fully believes that a free and fair hearing at CAS will bring all relevant facts to the forefront. There will be no further comment on this matter at this time," the club added in the statement.

The CAS had stayed the AIFF's decision while hearing the appeal from Inter Kashi.

A ruling from the Deputy President of the CAS Appeals Arbitration Division Sport had stated: "The All India Football Federation is ordered not to declare the winner of the I-League 2024-25 or organise a medal ceremony for the I-League 2024-25 until the present arbitration has been concluded."

# Overton ruled out of England's ODI, T20 series with broken finger

**PTI, LONDON:** Jamie Overton has been ruled out of England's remaining one-day internationals and T20 matches against the West Indies because of a broken finger sustained in Thursday's ODI series opener.

The right-arm fast-bowling all-rounder broke his right little finger while trying to make a return catch early in England's 238-run victory at Edgbaston.

Overton had grasped his hand and immediately jogged into the dressing room. After some treatment, he returned and finished with 3-22.

"He will now undergo a period of rehabilitation under the supervision of the England medical team," England Cricket said in a statement on Saturday.

"No replacement will be added to the ODI squad."

England can clinch its first ODI bilateral series win since September 2023 on Sunday in Cardiff. The third and last match is on Tuesday at the Oval.

A three-match T20 series begins next Friday.
