## Pvt bus owners want Majhi **Bus Scheme continued under Transport Department**

#### Tamankar urges govt to retain bus scheme with Dept, not Kadamba

PANJIM: The All Goa Private Bus Owners' Association (AGPBOA) has urged the State government to retain the Majhi Bus Scheme under the direct control of the Transport Department, instead of transferring its management to the Staterun Kadamba Transport Corporation.

Association's general secretary Sudip Tamankar, met with Director of Transport P Abhishek on Monday and submitted a detailed representation with regards to the administration of the Majhi Bus Scheme.

Tamankar highlighted that the Majhi Bus Scheme, currently operated by the Transport Department, comprises three main components-a Rs 3 fuel subsidy, a Rs 30,000 insurance benefit, and a Rs 10 lakh incentive for the purchase of new buses. He praised

#### 25 armed goons assault pregnant woman, husband at Bastora Victim Vivek sustains nasal fracture; assailants on the run

NACHINOLA: The law and order situation in the State has apparently gone for a toss as a shocking incident was reported at Bastora junction, wherein a pregnant woman and her husband were mercilessly assaulted by around 25 uni-dentified persons late Monday

The attack took place at Bastora junction at around 8 pm, where a group of around 25 unidentified individuals brutally attacked Vivek Shirodkar and his three-month pregnant wife, Shruti Shirodkar. The couple, residents of Nachinola, Aldona, operate a Shawarma van at the junc-

According to the complaint, the attack stemmed from a minor argument earlier in the day over a parking issue, during which the group allegedly threatened Vivek.

In the evening, as the couple had just opened their food van, the group of 25 persons, armed with iron rods, wooden sticks, choppers, and knives arrived at The attack took place at Bastora junction at around 8 pm, where a group of around 25 unidentified individuals brutally attacked Vivek Shirodkar and his three-month pregnant wife, Shruti Shirodkar. Police sources revealed that Vivek sustained nasal fracture and other injuries and was likely to be shifted to the Goa medical College and Hospital, Bambolim for further treatment. Further investigations are underway and the assailants are still at

### GCZMA postpones starred hotel hearing after activists object to short notice

PANIIM: The Goa Coastal Zone Management Authority (GCZMA) agreed to postpone the hearing of a starred hotel project at Bambolim after activists objected to the short notice

Reacting to the decision, Goa Green Brigade convenor Avertino Miranda said, "GCZMA has conceded to our demand for a fair and just advance notice to enable the complainants to participate in the hearing against the CRZ violator."

Miranda explained that the GCZMA had initially given only three and a half hours' notice, making it difficult for him to attend due to prior engagements. He requested the Authority to provide at least 10 days' advance notice in the interest of justice and fair play.

Judith Almeida of the Colva Civic and Consumer Forum (CCCF) also expressed her resentment at the GCZMA's decision to fix the personal hearing on Tuesday. "I received a letter by post on Monday morning, asking to be present for the hearing the very next day," said Almeida.

The GCZMA has now rescheduled the personal hearing for June 10.

PANJIM: The Aam Aadmi Party (AAP) Goa on Monday demanded the immediate revocation of the occupancy certificate granted to a mega housing project at Azossim-Mandur.

AAP leader Ramrao Wagh criticised a local politician for blaming the Azossim-Mandur Sarpanch while absolving himself of any responsibility regarding the issuance of occupancy certificates and alleged irregularities and corruption in the project.

Wagh questioned the politician's attempt to distance himself from the village panchayat, alleging it was a move to protect himself after previously

feigning ignorance on the matter. He pointed out that the politician had claimed to oppose the project for several years but was now shifting the blame onto the first-time sarpanch of the Azossim-Mandur panchayat.

According to Wagh, AAP MLA Cruz Silva had raised the issue in the Assembly in February this year. The matter was also discussed during the last two gram sabha meetings. Villagers were reportedly shocked to learn that the panchayat had granted occupancy certificates for 94 flats—87 of which were issued on a single day.

unjust directive. GCU spokesman litesh

Citing the recent fire aboard a passenger vessel at Malim jetty on Saturday. Patkar described the incident as a glaring example of the department's negligence. "The absence of a disaster management system is unacceptable. We demand a full audit of all vessels and immediate

corrective action," he said. Patkar accused the CoP of failing to conduct mandatorv safety audits of vessels under its jurisdiction and warned, "If the CoP Department does not set things in order within the next 15 days, we will launch a pub-

He further alleged that the International Ship and Port Facility (ISPF) security code had not been implemented, that no radio officer was present in the department, and that radio communication was inactive on all vessels. The vessels are not being monitored in accordance with Indian Registrar of Shipping (IRS) norms," he
