16 Naxalites surrender in Chhattisgarh; Kerlapenda village becomes Maoist-free

SUKMA: Sixteen Naxalites, including six carrying a collective cash reward of Rs 25 lakh, surrendered in Chhattisgarh's Sukma district on Monday, police said. Of them, nine cadres belonged to Kerlapenda village panchayat under Chintalanar police station limits. With this surrender, the village has become Naxalite-free, making it eligible for development projects of Rs 1 crore as per a new scheme of the state government, an official said. All 16 cadres, including a woman, turned themselves in before senior police and CRPF officials, here citing disappointment with the "hollow" and "inhuman" Maoist ideology and atrocities by ultras on local tribals, Sukma Superintendent of Police Kiran Chavan said.

Wife, son arrested for killing husband in Odisha's Nayagarh

BHUBANESWAR: The police arrested a woman and her son for allegedly killing her husband in Odisha's Nayagarh district, an officer said. The deceased was identified as Sishir Sahu, a forester in Sarankul Pancharida range of Nayagarh district. A day after recovering the half-burnt body of Sishir, the police arrested the deceased's wife and son after conducting a crime scene recreation, said Jyoti Ranjan Samantaray, sub-divisional police officer (SDPO), Nayagarh on Sunday. The deceased's wife Namita also sustained minor burn injuries while their son Abhishek was unharmed in the incident at their house in Baramasidanda area of the district on Friday night, he said. Namita with the help of Abhishek poured petrol on her husband and set him on fire following a heated argument, Samantaray said.

Telangana aims to become USD 3 trillion economy by 2047: CM Revanth Reddy

HYDERABAD: Telangana is working to become a USD 3 trillion economy by 2047 as the country aspires to achieve USD 30 trillion by then, Chief Minister A Revanth Reddy said here on Monday. Speaking at the Telangana Formation Day celebrations, Reddy said the state government hopes to contribute 10 per cent to the national GDP by 2047. "India is making efforts to emerge as a USD 30 trillion economy by 2047. As India and the (Central) government are making plans to become USD 30 trillion, we brought the Telangana Rising 2047 policy document to make the state a partner in it, to put the state at the top," he said.

Nepali man arrested for killing wife in Shimla

SHIMLA: A Nepali man was arrested for allegedly killing his wife in Kotkhai, about 60 km from state capital Shimla, police said on Monday. The body of the woman was found on Sunday evening with multiple injury marks and bruises, they said. According to police, Nepali labourer Ramesh Dangi informed his employer Hari Krishan Dhanta that Deepa, wife of Jeet Bahadur, was found unconscious with visible injury marks on her body. During preliminary inquiry on the spot, Jeet Bahadur, also a labourer, confessed that on Saturday, he had a physical altercation with Deepa and in the heat of the moment, he beat her with a wooden stick which killed her.

15-year-old boy drowns in Ganga river

KAUSHAMBI: A 15-year-old boy drowned while bathing in the Ganga River with his family, the police said on Monday. Aditya Chauhan visited the Sandipan Ghat on Monday morning with his mother, Seema Devi and aunt, Mangala Devi. While taking a bath, he went into deeper waters. The teenager's mother and aunt soon raised an alarm prompting locals at the ghat to jump into the river in an attempt to save him, but it was too late, the police said. The police, with the help of local divers, recovered Aditya's body from the river after about four hours. His body has been sent for a post-mortem examination.

Thunderstorms, gusty winds likely in parts of Andhra Pradesh till Jun 4

AMARAVATI: The India Meteorological Department (IMD) on Monday forecast thunderstorms and gusty winds in isolated parts of Andhra Pradesh from June 2 to 4. It noted that hot and humid weather conditions will prevail, before a likely respite on June 5 and 6. "Hot and humid weather is likely to occur in isolated places," the IMD said in a release. Thunderstorms accompanied with lightning are likely at isolated places over North Coastal Andhra Pradesh (NCAP), Yanam, and South Coastal Andhra Pradesh (SCAP) on June 2 and 3. Gusty winds reaching speeds of 30-40 kmph are also likely in NCAP, Yanam, SCAP, and Rayalaseema, the release said.

19,811 affected, 3,365 houses damaged in Manipur; severe flooding, landslide in Assam; Arunachal toll rises to 10

PTI, IMPHAL, GUWAHATI, ITANAGAR: More than 19,000 people have been affected by floods in Manipur caused by overflowing rivers and breaches in embankments, officials said on Monday.

They said 3,365 houses have been damaged and 19,811 people affected by floods triggered by incessant torrential rains during the last four days.

Thirty-one relief camps have been opened mostly in Imphal East district to mitigate the hardships of the people who have been evacuated from their homes and localities.

Heingang, Wangkhei and Khurai assembly constituencies in Imphal East district are worst affected

along with Senapati district.

Forty-seven landslides too have been reported in different parts of the state during the last four days.

Manipur Governor Ajay Kumar Bhalla visited several inundated areas of Imphal town even as the army and Assam Rifles personnel rescued nearly 800 people from submerged localities in Imphal East, the worst-affected district, they said.

Meanwhile Assam remained grim on Monday with the water levels rising in many parts of the state, officials said.

The total number of people losing their lives in this year's flood and landslides has in-

creased to 10.

Cachar is the worst hit with over one lakh people affected, followed by 85,000 people in Sribhumi and 62,000 in Nagaon, it added.

The authorities have distributed 1,090.08 quintals of rice, 284.63 quintals of dal, 952.76 quintals of salt and 4,726.26 litres of mustard oil among the flood victims of the state during the last 24 hours. At present, 764 villages are under water and 3,524.38 hectares of crop areas have been damaged across Assam, the ASDMA said.

Embankments, roads, bridges and other infrastructure have been damaged by flood waters in many districts across

the state.

In Arunachal one more death reported from Lohit district, the toll in landslides and floods in Arunachal Pradesh rose to 10 even as incessant monsoon rains lashed the state on Monday, officials said.

PM Modi unlikely to attend upcoming G7 summit in Canada

Ottawa yet to send an invitation to Modi



PTI, NEW DELHI: For the first time in six years, Prime Minister Narendra Modi is unlikely to attend the upcoming G7 summit to be held in Canada's Alberta province, people familiar with the matter said on Monday.

Canada is hosting the summit from June 15 to 17 that is expected to deliberate on pressing challenges facing the globe including the Russia-Ukraine conflict and the situation in West Asia.

It is learnt that Ottawa is yet to send an invitation to the Indian prime minister for the summit, but Modi, in any way, would have skipped it as such a visit would have required a lot of groundwork considering the current state of ties between the two sides, said the people cited above.

The India-Canada relations hit rock bottom following then Prime Minister Justin Trudeau's allegations in 2023 of a potential Indian link to the killing of pro-Khalistan separatist Hardeep Singh Nijjar.

However, Liberal Party leader Mark Carney's victory in the parliamentary election in April triggered hopes for reset of the relationship.

The assessment in New Delhi has been that there was no clear indication yet from the new government in Canada to address India's concerns over activities of the pro-Khalistani elements in that country.

Moreover, there has been no significant forward movement by New Delhi and Canada to restore each other's high commissioners.

In October last year, India recalled its high commissioner and five other diplomats after Ottawa attempted to link them to the Nijjar case.

India also expelled an equal number of Canadian

diplomats.

"For a prime ministerial visit, we needed to carry out a lot of groundwork considering the state of bilateral relations," explained one of the people.

Above all, security is a major issue, said another person aware of India-Canada ties.

In the last few months, the security officials of India and Canada resumed contacts and both sides were looking at the possibility of appointing new high commissioners.

The exit of Trudeau was seen as an opportunity to improve bilateral ties.

India had accused Trudeau's government of allowing pro-Khalistani elements to operate from Canadian soil.

White tiger cub dies in Nandankanan Zoo

PTI, BHUBANESWAR: A seven-month-old white tiger cub died at Nandankanan Zoo in Bhubaneswar, officials said on Monday.

The white tiger cub, born to Melanistic tiger Krishna and white tigress Rupa on November 2 last year, showed signs of lameness in March and was under regular veterinary care, including diagnostic imaging, medication, and nutritional supplementation, a zoo officer said.

Experts from the Centre for Wildlife Health (CWH) have also examined the tiger cub, and blood tests showed no major abnormalities. Despite initial recovery, the cub exhibited some degree of lameness, he said.

On the night of May 31, the cub ate normally and showed no signs of distress. However, on the next day, the cub was seen struggling and passed away in the evening, he said.

Gnanasekaran gets life sentence in Anna varsity case

PTI, CHENNAI: A Mahila Court here on Monday awarded life sentence for a minimum period of 30 years without remission to the accused Gnanasekaran, who has been convicted for rape of a girl student on the Anna University campus in December last year.

Mahila Court judge M Rajalakshmi, who convicted 37-year-old Gnanasekaran on May 28, awarded life imprisonment for a minimum period of 30 years without remission for the offence of rape, which falls under section 64 (1) of Bharatiya Nyaya Sanhita Act (BNS) and the judge imposed a total fine of Rs 90,000 on him.

Chief Minister MK Stalin said the very stringent punishment has been secured and thanked the court and welcomed the judgment.

The chief minister recalled that recently the gov-

ernment had made amendments ruling out remission for sexual offenders. In this case, the court has awarded punishment without scope for remission. The court has lauded the police department and this has shattered the thought of some to seek political mileage even in this matter.

The court awarded sentences in respect of each of the 11 charges proved by the prosecution against the accused and the sentences shall run concurrently. The judge sentenced Gnanasekaran to imprisonment for 10 years under section 87 of BNS (Kidnapping or inducing a person for illicit purposes).

In case of involvement of others, the AIADMK said it would bring them to book after it formed the government following polls to the state Assembly in 2026.
