PANJIM: Goa has set a target of installing 21,200 rooftop solar systems by 2027, generating 65 MW of clean and green energy, and ensuring affordable, sustainable power access for poor and middle-class households under the PM Surya Ghar Muft Bijli Yoja-na (PM-SGMBY), Chief Minister Pramod Sawant said on Tuesday.

In a post on X (formerly Twitter) after chairing a high-level meeting at Mantralaya, the Chief Minister

### FDA shuts down two food Truckers oppose Mormugao Port flyover toll

Fear it would erode their earnings

PANIIM: Local truck and heavy vehicle owners have strongly opposed the newly imposed Rs 300 toll per trip at the recently inaugurated Mormugao Port flyover.

Implemented this week, the toll has raised serious concerns among transporters and logistics operators who depend on the flyover for daily access to the port.

The local operators said the toll came as an unexpected shock. Rajesh Naik, a truck owner from Vasco. said "We were not given sufficient notice to adapt our business. A Rs 300 charge per trip is substantial, especially for those making multiple daily trips. This will severely cut into our already

## Massive boulders at Kundaim on the verge of collapse

Commuters fear boulders could roll down any time; urge authorities to clear them immediately



PONDA: Commuters have raised concerns over the presence of massive boulders on the hillside along the Kundaim bypass on the National Highway, which they claim are on the verge of collapse and could roll down any moment, endangering the lives of people and have appealed to the authorities to clear them immediately.

It is pertinent to note that the ongoing widening work of the Kundaim

bypass has been in progress for the past two years, involving hillside cutting in certain areas, which appears to have exposed these massive boulders. Recent rains have likely further destabilised them, leaving them in a dangerously loose state and at risk of falling at any moment.

This road widening project was initiated following demands from Kundaim residents due to tragic accidents at Manaswada Junction, and locals are advocating for two-way traffic on the completed bypass. According to locals, this section of the National Highway is used by both motorists and pedestrians. The potential for falling boulders to land on the highway could lead to severe accidents with grave consequences.

The residents have urged the authorities to assess this situation and undertake the necessary measures to remove these loose boulders to ensure the safety of commuters using the Kundaim bypass.
