Teenage girl raped and impregnated by man in Maharashtra; accused on the run

LATUR: A 17-year-old girl was allegedly raped and impregnated by a man in Ausa taluka of Maharashtra's Latur district, police said on Tuesday. The crime took place over a period of seven months, and the accused has been on the run since the case was registered at the Ausa police station on May 30, they said. The accused reportedly kept a close watch on the girl, frequently visiting the farm shed when she was present. On one such occasion, he allegedly sexually assaulted the minor and threatened to kill her if she disclosed about the incident to her family members. The minor's ordeal, which began seven to eight months ago, came to light recently, he said. A medical examination of the victim confirmed that she was six months pregnant, he added.

Three arrested with arms and ammunition in Jharkhand

JAMSHEDPUR (JHARKHAND): Three persons have been arrested and arms and ammunition seized from their possession in Jamshepur city of Jharkhand, police said. Acting on a tip-off, police raided Marine Drive Road at Ramnagar beside Kharkhai River in Kadma police station area on Monday and nabbed the trio following a chase as they were trying to flee, Superintendent of Police (City) Kumar Shivashish said. Of the three, two buyers, identified as Lalit Yadav (33) and Rakesh Kumar (30), had come to the spot to purchase a firearm from arms dealer Sharukh Khan (29). Police seized two country-made pistols and three cartridges, he said. The SP said Khan has criminal antecedents and a case has already been lodged against him. He said a police investigation is underway to find out the source of the arms. A case under sections of the Arms Act has been lodged, he added.

Four girls drown in Yamuna river in Agra

AGRA (UP): Four teenage girls drowned while bathing in the Yamuna river near Nagla Nathu village here on Tuesday, officials said. According to police, six girls had entered the river around 10 am for a bath and soon started drowning. Locals managed to rescue two of them, while four drowned. Their bodies were fished out by locals later. The deceased have been identified as Divya (14), Sandhya (12), Shivani (17), and Naina (14). The two rescued girls - Sonam and Muskan - have been admitted to a nearby hospital. A local resident, Dipesh, who witnessed the incident, said he had gone to the river with friends when he noticed the girls drowning. District Magistrate, Agra, Arvind Mallappa Bangari,

UP: 2 killed as truck runs over motorcycle in Jaunpur

JAUNPUR (UP): Two persons were killed on the spot and another sustained serious injuries after a speeding truck ran over a motorcycle here, the police said on Tuesday. The police reached the spot immediately after receiving information about the incident and sent the bodies for postmortem, Sarai Khwaja Station House Officer (SHO) Vinay Prakash Singh said. The deceased were identified as Amla Yadav (50), son of Ballar Yadav, and Mohit Yadav (20), son of Shankar Yadav. Shalu (18), who was also riding the motorcycle, suffered injuries and was admitted to a hospital for treatment. The truck driver fled the scene of the accident and a search has been launched to track him down, the SHO added. Further investigation is underway.

School bus skids off road, falls in field; Children suffer minor injuries

THIRUVANANTHAPURAM: Some school students suffered minor injuries after their school bus skidded off from the road and fell into a field in nearby Nagaroor on Tuesday, police said. The incident happened when the bus was on its way to the state-run school after picking up children from their respective boarding points. At least 19 children were there in the bus when the incident happened, and some of them suffered injuries, they said. Local people rescued the children trapped inside the bus and rushed them to a nearby hospital. General Education Minister V Sivankutty later visited the injured children at the primary health centre in Kesavadasapuram.

Five held in Hyderabad for trying to sell cocaine mixed with ephedrine

HYDERABAD: Five people were apprehended for allegedly attempting to sell cocaine laced with Ephedrine in Kukatpally here, police said on Tuesday. The accused were intercepted and were taken into custody on June 2 while they were searching for buyers and a total of 820 grams of the drug worth Rs 1 crore was seized from their possession, Deputy Commissioner of Police N Koti Reddy said. The main accused, an Armed Reserve constable from Tirupati in Andhra Pradesh, who is the supplier of the contraband is absconding, the DCP said. During the ongoing investigation, it was revealed that the police constable proposed the sale of Ephedrine for profit, a release from Cyberabad Police Commissionerate said. The seizure was made as per NDPS Act procedures, the release added.

Mizoram rain triggers 5 deaths, 552 landslides, and 152 house damages within 10 days

PTI, AIZAWL: Mizoram has reported five deaths in the current wave of landslides, house collapse and other calamities triggered by heavy rains in the last 10 days, the state's Disaster Management and Rehabilitation department said on Tuesday. Data shared by the department said that three people died in Champhai district and one each in Aizawl and Serchhip districts due to collapse of houses and walls caused by landslides and flash floods. The state also reported 552 landslides at several places, while 152 houses have collapsed or have been damaged due to rain during the same period, it said. One hundred and ninety-eight families have abandoned their houses due to landslides or fissures and 92 others evacuated their homes due to

34 TOURISTS, FAMILY MEMBERS OF ARMY PERSONNEL AIRLIFTED FROM SIKKIM'S LANDSLIDE HIT CHATEN

PTI, GANGTOK: Altogether 34 people - 27 tourists and seven family members of the army personnel were evacuated from landslide-affected Chaten area in north Sikkim on Tuesday, officials said. This was the first successful aerial evacuation carried out under the current emergency response plan in the state where inclement weather condition continues. Three army personnel were killed and six soldiers went missing after a landslide hit a military camp at Chaten. Several others were also injured. The landslide, which occurred at 7 pm on Sunday near Lachen town in Mangan district, was triggered by heavy rainfall in the area. Search and rescue operations to find out six missing army personnel are continuing on Tuesday as a team of 23 NDRF personnel, equipped with satellite phones and essential relief equipment, reached Chaten, officials added.

OVER 1.64 LAKH AFFECTED IN MANIPUR FLOOD, ONE DEAD

PTI, IMPHAL: The flood situation in Manipur worsened on Tuesday as more than 1.64 lakh people were affected by the calamity, after several rivers overflowed and breached embankments following heavy rainfall in the state, officials said. The body of a person who was washed away in floodwaters was found in Imphal West district during the day. A population of 56,000 people had been affected by the calamity on Monday. Though the water level of rivers flowing across the Imphal Valley districts decreased significantly on Tuesday, several areas of Imphal East district continue to be inundated for the fourth day. At least 1,64,879 people have been affected by the flood while 35,143 houses have been damaged. Officials said that 643 localities have been affected, mostly in Imphal East district, while 82.79 hectares of agricultural field have been under water. At least 3,917 flood-hit people have been evacuated while 77 relief camps have been opened.

Eighteen landslides were reported in Aizawl district, while 13 houses have collapsed or have been damaged and 17 others have

been abandoned, it said.

Khawzawl district reported 75 landslides, Lunglei district (60) and south Mizoram's Siahia district reported 53 landslides, it said.

Over 29 houses collapsed or were damaged in Siahia district, 23 in Kolasib district, 18 in Lunglei district and 9 in Khawzawl district, the data said.

Assam flood scene remains critical; Modi calls up CM to enquire about situation

PTI, GUWAHATI: The flood situation in Assam continued to be critical on Tuesday with over 5.35 lakh people affected in over 20 districts while the toll remained unchanged at 11.

Prime Minister Narendra Modi took stock of the flood situation from Assam Chief Minister Himanta Biswa Sarma, assuring him of full support from the central government.

Sarma visited Cachar district, which is among the worst-hit, during the day, while the meteorological department issued a forecast of more rain in several parts of the city.

BJP president JP Nadra also expressed concern over the situation in most parts of North East and urged the people in the affected areas to take precautions and follow the advisories from local authorities.

Briefing Modi over the phone, Sarma informed him how continuous rainfall in Assam and adjoining states has led to flooding and impacted the people.

ARUNACHAL FLOOD TOLL RISES TO 11, 938 AFFECTED IN 23 DISTRICTS

PTI, ITANAGAR: The death toll in floods and landslides triggered by relentless rain in Arunachal Pradesh has increased to 11 as a labourer died in a wall collapse incident in Anjaw district, officials said on Tuesday. According to a State Emergency Operation Centre (SEOC) statement, while 38-year-old Bhaben Murmu died when a wall collapsed during a landslide on June 1, three GREFF workers were injured in the incident.

A total of 938 people are now affected by floods in 156 villages in 23 districts, it said.

Lower Subansiri district reported significant damage, including the destruction of 114 kutcha houses, 45 pucca houses, and nine huts. The district has also seen serious infrastructure losses, including the damage of 51 roads, 17 power lines, 23 water supply lines and two schools, officials said.

Rajasthan govt employee arrested for spying for Pak

PTI, JAIPUR: A Rajasthan government employee who was earlier detained on suspicion of espionage for Pakistan has now been arrested, the police said on Tuesday. Shakur Khan, an Assistant Administrative Officer (AAO) posted at the Jaisalmer employment office had allegedly been passing sensitive, strategic information to Pakistan, they said. The government employee had been under surveillance for suspicious activities over an extended period.

During monitoring, agencies discovered that he was in regular contact with individuals linked to the Pakistan High Commission, particularly Ahsan-ur-Rahim alias Danish and Sohail Qamar, Inspector General (CID-Security) Vishnu Kant Gupta said. "Khan was taken into custody for questioning a few days ago and was interrogated extensively at the central interrogation facility in Jaipur by multiple intelligence agencies," Gupta said in a statement. He further shared that Khan had obtained Pakistani visas on several occasions and travelled to Pakistan, allegedly with the assistance of Danish. Investigations revealed

that during his visits, Khan came in contact with agents of Pakistan's spy agency ISI.

He has also been accused of collecting sensitive information upon return to India and transmitting it to Pakistani handlers through platforms such as WhatsApp.

Gupta noted that the case constitutes a serious security breach under the Official Secrets Act, 1923. "A case has been registered, and Khan has been arrested under relevant sections of the Act," he said.

2 medics fined for ragging MBBS student

PTI, BERRHAMPUR (ODISHA): Two house surgeons of Odisha government-run-MKCG Medical College and Hospital here have been imposed a fine of Rs 25,000 each for allegedly ragging a fourth-year MBBS student of the health institute. The anti-ragging committee of the college has taken this decision in its meeting held on Monday, officials said.

"We have received a complaint from the anti-ragging cell about the ragging of a fourth-year MBBS student by the

house surgeons on May 12. Based on the complaints, the anti-ragging committee meeting was held to discuss the complaint," said MKCG Medical College Principal Suchitra Dash.

After a thorough discussion, the committee has decided to impose a fine of Rs 25,000 each on the two house surgeons involved in the incident, she said.

The house surgeons have been fined for their misconduct on the ground of violation of decency and morale through ragging, with the junior student.

Medical representatives banned from meeting doctors in central govt hospitals

PTI, NEW DELHI: Medical representatives have been prohibited from meeting doctors in central government hospitals to safeguard patients' interests and maintain ethical standards. The Directorate General of Health Services (DGHS) has instructed all central government-run hospitals not to permit medical representatives in the hospital premises.

"This is in reference to the earlier instructions regarding not permitting en-

try of Medical Representative in hospital premises. In this regard it is once again instructed that the medical representatives should not be permitted in the hospital premises. The head of the institutions shall give necessary strict directions in the matter to all officials," an order issued on May 28 stated.

The order stated that medical representatives may be requested to share recent advances regarding any treatment, investigation or procedure by email or other digital media. "It is requested to take necessary action in the matter and action taken report may be furnished to this directorate," the directive said. "The move is aimed at preventing medical representatives from unduly influencing doctors inside hospital complexes into prescribing medicines promoted by their companies," an official source said.
