

court chastised the NBE decision to hold the exam in two shifts.

The NBE informed the top court that soon after the May 30 order, it informed TCS about the top court's directive in an email sent at around 1:21 pm.

"TCS was requested to confirm the availability of the adequate number of test centers, feasible for conducting the exam in a single shift on June 15, 2025. TCS responded vide email dated May 30, 2025 at 3.52 pm stating that the time available was insufficient to hold the said exam in a single shift on the scheduled exam date,

i.e., June 15, 2025," the NBE said.


