MARGAO: A sewage leak near the South Goa District Hospital has raised alarm among farmers and residents of the Danvoddem-Fatorda area. with fears mounting over agricultural fields' damage and potential health hazards due to possible contamination of drinking water.

The leak, reportedly caused by damage to sewage chambers and pipelines during recent excavation work undertaken by the Electricity Department, has resulted in untreated sewage spilling into agricultural fields. clear backlog of revenue cases

MARGAO: In a bid to expedite the disposal of long-pending revenue cases, South Goa District Collector Egna Cleetus, has directed all Revenue Commissioners and Deputy Collectors in the district to hold special hearings every Monday morning.

These sessions will focus exclusively on revenue cases that have been pending for more than five years.

The directive comes after a review by the district administration revealed a significant backlog of such cases before various Revenue Courts in South Goa. The Collector emphasised the urgent need to re-

The order specifies that if any party involved in a case — including lawyers or authorised representatives — is unable to attend a Monday morning hearing, they must be offered an alternative date at their convenience

Collector orders weekly hearings to

solve these matters in accordance with legal procedures and has set a three-month target to clear the backlog.

According to the order, each office is required to prepare a weekly list of cases that have been pending for five years or more. These cases are to be prioritised for hearing during the special Monday sessions. Once the pending matters are dealt with, regular cases may also be taken up for hearing.

To ensure fairness and accessibility, the order

specifies that if any party involved in a case — including lawyers or authorised representatives is unable to attend a Monday morning hearing, they must be offered

an alternative date at

their convenience. All concerned officers have been instructed to submit a monthly report detailing the hearings conducted and progress made. These reports will be reviewed by the South Goa District Collectorate to monitor compliance and effectiveness.

Additional District Collectors have been assigned the responsibility of overseeing the implementation of the directive. They will ensure that hearings are conducted diligently and that cases are disposed of strictly within the framework of the law.

"The objective is to ensure timely justice and prevent unnecessary delavs in revenue matters." said the order, highlighting the administration's commitment to improving judicial efficiency in the district.

This initiative is expected to significantly reduce the long-pending burden on Revenue Courts and enhance the overall functioning of the revenue administration in South Goa.

Alert villagers thwart development work on converted orchard, paddy field in Curtorim

According to locals, the sub-division and plotting of the land were being carried out without the mandatory

The villagers have demanded a full investigation into the land conversion and development permissions. They argue that unchecked urbanisation will damage the local environment and violate the traditional land use practices of the

The incident has brought to light growing concerns over illegal land conversions and unregulated development in South Goa's rural pockets, with locals vowing to resist any move that threatens the ecological balance and heritage of their village.

'We will resist': Viriato warns outsiders buying land in Goa

S Goa MP completes a year in office; slams state govt over land conversions, draft taxi guidelines, lapses in public healthcare

MARGAO: Marking one year since his election, South Goa MP Viriato Fernandes held a press conference in Margao on Wednesday with South Goa Congress district and block heads, presenting a report card of his performance and reaffirming his commitment to protecting Goa's land, identity, and people's rights.

Warning that outsiders purchasing large parcels of land in the state were taking a "huge risk". Fernandes said Congress would resist any illegal construction, citing the Bhutani real estate project in Sancoale, which the party strongly opposed, as an example of its consistent stance against large-scale developments threatening Goan communities.

He criticised the state government for facilitating mass land sales and conversions through controversial legislation, alleging these laws quietly dispossess locals and ignore ecological con-

On the contentious issue of app-based taxi aggregators, Fernandes condemned the draft guidelines, saying they were introduced without consulting local taxi operators. He accused the Transport and Tourism departments of ignoring stakeholders and supported the opposition voiced by Goan taxi owners, warning the move threatened the livelihoods of thousands.

Outlining his parliamentary contributions, Fernandes said he had raised issues including

the demand for ST reservations in the Goa Assembly, coal pollution, Mhadei river diversion, double-tracking, and threats to Goa's natural heritage. He also called for implementation of the 73rd Constitutional Amendment on Panchayati Raj, UNESCO status for tiatr, and opposed demolition of religious structures like the Dev Khapreshwar temple.

He used Zero Hour and Rule 377 to raise concerns such as coastal erosion, gold smug-

gling, exclusion of villages from eco-sensitive zones, delays elevated in the highway, satellite spectrum issues, and irregularities in the Indian Maritime University entrance exams.

As a member of the Parliamentary Defence Commit-Fernandes said he had supported initiatives for armed forces modernisation readiness. and MPLAD were utilised for a new fishing jetty in Vasco da Gama and restoration of water bodies under the Mission Amrit Sarovar

He also took up the continuation

of operations at Dabolim Airport. protection of homes and temples in Bhoma, and equitable employment for Goans in the postal department. He opposed dredging of rivers and destructive fishing practices like bull trawling and LED fishing. Criticising the government's failure to provide essential medical equipment and address staffing shortages, Fernandes said patients continue to suffer due to neglected healthcare infrastructure.
