CBI 'imposters' extort over Rs 4 lakh from Verna woman

VASCO: Posing as CBI and MIDC police officers, an unidentified group of individuals allegedly cheated a woman residing at Verna of Rs 4.04 lakh.

The incident occurred on December 30 last year at Verna, when fraudsters contacted the complainant via WhatsApp video call.

The fraudsters told the complainant that her cell phone number, linked to her Aadhaar Card, was involved in illegal activities

FAKE ARREST THREAT

- The complainant was told her Aadhaar-linked number was involved in illegal activities and that an FIR had been filed against her
- A fraudster posed as a CBI officer, showed a fake ID, and sent a fabricated arrest warrant and seizure order
- The accused demanded money, threatening to arrest her and her daughter if she didn't pay
- Fearing for her safety, the woman made three payments totalling Rs 4,04,998

such as receiving and concealing in money laundering, human trafficking, and kidnapping. They further falsely informed her that an FIR had been registered

against her. To further intimidate her, one of the fraudsters posing as a CBI officer showed an ID card and sent a fabricated arrest warrant and seizure order.

The accused demanded money to prove her innocence, and threatened to arrest her and her minor daughter if she did not comply.

Fearing for her safety, the woman originally from Gujarat made three separate payments totalling Rs 4,04,998 through UPI and bank transfers.

The Verna Police registered the case against unknown persons under BNS and IT Act. Verna PI Anand Shirodkar is conducting investigations under the guidance of Mormugao DySP Gurudas Kadam.

Call for action, policy reforms to protect marine wildlife in Goa

MARGAO: A troubling pattern of marine wildlife casualties continues to plague Goa's coastline, with environmentalists demanding systemic policy reforms as individual rescue efforts prove insufficient to address the escalating crisis.

Recent strandings at Hollant and Agonda beaches highlight the severity of the situation. A live spinner dolphin, a deep-water species rarely seen in coastal waters, was discovered with multiple cuts believed to be from trawl nets, indicating the animal was injured offshore before becoming disoriented and washing ashore. The dolphin's survival chances remain uncertain given its deep-water nature and injuries.

Simultaneously, a sea turtle was found alive at Agonda beach, likely driven ashore by rough weather, and is receiving Forest Department treatment.

These incidents represent the latest additions to an alarming surge of strandings witnessed over the past two to three months. Multiple marine species, including Humpback Dolphins and

Finless Porpoises—typically near-shore dwelling coastal species—have been washing up dead along Goa's beaches. The Forest Department has been conducting post-mortem examinations, with preliminary findings pointing to human-related activities as primary factors.

Marine wildlife conservationists express frustration over the conspicuous absence of marine life protection measures in the recently released Goa State Biodiversity Strategy and Action Plan 2025-2030. This oversight represents a critical gap in environmental planning, particularly given the interconnected nature of marine conservation challenges.

Environmental advocates are calling for comprehensive measures including stricter fishing regulations, enhanced vessel traffic management, and dedicated marine protected areas.

Without systematic intervention addressing underlying causes of marine wildlife injuries and deaths, Goa's marine biodiversity faces continued degradation, threatening both ecological integrity and the sustainable future of coastal communities dependent on healthy marine ecosystems.

Swimming, entry to waterfalls banned in South Goa

Verna resident booked for firing gunshots

MARGAO: The Verna Police registered an offence against 53-year-old Cedric Menezes Gama, a resident of Verna, for allegedly firing three gunshots. According to the police, Wilfred Menezes Gama from Verna, filed a complaint stating that on June 3, at Verna, his elder brother, Cedric, threatened him due to a strained relationship. The complainant further alleged that Cedric then produced his licenced firearm and discharged it three times, thereby acting rashly and negligently and endangering the life and safety of the complainant, his family, and others in the vicinity. The police registered the offence under Bharatiya Nyaya Sanhita and Arms Act. PSI Rajdatt Arsekar is currently investigating the case.

Colva Police book four for sexual assault

MARGAO: The Colva Police registered a case of alleged sexual assault against four persons based on a complaint lodged by a woman. According to police, four individuals, including two suspected advocates, have been named in the complaint, which was initially received by the Crime Branch in Panjim from the victim, who is currently in judicial custody at Colvale jail. Her detailed statement is pending. The victim, arrested previously by the Crime Branch under the NDPS Act, was produced in court, and a remand was recently taken. Her complaint was recorded by the Crime Branch and forwarded to Colva police for investigation, leading to the registration of the offence on Tuesday. The Crime Branch instructed Colva police, who subsequently registered the offence. Lady PSI Varshada Naik Dessai has registered the case under BNS, and the investigation is on.

Uttar Pradesh peeping Tom arrested

MARGAO: The Curchoem Police arrested Sachin Kumar, 27, from Uttar Pradesh for allegedly peeping at a minor girl through a ventilator in a changing room at a private farm in Kirlapal-Dabal, Curchoem. The accused had been working at the farm for a month. Police registered a case under BNS 2023 and Goa Children Act 2003. After being produced before JMFC Quepem, the accused has been remanded in 14 days of judicial custody and sent to Colvale jail. According to the police, the incident occurred on June 3, 2025, when a family visited the farm in Dabal. After bathing, the minor girl went to the ladies' washroom and found the accused looking through the ventilator. She cried for help, and her family members rushed to her aid.
