# Locals: Taxi apps not just for tourists, we need affordable transport too

Goans counter cabbies' claims that taxi aggregator apps would only cater to tourists

MARGAO: Several residents from across Goa have come forward in support of the draft Transport Aggregator Guidelines 2025, rejecting the claim made by some taxi operators and political parties that appbased taxi services are only for tourists. They argue that the current state of public transport and the inaccessibility of affordable taxis make such services a much-needed option for

Goans as well. Locals said the repeated narrative that Goans don't need taxi services because most households own private vehicles ignores the daily transport struggles faced by many. "Owning a vehicle has become a necessity, not a luxury," said a resident from Cuncolim. "It's only because there's no reliable, affordable public transport that Goans are forced to be self-reliant. But that

doesn't mean we wouldn't prefer the convenience of booking a taxi, especially through a regulated app service."

They pointed out that unlike larger states where aggregator taxis are now a common transport mode even for residents who own vehicles. Goa still lacks this option. "Even in cities like Mumbai and Bengaluru, people who have cars still use Ola or Uber for short trips or late-night travel. Why should Goa be left out of this convenience?" said a Margao resident working in the

Goans also highlighted the challenges of public transport after dark, particularly for those living outside the main hubs. "Beyond Panjim, Margao, Mapusa and Vasco, and outside the limited intercity routes, it's next to impossible to get home at night without your own vehicle," said a working woman from Quepem. ### **CM** Sawant reviews Margao monsoon prep, orders urgent fixes

Dismisses fear of third wave of Covid, reiterates 'bivpachi garaz na'



MARGAO: In a rare late-night meeting at the South Goa Collectorate, Chief Minister Pramod Sawant conducted a detailed review of monsoon preparedness and governance issues with key officials and elected representatives. The Chief Minister assured the Margao Municipal Council of budgetary support, while urging them to fast-track works using existing allocations and 14th Finance Commission grants. A significant development was the identification of 12 unsafe buildings in Margao by the Directorate of Municipal Administration, with two to three structures set to be demolished in the coming days. Funds for the demo-

lition have already been allocated. Monsoon preparedness dominated the discussion, with departments such as the Electricity, Fire, and Water Resources instructed to complete all pending works urgently—this includes desilting drains, repairing roads, removing dangerous trees, and preventing water stagnation. Following a recent incident where a sewer line was damaged during underground cabling, the CM halted all such work and set a deadline for repairs, criticising the lack of coordination between departments.

Projects under GSUDA in Margao and elsewhere in South Goa were reviewed and given a one-month deadline for resolution of pending issues. Sawant also ordered a crackdown on illegally parked rental vehicles in Margao, giving traffic consequences.

police eight days to act, including towing abandoned vehicles and clearing footpaths.

Law and order issues were also addressed, with Konkan Railway directed to step up security across stations. On waste management, Sawant and Margao MLA Digambar Kamat reported progress at the Sonsoddo Hill and Legacy dump sites, while announcing that waste from Sonsoddo will now be treated on-site through a dedicated facility. The MMC will also receive electric vehicles for garbage collection.

The CM responded to a complaint about illegal construction damaging Fatorda stadium's wall by ordering an immediate inspection. Forest rights cases will be expedited under the Collector's supervision, and 16 abandoned stone quarries deemed hazardous during the monsoon will be fenced off. He also reviewed the beautification of River Sal.

The Chief Minister also called for faster clearance of pending cases at mamlatdar and deputy collector levels and endorsed FDA-led initiatives in the district. On health concerns, he noted that Environment Minister Aleixo Sequeira is recovering well in Delhi after completing major treatment. Responding to media queries about a third wave of COVID-19. Sawant said case numbers are low and reiterated his earlier line, "bivpachi garaz na" (no need to fear). ### AAP MLAs back cabbies, want policy scrapped

#### Say new app system will cripple livelihoods

MARGAO: Taxi operators from across Goa met Aam Aadmi Party MLAs Venzy Viegas (Benaulim) and Cruz Silva (Velim) this week, urging withdrawal of the draft Transport Aggregator Guidelines 2025. Calling the 20 May gazette "one-sided", the legislators said rules were framed without consulting traditional cab owners who have served tourists for decades.

"If enforced, the new app-based system will cripple Goan taxi livelihoods," Viegas warned, adding that operators present "hold all permits and have run registered businesses for years." Silva argued the government should shield local firms, not open the field to large platforms that

could displace them. AAP has already opposed aggregator models in coastal belts on similar grounds, the MLAs noted, citing other states where app platforms marginalised traditional drivers. They pledged to raise the issue in the Assembly and press for scrapping the notification.

To craft a "balanced, sustainable" policy, Viegas and Silva proposed a joint committee of officials, union representatives and stakeholders to redraft guidelines through transparent dialogue. The duo also joined operators on the ground during their protest, reiterating full support and warning that continued unrest could dent Goa's tourism image.

#### Fishers urge minister to enforce LED fishing ban

MARGAO: Goenchea Raponkarancho (GRE) and other fishing groups met Fisheries Minister Nilkanth Halarnkar in Porvorim to push for action on eleven key demands affecting the fishing community.

GRE General Secre-Olencio Simoes said the primary focus was enforcement of the High Court of Bombay at Goa's May 8, 2025 order banning LED light fishing, bull trawling, and pair trawling. GRE urged the minister to ensure implementation of all seven directions in the order and to direct the Coast Guard, Coastal Police, and Fisheries Department to enforce compliance, citing continued violations.

GRE also sought a ban on gensets and diesel generators on mechanized boats, stating they are misused to power banned LED lights, threatening marine life and traditional livelihoods.

Calling for stronger penalties and better enforcement, GRE highlighted the lack of amendments to the Goa, Daman and Diu Marine Fishing Regulation Act since its enactment 45 years ago, and pushed for reforms to curb illegal

## Don Bosco Society launches Kharif season with drone tech; CM pledges push for mechanised agri

MARGAO: The Don Bosco Society, under the leadership of Fr George Quadros, launched the Kharif season in Raia on Wednesday with a strong emphasis on mechanised farming and drone-based technology. Chief Minister Pramod Sawant, who inaugurated the event, praised the Society's pioneering work in agricultural innovation and community empowerment. Also present was Director of Agriculture Sandeep Fal Dessai, who lauded Fr Quadros for his decade-long contribution to transforming paddy cultivation in

Fr Quadros, who has led the mechanisation drive since its inception, has expanded the area under mechanical paddy transplantation



from just 40,000 square metres to 40 lakh square metres over the past ten years, with critical support from the state Agriculture Department. The latest leap involves the use of drones—not only to assist with plantation but also for pesticide spraying, significantly improving efficiency and coverage.

Applauding these efforts, CM

Society, led by Provincial Fr Clive Telles, for its role in creating Goencho Xetkar, a grassroots collective aimed at replicating this successful model across Goa. The Chief Minister also tried his hand at flying one of the drones. Unveiling the government's long-term vision, Sawant announced a tenfold expansion of mechanised agriculture—from the current 400 hectares to 4,000 hectares—over the next decade. To achieve this, the state will provide subsidies on drones, transplanters, and other modern farm machinery to Farmer Producer Organisations (FPOs) cultivating up to one lakh square metres of land.

Sawant commended the Don Bosco

As part of the central government's Drone Didi scheme, Goa will procure 10 drones within a month, which will be operated by women for agricultural purposes. "We are working to empower women farmers while increasing productivity through advanced tools," said the Chief Minister.

Emphasising sustainability alongside mechanisation, he called for collective efforts to raise Goa's forest cover from the existing 66% to 76% in the coming years.

In a further boost to agricultural entrepreneurship, Sawant also announced that a Central government-approved Agri Clinic training programme will commence in Sakhali in July 2025. Open to BSc Agriculture graduates, the threemonth course will make participants eligible for 80% subsidised loans to set up agri clinics.

### GMC to get 33 more PG seats

MARGAO: The Goa Medical College (GMC) will get 33 additional postgraduate seats in a phased manner, Health Minister Vishwajit Rane announced, stating that the National Medical Commission (NMC) had approved the expansion following efforts made by the state govern-

ment. Rane said the Dean of GMC has been directed to start the process of recruiting additional senior resident doctors. "We will not wait for the last minute. We must begin the process from now," he said.

He added that the NMC team that visited GMC earlier this year was satisfied with the infrastructure and faculty strength, and approval has now been granted.

Meanwhile, Chief Minister Pramod Sawant said the government was "positive" about the demand for a stipend hike by junior resident doctors and that a decision would be rolled out soon. He made the remarks after meeting representatives of the Association of Junior Resident Doctors at the Secretariat on Tuesday.

### Vertical forests soon to be mandatory in high-rise bldgs

MARGAO: In a significant move towards sustainable urban development, Goa's Urban Development and Town and Country Planning (TCP) Minister Vishwajit Rane announced that the state government will soon issue an official notification mandating the implementation of the vertical forest concept for all buildings with a Floor Space Index (FSI) ranging between 250 and 300.

Speaking to reporters at a tree plantation drive at the Sonsoddo dump yard in Margao, Rane emphasised that the initiative is aimed at increasing urban greenery and promoting environmentally friendly construction practices, particularly in high-density areas.

He described the decision as a "bold step" towards creating greener urban spaces that align with global standards of eco-conscious develop-

According to Rane, all necessary approvals have already been granted, and the guidelines for the vertical forest concept will be formally notified shortly. The government's plan is to make the integration of green infrastructure a core requirement in the design and construction of large-scale residential and commercial build-

Importantly, the Minister made it clear that Occupancy Certificates (OCs) will only be issued to developers who fully comply with the vertical forest guidelines.

The vertical forest concept, made popular globally through iconic projects in cities like Milan and Singapore, involves incorporating shrubs, and other greenery into the architecture of buildings-often on balconies and façadesto reduce pollution, lower ambient temperatures, and improve biodiversity in urban environments.
