# **World Bank report** shows India has lifted millions out of poverty

269 mn rise out of extreme poverty in 10 yrs; subsidised food, cash transfers, greater access to welfare key drivers

AGENCIES, NEW DELHI: In a decade marked by rising inflation, a global pandemic, and heightened economic uncertainty, India has achieved a remarkable feat - lifting 269 million people out of extreme poverty, according to the World Bank's latest global poverty report.

The dramatic fall in poverty comes despite the international financial institution raising the threshold for extreme poverty to \$3 per day (2021 Purchasing Power Parity or PPP), up from the earlier benchmark of \$2.15. Even under this more stringent standard, India's extreme poverty rate dropped from 27.1% in 2011-12 to just 5.3% in 2022-23.

The transformation is evident across both rural and urban India. The rural-urban poverty gap narrowed significantly as rural extreme poverty dropped from 18.4% to 2.8%, and urban poverty fell from 10.7% to just 1.1%. Programmes providing subsiPROGRESS OVER A DECADE, AT A GLANCE

The World Bank estimates that 75.24 million Indians were living in extreme poverty in 2022-23, down from 344.47 million in 2011-12. Using the

previous \$2.15 poverty line, that figure was even lower—just 33.66 million people.

states—Uttar Pradesh, Maharashtra, Bihar, West Bengal, and Madhya Pradesh—played an outsized role in this progress. These populous states, once home to 65% of India's poorest, accounted for nearly two-thirds of the national poverty reduction.

India also made progress at the Lower-Middle-Income Country (LMIC) poverty line, revised to \$4.20 per day. The percentage of the population below this line fell from 57.7% in 2011-12 to 23.9% in 2022-23, signalling broader economic improvements bevond just the extreme poor.

In contrast, the global extreme poverty rate rose during the same periodfrom 9% to 10.5%—as COVID-19 and inflation took a heavier toll on other developing nations. India's performance stands out as a rare success story in a world grappling with economic headwinds.

However, the World Bank cautioned that India's real GDP is still about 5% below its pre-pandemic trend and warned of potential downside risks such as global trade tensions and policy uncertainty.

# Low hatching rate of Olive Ridley eggs at Morjim a cause for concern

Of 15,119 eggs, 4,114 failed to incubate, with only 11,005 hatchlings released

MORJIM: The low hatching rate during the recent Olive Ridley turtle nesting season at the Tembwada hatchery in Morjim has left herpetologists and marine life enthusiasts worried.

Of the 15,119 eggs relocated, a concerning 4,114 failed to incubate, and only 11,005 hatchlings were successfully released.

According to a Right to Information (RTI) response from the Forest Department, 175 Olive Ridley turtles laid a total of 18.243 eggs in North Goa this season. Of these, 15,119 were relocated to Tembwada in Moriim, while the status of the remaining 3,112 eggs is currently unknown.

"The rate of non-hatching of eggs is extremely high and this could be due to extraneous factors like interfering with the natural process of nesting. As vet not understood, natural phenomena guides' marine turtles to navigate long distances and lay eggs on beach locations," explains retired Captain Gerald Fernandes, the recipient of the first WildLife Conservation Award winner and a resident of Morjim.

Atmaram Gauns, Range Forest Officer (RFO) North Goa subscribes to the big number of eggs not hatched to the prevalent weather conditions. "The sudden showers made the sand hard and with it getting hard, the eggs must have got spoiled," explained Gauns.

However, Gauns explanation was torn apart by local Antonio Vaz who claimed: "The unseasonal rains fell towards the end of May by which time all hatchlings should have been released.

#### **BENGALURU STAMPEDE:**

#### **HC seeks govt** reply on 9 key questions

PTI, BENGALURU: Who authorised the RCB victory celebration event? When and how was the decision made? Whether the organisers had obtained the necessary permissions? were among the questions for which the Karnataka government will have to file its replies to the High Court by June 10, in connection with the June 4 stampede that killed 11 people.

The High Court has directed the State government to submit detailed responses to nine critical questions. A division bench comprising Acting Chief Justice V Kameswar Rao and Justice C M Joshi raised the queries on Thursday while hearing a suo motu writ petition initiated by the court in the wake of the tragedy. The government has been asked to file its replies by June 10.

The stampede occurred on June 4 evening in front of the Chinnaswamy stadium here, where a large number of people thronged to participate in the RCB team's IPL victory celebrations. Eleven people died and 56 were injured in the incident.

The bench also questioned the existence of a SOP to manage gatherings of over 50,000 people for sporting events and public celebrations of this scale.
