

DOCS CALL OFF GMC AGITATION AS TALKS FINALLY DEFUSE CRISIS

CM agrees to medics' demands; MOU signed in his presence

PANJIM: The agitation building up at Goa Medical College (GMC) was defused on Tuesday as doctors called off their stir after Chief Minister Pramod Sawant visited the hospital and addressed their demands, taking an upper hand to defuse a crisis that has rocked Goan politics since the weekend.

The protests - sparked by Health Minister Vishwajit Rane's outburst against GMC Chief Medical Officer Dr Rudresh Kuttikar, the video of which went viral and sparked national headlines, had escalated into a national controversy - but

the resolution eased tensions.

The strike, led by the Goa Association of Resident Doctors (GARD) and supported by the Federation of All India Medical Association (FAIMA), demanded an apology from Rane for his remarks in the hospital's casualty ward, with a 24-hour ultimatum.

On Tuesday afternoon, Sawant met with GMC Dean Dr Shivanand Bandekar, Medical Superintendent Dr Rajesh Patel, Dr Kuttikar, GARD president Dr Aayush Sharma, SP Rahul Gupta, and other representatives,

while doctors protested outside the Dean's office, holding placards demanding an apology.

Following discussions, most demands of the doctors were accepted, and a Memorandum of Understanding (MoU) was signed in Sawant's presence. A Police Sub-Inspector (PSI) will be deployed at the Bambolim police outpost, 50 additional police personnel will be stationed at the GMC complex, and a vigilance committee, headed by the Secretary (Health) and including the GMC Dean, Medical Superintendent, and relevant department heads, will address future issues through established

Blow to tiatr as Ravindra Bhavan shuts auditoriums

Pai Tiatr Auditorium, Black Box theatre at Margao venue shut after false ceiling collapse

MARGAO: There was bad news for tiatr lovers on Tuesday as Ravindra Bhavan Margao (RBM) announced the closure of its Pai Tiatr Auditorium and the Black Box theatre. The decision came after a section of the false ceiling collapsed and extensive dampness was detected in the facility, raising serious safety concerns.

According to a report submitted by the Public Works Department (PWD) Division VIII, the closure - effective since May 19 - was deemed necessary to ensure the safety of performers and the public. Initially, water leakage was the main problem, aggravated by heavy rainfall

that delayed emergency roof repairs. Though the roofing work has since been completed, further inspections revealed deeper structural damage.

PWD engineers found the false ceilings of both venues to be compromised, with signs of damp-

ness, and potential risk of collapse.

The 17-year-old ceiling structures were declared unfit for continued use, and the department recommended a complete overhaul before resuming any cultural activities.

India's population touches 1.46 b even as fertility rate drops: UN

PTI, NEW DELHI: India's population is estimated to reach 1.46 billion in 2025, continuing to be the highest in the world, according to a new UN demographic report, which also revealed the country's total fertility rate has fallen below the replacement rate.

UNFPA's 2025 State of World Population (SOWP) Report, The Real Fertility Crisis, calls for a shift from panic over falling fertility to addressing unmet reproductive goals.

Millions of people are not able to realise their real fertility goals, it asserts.

This is the real crisis, not underpopulation or overpopulation, and the answer lies in greater reproductive agency - a person's ability to make free and informed 150 per cent choices about sex, contraception and starting a family, it says.

The report also reveals key shifts in population composition, fertility, and life expectancy, signalling a major demographic transition.

The report found that India's total fertility rate has declined to 1.9 births per woman, falling below the

replacement level of 2.1.

This means that, on average, Indian women are having fewer children than needed to maintain the population size from one generation to the next, without migration.

Despite the slowing birth rate, India's youth popu-

lation remains significant, with 24 per cent in the age bracket of 0-14, 17 per cent in 10-19, and 26 per cent in 10-24.

The country's 68 per cent of the population is of working age (15-64).

Assistência Goa urges Missionaries of Charity to reopen St Inez home

PANJIM: In an extraordinary general body meeting held on Sunday, Assistência Goa unanimously resolved to request the Missionaries of Charity to reconsider their decision to shut down the home for the destitute at St Inez, Panjim.

The charity organisation has faced sharp public criticism after the Missionaries of Charity vacated the premises on April 28, ending over 49 years of service

at the location. The religious order cited a sharp decline in vocations as the reason for being unable to continue its work at the home.

Following the closure, 44 residents from the St Inez facility were relocated to other Missionaries of Charity homes in Carambolim, Quepem, and Cotto-de-Fatorpa.

Amid interest from several NGOs to take over operations at the now-vacant facility, Assistência Goa convened its members and

passed a unanimous resolution to approach the Missionaries of Charity.

"The general body has decided to write to the Missionaries of Charity requesting to reconsider its decision. We will talk to them," said one of the members.

When asked whether the applications from NGOs wishing to manage the facility were considered, the member added, "We will think of it only after receiving the reply from the Missionaries of Charity."

High Court directs PWD to resolve Usgao water crisis in 10 days

Court responds to PIL highlighting severe water shortage in Usgao village

PANJIM: The High Court of Bombay at Goa on Tuesday directed the Public Works Department (PWD) to address the severe water shortage in Usgao, Ponda taluka, and resolve the issue within 10 days. The order came during a hearing of a public interest litigation (PIL) filed by Rohan Naik, who highlighted the acute water scarcity faced by Usgao residents.

Naik's petition, supported by a February

21, 2025, O Heraldo report submitted to the court, detailed the plight of villagers. Advocate Shane Coutinho, representing Naik, filed an additional affidavit stating that in several wards of Ganjem-Usgao village panchayat, drinking water is supplied for less than 30 minutes daily. In some wards, residents rely on bore wells and lack access to treated water. Naik also noted that interior areas do not receive water from the Opa treatment plant,

with no action taken by authorities to address these hardships.

Naik urged the court to direct the PWD to supply treated water to wards

2, 3, 7, 8, 9, 10, and 11 of Usgao, which has 11 wards in total. The division bench, comprising Justices Bharati Dangre and Nivedita P Mehta, acknowledged the

grievances, supported by newspaper clippings annexed to the affidavit. The court took the additional affidavit on record.

3 Swedes arrested with LSD, Ketamine worth Rs 2.6 cr

PANJIM: The Anti-Narcotics Cell (ANC) of the Goa Police has arrested three Swedish nationals for allegedly possessing a substantial quantity of illegal narcotics, with an estimated street value of Rs 2.59 crore.

According to officials, the accused were found in possession of 24.8 grams of LSD in liquid form, 70 LSD blotter papers, 49.3 grams of liquid ketamine and 1.5 grams of ketamine powder. The operation marks a significant seizure in the State's ongoing efforts to curb the

drug menace.

Preliminary investigations have revealed that the foreign nationals had been residing in Goa for approximately two years without valid travel or residential documentation, indicating serious violations of Indian immigration laws in addition to offences under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

The arrested individuals have been identified as Andreas Lorenzo Calic (39), Sami Antero Hilden Tanskanen (36) and Joel Emmanuel Carlstrom (33).
