# **Row over UTTA leadership** sparks fresh tribal unrest

Allegations of fraud, illegal elections and misuse of power levelled against tribal alliance executive; charge Prakash Velip, Govind Gaude used platform for personal gain

**PANJIM**: A coalition of prominent Scheduled Tribe (ST) organisations has jointly filed a petition before the District Registrar and Inspector General of Societies (South), challenging the legality of the current executive council of the United Tribals Associations Alliance (UTTA).

Addressing a press conference, Govind Shirodkar of the Gawada, Kunbi. Velip and Dhangar Federation stated that the organisations party to the petition include the All

Goa Scheduled Tribes Union, Tribal Welfare Organisation, Gaud Iamat Mahasangh Goa, Taleigao Tribal Welfare, Gomantak Gaud Maratha Samaj, Tribes of Goa, and Gomantak Velip Samaj Sangh.

Shirodkar said the petition contains serious allegations of fraud, financial mismanagement, and violation of the UTTA's bye-laws by the present leadership headed by Prakash Velip.

"It contests the validity of the election allegedly held on September 30, 2022, stating that no proper notice was served to member as-

sociations, and that many names listed as attendees or members are fraudulent or not affiliated with the alliance," he said.

The petitioners have sought a declaration that the 2022 election is null and void, the appointment of an independent administrator, and an immediate audit of financial records. They have also prayed for ad-interim relief restraining the current executive council from functioning.

Shirodkar further alleged that both Prakash Velip and Minister for Sports, Art and Culture and Rural

Development Govind Gaude have used the UTTA platform for personal gain. He claimed that the existing leadership does not consult other tribal organisations before making decisions.

He also pointed out that Velip has held office for the last seven years, contrary to UTTA's rules. "According to the bylaws, the term of the executive council of UTTA has to be for three years, and no member can continue for two consecutive terms. But Prakash Velip has been there for seven years," Shirodkar said.

MAPUSA: In a blatant violation of FDA orders, a vendor allegedly broke the official seal of a godown and fled with 1.5 tonnes of bananas that had been seized on suspicion of chemical ripening. The pre-dawn incident occurred at 4:25 am on Tuesday, shortly after the Food and Drugs Administration (FDA) had sealed the premises and collected samples for testing.

"Further investigation is in progress. If the vendor does not cooperate, he will be handed over to the police," the official added.

The FDA was awaiting laboratory test results at the time of the breach, which would confirm whether the bananas were chemically ripened.

# Tenant held for theft of gold, cash at Kundaim

PONDA: The Mardol Police have arrested a tenant for allegedly breaking into his landlord's house and stealing gold ornaments and cash worth Rs 4.62 lakh. The accused, identified as Pradip Navait, a resident of Kundaim, Ponda, and native of Madhya Pradesh, was apprehended a day after the crime.

The incident occurred on 9 June when the complainant, Suchita Naik, had left for work at Kundaim Industrial Estate, and her two children had gone to school. The house, located in Kundaim, was left unoccupied at the time. The accused, who rented a room on the premises, remained in his tenanted room to avoid suspicion.

According to the complaint filed by Suchita Naik, an unknown person had entered her home by forcing open the back door and stole gold ornaments worth approximately Rs 4.5 lakh and around Rs 12,000 in cash from a cupboard.

Following the report, Mardol Police launched an investigation and brought tenant Pradip Navait in for questioning. Upon thorough interrogation, he was found to be involved in the crime and was subsequently arrested.

Local residents, shocked by the betrayal, have demanded a thorough investigation to ensure full recovery of the stolen items.

Mardol Police are continuing efforts to trace and recover the stolen property.

## No ban on mediapersons in hospitals **Team Herald**

BICHOLIM: Chief Minister Pramod Sawant clarified on Tuesday that only photography and videography are prohibited inside hospital rooms, not the entry of mediapersons into hospitals. This followed the display of a 'No journalists allowed' board at the Primary Health Centre (PHC), Bicholim.

The PHC authorities removed the board after the Chief Minister's clarification that the restriction is limited to photography and videography inside hospitals to protect patient privacy.

"Photography and videography are not allowed in hospitals. We did't say media personnel won't be allowed. I am telling again, not a media person but photography and videography will not be allowed in the inte-

# **Coastal MLAs united against** taxi aggregator apps

CALANGUTE: Calangute MLA Michael Lobo on Tuesday stated that all MLAs from Goa's coastal belt are firmly opposed to the introduction of new taxi aggregator apps in the State, reiterating their collective support for local taxi operators.

Addressing the media in Calangute, Lobo said a meeting of coastal MLAs and ministers was held on Monday to discuss the ongoing taxi issue. "Yesterday there was a meeting of coastal belt MLAs and ministers to discuss the taxi issue. CM was supposed to be there but because of the GMC issue

he could not make it. All the coastal MLAs are against bringing in new taxi apps and fully support taxi owners' demand to scrap the proposed cab aggregator guidelines. We will not allow outsiders to bring in cab aggregators," he said.

Lobo emphasised the need for transparency and standardisation of fares. "The issue is how to bring transparency in point-to-point fares; how the customer will get his bill on his mobile or through WhatsApp or email. There should be no bargaining. Digital. online payment with clear point-to-point fares is the only solution," he stated.

Citing Prime Minister Narendra Modi's Digital India initiative, Lobo added, "We give our full support for transparency in fares. I have always supported taxi owners. I'm strongly with local taxi owners to see that cab aggregators do not come from outside to our State.'

He further argued that it is neither viable nor profitable for local taxi operators to work under aggregator models. "What is the status of the taxi meters? Nobody has used them. Taxi owners spent Rs 12.000 to fix them, and every year they have to pay Rs 5,000 for renewal," Lobo pointed out.
