15-day-old baby girl dies of aspiration pneumonitis in Fatorda

MARGAO: A 15-day-old baby girl from Fatorda was brought dead to the South Goa District Hospital (SGDH) in Margao. According to Fatorda Police, the infant was breastfed by her mother and shortly after turned yellowish in colour. She was rushed to the hospital where doctors declared her brought dead. Police conducted an inquest panchanama and later a post-mortem examination, where the Police Surgeon confirmed aspiration pneumonitis as the cause of death. The body was handed over to the family. PSI Sachin Patil of Fatorda Police Station is conducting the inquiry.

Fisherman drowns after getting tangled in net at Reis Magos

PANJIM: A fisherman drowned on Sunday evening at Reis Magos Beach after becoming entangled in his own fishing net. The deceased, identified as Francis Lobo, 57, from Dalndi, Nerul, was rescued by locals and taken to PHC Candolim in a 108 ambulance, where he was declared brought dead. Police said Lobo was casting his net when the accident occurred. Investigations are ongoing.

Corgao man dies in motorcycle mishap at Porvorim

PANJIM: A 56-year-old man from Corgao, identified as Keshav Shetye, died in a self-accident involving a motorcycle at Porvorim on Monday night. According to police, Shetye lost control of his two-wheeler and fell near Jivottam Math, Porvorim. He was initially shifted to a nearby hospital by locals and later referred to Goa Medical College and Hospital (GMC), Bambolim, where he was declared brought dead.

Body of Ghaziabad man found in Mandovi River

PANJIM: The body of a 38-year-old man, identified as Madhur Arora from Ghaziabad, Uttar Pradesh, was recovered from the Mandovi River near Divja Circle on Tuesday evening. The recovery operation was carried out jointly by personnel from the Coastal Police, Panjim Police, Old Goa Police and the Fire and Emergency Services. The body was sent to the Goa Medical College and Hospital (GMC), Bambolim, for post-mortem examination. Police have registered a case of unnatural death and stated that further investigation is currently underway.

Court rejects bail for man accused of stabbing girlfriend in Quepem

MARGAO: The Sessions Court in Margao has rejected the bail application of Anant Kadam, who was arrested for allegedly stabbing his girlfriend, Sakshi Naik, near Shirvoi, Quepem. The incident occurred on 12 May when Kadam allegedly followed Sakshi and complainant Angel Travasso in his car, rammed their scooter, assaulted both, and stabbed the victim in the stomach. Sakshi was hospitalised with serious injuries and has since been discharged from Goa Medical College, Bambolim. Police have booked Kadam under Sections 126(2) and 109 of the BNS 2023. His mobile phone and car were seized, and the weapon used in the attack has been recovered.

Man found dead in rented room in Collem

MARGAO: Kannan Raju, a resident of Souzamoll, Collem, and native of Tamil Nadu, was found dead in his rented room where he had been living alone for the past 15 years. Collem Police received the information from PHC Pilliem and conducted an inquest panchanama at the spot. The body has been preserved at SGDH Margao for medico-legal procedures. Post-mortem examination is awaited. Investigations are being conducted by LPSI Vibhavari Gaonkar of Collem Police Station.

Two injured after car rams tree, overturns in Canacona

MARGAO: Two persons were injured in a self-accident on the old NH-66 at Tamnem-Loliem, Canacona, when their car, travelling from Poinguinim towards Maxem-Loliem, crashed into a tree and overturned. Locals rushed to the scene and helped extract the trapped occupants. While the driver sustained minor injuries, the co-passenger, who was reportedly not wearing a seatbelt, suffered serious head injuries. Both were taken to CHC Canacona and later shifted to SGDH Margao.

Man killed after car hits parked truck in Dharbandora

PONDA: Uttam Sinha, 32, a resident of Haveli-Curti, died after his car collided with a parked truck at Pansule, Dharbandora, on Sunday evening. He was en route to Ponda from Dharbandora when the accident occurred. Sinha was rushed to GMC Bambolim with serious injuries but succumbed during treatment. Locals have raised concerns over faulty road design and irregular truck parking, urging authorities to act to prevent further mishaps.

Lumpy skin disease outbreak among stray cattle scares Siolim residents

SIOLIM: A rising outbreak of contagious Lumpy skin disease (LSD) among stray cattle in the Siolim Marna and Siolim Sodiem panchayat areas has alarmed local authorities, veterinary staff and animal welfare groups. The disease, which causes visible and severe lumps on the animals' skin, is spreading rapidly and putting both infected and healthy cattle at risk.

The disease is spreading rapidly and with no one to care for the stray bovines, the animals are often found dying by the roadside with stray dogs feasting on the decayed animals, said villagers lashed out at the panchayat for turning a blind eye to the issue.

Despite efforts to impound stray cattle, the situation remains grim. With no adequate grazing grounds, an increasing number of concrete constructions and insufficient fodder in cow sheds, cattle continue to roam freely on village roads. Locals estimate that around 800 cows are left astray at any given time, heightening the threat of further infection.



The spread of the disease has put veterinary personnel and goushala staff in a difficult position, as handling and treating these animals pose a risk of cross-contamination. Moreover, NGOs have expressed reluctance to shelter infected animals due to fear of endangering

healthy livestock within their premises.

Siolim Sodiem Biodiversity Management Committee (BMC) confirmed the seriousness of the matter and directed the Panchavat and Health authorities to take up the matter imme-

"After the BMC brought this issue to our notice, the panchayat has informed the Animal Husbandry authorities to work out a solution to this vexatious issue," sarpanch Deepa Naik said.

"Our demand does not end here. We strongly feel that each cattle owner should look after his or her cattle and minimise stray cattle incidents. Once these cattle are infected or meet with accidents, the owners disown them. This is very sad," she added.

mandate that each panchayat take strict action against stray cattle, including impounding them or relocating them to goushalas. Some aggrieved residents have also suggested fitting ear chips to the cows to identify and trace negligent

"It is a great pity to see these cows affected with this sickness and moving on village streets," said William Fernandes, Marna panch and added that he would request the gaushala as to take care of the impounded cattle. However, Veterinary Officer

of the Siolim Government Veterinary Centre, Dr Kripa Acharya, expressed optimism regarding the treatment of infected animals. "Such cases have not so far been brought to light, but if they are, they can be treated by following the necessary SOPs to prevent the disease from spreading," she assured. Dr Acharya however said that there are a large number of strays in the village and requested the panchayats and NGOs to join hands in treating the stravs.

Fourth arrest in Rs 10 cr Ambergris smuggling case

SANGUEM: In a major breakthrough, the Sanguem Police have arrested a fourth individual in connection with the illegal smuggling of whale vomit (ambergris).

The accused has been identified as Sachin Mhatre from Mumbai. He was produced before the Judicial Magistrate First Class (JMFC), Sanguem, who remanded him in police custody for three days.

This arrest is part of an ongoing investigation into the illicit trade of ambergris — a rare and highly valuable marine substance often used in the perfume industry.

Last week, the police had arrested three others: Sainath Shet (50) from Ponda, Ratnakar Karapurkar (55) from Mormugao. and Yogesh Redkar (45) from Sindhudurg. They were caught with 5.7 kg of ambergris, valued at approximately 10.06 crore, at Dabamol, Sanguem.

On Tuesday, the three were produced before the JMFC, Sanguem, and were granted bail after the conclusion of their fourday police custody.

Ambergris, commonly referred to as "whale vomit," is a prohibited substance under the Wildlife Protection Act due to its link with endangered species.
