Kerala govt open to talks over concerns on new school timings

THIRUVANANTHAPURAM: The Kerala government has said it is willing to hold discussions with any group experiencing difficulties following the announcement of revised school timings for high schools in the state. The revised timings, announced on Wednesday, extend the school day by 15 minutes in both the morning and evening sessions, except on Fridays. Under the new schedule, high school classes will run from 9.15 am to 4.15 pm. Muslim scholar and president of Samastha Kerala Jamiyyathul Ulama, Jifri Muthukoya Thangal, has expressed concern that the revised schedule would affect madrassa education for around 12 lakh students.

Siddaramaiah urges Andhra CM to lift ban on entry of Totapuri Mangoes from K'taka

BENGALURU: Karnataka Chief Minister Siddaramaiah has urged his Andhra Pradesh counterpart Chandrababu Naidu to withdraw the ban on entry of 'Totapuri' Mangoes from Karnataka into Chittoor district. In a letter dated June 11, the CM said such unilateral actions, taken without prior consultation or coordination, run contrary to the spirit of cooperative federalism. He also expressed concerns that the move could lead to avoidable tension and retaliatory measures, and disruption of the interstate movement of commodities. Karnataka Chief Secretary Shalini Rajneesh had on June 10 written to her counterpart in Andhra Pradesh K Vijayanand requesting him to revoke the ban.

Road crash in Jhansi leaves three dead

JHANSI: Three members of a family were killed and five others injured after their car rammed into a road divider early Thursday in Jhansi district, police said. The accident occurred around 4 am in Moth area when a cross over utility vehicle travelling from Siddharthnagar to Maharashtra, lost control and hit the divider near Khilli village in Poonch area, Moth Circle Officer Devendra Nath Mishra said. The deceased were identified as Amir (45), Asma (40) and her 15-year-old daughter Parveen, all residents of Itari Bazar in Naugarh, Siddharthnagar district. According to police, the family was returning to their workplace in Maharashtra after celebrating Eid in their

LUCKNOW: Uttar Pradesh Chief Minister Yogi Adityanath on Thursday called child labour a "curse" and urged citizens to unite against the practice by ensuring that every child receives education, security and dignity. Taking to social media platform X on the occasion of World Day Against Child Labour, the CM stressed that only through awareness and collective effort against child labour can a sensitive and empowered society be built for the future. "Child labour is a curse, it cannot be accepted! Let us, on this World Day Against Child Labour, pledge to connect every child with education, safety, dignity and values," he said.

Woman kills husband 15 days after marriage in Maharashtra's Sangli; arrested

SANGLI: Even as ripples caused by the murder of Indore businessman Raja Raghuvanshi are yet to subside, a case has surfaced in Maharashtra's Sangli where a 27-year-old woman allegedly hacked her husband to death just a fortnight after their wedding. The woman attacked her 53-year-old husband, Anil Lokhande, around 12.30 am on Wednesday after he insisted on consummating their 15-day-old marriage, police said, adding the accused has been arrested. The couple resided in Kupwad tehsil of Sangli district, a police official said.

Delhi-Keylong-Leh bus to resume service on Jun 13

SHIMLA: The Himachal Roads Transport Corporation (HRTC) will resume the Delhi-Keylong-Leh bus that passes through the world's highest highway, on June 13, after a gap of eight months. The bus passes through the Manali-Leh highway, the highest in the world, and covers a 1,026-km distance in 26 hours. The one-way fare has been fixed at Rs 1,830, officials said on Thursday With mercury soaring in the plains, the tourists are eagerly waiting for the bus which crosses Baralacha La at 16,020 ft, Lachung La at 16,620 ft, and Tanglung La at 17,480 ft.

Sonam, Raj accuse each other of being mastermind of honeymoon murder

PTI , SHILLONG: Sonam Hills district on June 2. Raghuvanshi confessed to be part of the conspiracy to kill her husband Raja during their honeymoon in Meghalaya, and accused Raj Kushwaha of being the mastermind of the Indore-based businessman's murder, a senior police officer said on Thursday.

On the other hand, Kushwaha, Sonam's suspected boyfriend, put the blame for orchestrating the murder on her, Deputy Inspector General of Police DNR Marak said on Thursday.

Sonam and Kushwaha are among the five people arrested in connection with the murder of Raja Raghuvanshi, whose decomposed body was recovered from a gorge in Sohra area of East Khasi

"Sonam confessed to be a part of the conspiracy to kill her husband but we are yet to establish who the mastermind of the plot is. Both Sonam and Raj are blaming each other," Marak told PTI.

He said the investigation has started to unearth the conspiracy.

"There are inconsistencies in the statements collected individually of all the accused persons. We are also investigating the amount of money Sonam promised to pay to the hitmen and how much she had already paid," Marak said.

had left their suitcase at a homestay in Sohra before going missing, and the 'mangalsutra' and a ring found in it helped investigators crack the honeymoon murder case, Meghalaya DGP, I Nongrang, said. Sonam (25) and Raja (29) got married in Indore on May 11 and reached Meghalaya via Guwahati in Assam on May 20 for their honeymoon. Both of them went missing on May 23 in Sohra in East Khasi Hills district, hours after checking out of a homestay at Nongriat village. "We recovered Sonam's 'mangalsutra' and a ring from the suitcase the couple abandoned at a homestay in Sohra. A married woman leaving behind the ornaments gave us a clue to pursue her as a suspect in the case," Nongrang told PTI on Wednesday evening. 'Mangalsutra' is a necklace worn by married Hindu women. Raja's body was found in a gorge near Weisawdong Falls on June 2.
