Six plane crash victims identified on basis of DNA samples: Officials

PTI, AHMEDABAD: Authorities at the Ahmedabad Civil Hospital have so far identified eleven victims of the June 12 Air India plane crash through DNA testing and started the process to hand over the bodies to their relatives, officials said on Saturday.

Speaking at a press conference, Dr Rajnish Patel, professor of surgery at the government-run B J Medical College, said the mortal remains of one victim were handed over to the family on Saturday while those of another two victims will be handed over

by the day's end.

"DNAs of 11 victims of Ahmedabad plane crash have matched with kin so far," he said.

The civil hospital will contact the families as soon as a DNA match is found, and they should not rush to the hospital, he added.

The bodies of eight victims, who were identified by their relatives and did not need DNA profiling, have already been handed over to their families by the hospital, officials had said earlier.

Alok Pandey, Relief Commissioner and Revenue Secretary of Gujarat, said the deceased from the state hailed from 18 of the 33 districts.

As many as 230 teams were formed to coordinate with the families and the kin of 11 foreign nationals who died in the tragedy too have been contacted, he said.

The victims included 241 of the 242 passengers and crew members on board the London-bound flight. One passenger miraculously survived.

MANGALURU PLANE CRASH SURVIVORS RECALL HORROR, GRATITUDE 15 YEARS ON

PTI, MANGALURU (KARNATAKA): Fifteen years after the tragic crash of Air India Express flight IX 812 in Mangaluru airport, which killed 158 people, a survivor of the accident, K Pradeep, still recalls the day with solemn reflection and quiet gratitude. That aircraft overran the runway on May 22, 2010 and crashed. Pradeep, now a civil contractor in the city, visits the crash memorial at Kulur every May 22. He lays flowers at the plaque, stands in silence for the lives lost, and offers prayers.

"It was the charity work done by my parents and their blessings that saved me," he told PTI, recalling the horrific moment when the Boeing 737 aircraft failed to stop and plunged into a gorge. After paying tribute, he also visits temples to thank the divine for what he calls a miraculous escape. Another survivor, Usman Farooq, who now works with an ambulance service, also believes his survival was due to divine intervention. He remembers how the portion of the aircraft near the wing, where he was seated, broke apart just in time to allow his escape. Farooq said he owes his life to the Almighty and sees his work in emergency services as a way of giving back.

As many of the bodies are burnt beyond recognition or damaged otherwise, authorities are carrying out DNA tests to establish the identity of the victims.

In order to expedite the DNA matching process, Gujarat Minister of State for Home Harsh Sanghavi held a meeting with the officials of the state Forensic Science Laboratory (FSL) on Saturday.

"Apart from forensic experts from all over Gujarat, several experts sent by the Centre are working round the clock to match DNA samples. As soon as the results come, we send them to the civil hospital so that families can claim the bodies," he told reporters.

"As of Friday, relatives of nearly 220 deceased persons had approached the police to give their samples," said police inspector Chirag Gosai, who is handling the affairs at the post-mortem room. They are sent to BJ Medical College, he added.

KOZHIKODE CRASH SURVIVOR RELIVES TRAUMA AFTER AHMEDABAD TRAGEDY

PTI, THIRUVANANTHAPURAM: He is still finding it hard to come to terms with the horrendous memories he had on board a crashed aeroplane around five years ago. The jerking sounds, screams of children and a call from a fellow passenger from behind to pray to the Almighty were still part of his nightmares, said Ashique, a Keralite man who had a narrow escape in the flight crash that happened at Kozhikode airport in 2020. The tragic plane crash in Ahmedabad, which killed 241 people on board a London-bound Air India flight on Thursday, brought the horrors of the Kozhikode flight accident back to the minds of people, including Ashique.

He came with his father to give a statement as a witness. He was then sent away with his father. No arrests or detentions have been made," the Crime Branch said.

Talking to reporters, Aryan said the crash happened 24 seconds after he started recording.

"I felt very scared because of what I witnessed. My sister was the first one to see my video, who then informed my father. I had no idea the flight would crash," he said.

Red Alert in Coastal Ka'taka

PTI, MANGALURU (KARNATAKA): The India Meteorological Department (IMD) has issued a red alert for coastal Karnataka, including Dakshina Kannada district, where heavy rainfall since Saturday afternoon has disrupted daily life.

Several low-lying areas of Mangaluru city have reported waterlogging. Roads beneath the Pumpwell flyover were submerged, causing severe traffic disruptions.

A bus broke down at a flooded stretch, prompting passengers and locals to push it to the roadside. Roads on Car Street, Lower Bendur, Kottara and few other low lying areas have reported heavy inundation and flooding.

The red alert remains in effect until the morning of June 16, with authorities warning of continued heavy rainfall across the Dakshina Kannada district.

Four Naxalites killed in MP encounter include 3 women

PTI, BALAGHAT (MP): Four Naxalites, including three women, were killed in an encounter with security forces in a forest area of Balaghat district in Madhya Pradesh on Saturday, Chief Minister Mohan Yadav said.

Balaghat is a Maoist-affected district that shares borders with Maharashtra and Chhattisgarh.

A grenade launcher, a self-loading rifle (SLR), two .315 bore rifles, other weapons and material were recovered from the site, Yadav said.

Incidentally, the encounter took place when Union Home Minister Amit Shah was in the state to inaugurate the BJP's training camp in Pachmarhi.

"One male and three female armed Naxalites have been killed in an encounter during a joint operation of (MP's anti naxal force) Hawk Force, District (Police) Force and CRPF in the forests of Pachmadar and Katejhiriya," he said.

The search operation, in which a large number of police officers and jawans are engaged, is still underway, he said. "Hearty congratulations to our indomitable, courageous soldiers and senior police officers of the state for this success," CM Yadav added.

Talking to PTI over the phone, Balaghat Zone Inspector General of Police Sanjay Kumar said efforts to identify the deceased Naxalites were on.

The operation against the Naxalites is still on, he said from the spot located in Roopjhar police station limits, about 40 km from the district headquarters.

The operation was launched following intelligence inputs about their movement received last evening, he said. Superintendent of Police Aditya Mishra said the Maoists killed were hardcore cadres of the MMC zone's GRB division, adding that efforts are underway to ascertain their identities.

"Security forces had received intelligence inputs about the presence of a group of Maoists belonging to GRB division. Acting on the tip-off, a joint search operation was launched by Hawk Force, district police, and CRPF personnel. During the operation, the Maoists opened fire on security personnel with an intention to inflict casualties and loot their weapons — Aditya Mishra, Superintendent of Police

Cholera detected in Odisha; diarrhoea toll rises to 5

PTI, BHUBANESWAR/JAJPUR (ODISHA): With the death toll due to diarrhoea rising to five on Saturday and 1,500 others being infected with the water-borne disease in Odisha's Jajpur, the Centre rushed three separate expert teams to study the ground situation in the district where some cases of cholera have also been detected, officials said.

"In view of the diarrhoea outbreak in different parts of the district, the holidays from June 14 to 16 are hereby cancelled.
