Buffalos emerge as new hazard on Ponda roads after spate of fatal accidents

Locals say animals not visible at night due to their black colour; claim human lives at risk

PONDA: After a series of fatal road accidents involving stray cattle, buffalos are now emerging as a major road hazard across the Ponda, Dharbandora, and Dhavli-Farmagudi highway belt. Their dark colour makes them nearly invisible at night, particularly when streetlights are not functioning, leading to deadly crashes that have claimed both human and animal lives in recent weeks.

Two serious incidents were reported this month alone. On 13 June (Friday) night, Dikshay Gurudas Gaude (30), a resident of Rajinwada, Bandora, tragically lost his life after his scooter collided with buffalos sitting on the road near Gaunem. Sexual assault case against four, including two suspected advocates

MARGAO: Colva Police have registered a case of rape against four individuals, including two suspected to be advocates, following a complaint by a woman currently in judicial custody. The investigation has now been handed over to the Margao Women's Cell. Sources said the complaint was received from the Crime Branch, Panjim, as the woman is an accused in a separate NDPS case and is lodged at Colvale jail.

Her statement was recorded by the Crime Branch and forwarded to Colva Police, who registered the offence under Sections 140(3), 64(1), 64(2)(m), and 70(1) of the Bharatiya Nyaya Sanhita (BNS). Police confirmed that the probe is in its initial stages and the woman's detailed statement is yet to be recorded. The complaint alleges that the victim was sexually assaulted by the accused.


