Smuggled booze laden container truck catches fire at Dhargal

Vehicle's cabin gets damaged; driver flees before authorities arrive

DHARGAL: A Nagaland-registered container truck laden with smuggled liquor suddenly caught fire early Tuesday morning while parked along the roadside at Dhargal on National Highway 66.

Alerted by passersby, personnel from the Pernem Fire and Emergency Services (FES) rushed to the site and successfully doused the blaze. Despite their efforts, the truck's cabin was damaged.

The driver reportedly fled the scene before the authorities arrived. Police and excise officials are investigating the ownership and legality of the liquor transported in the vehicle.

Speaking to mediapersons, a Fire and Emergency Services (FES) personnel said, "We received a call at around 7.45 am. We reached the spot within 10 minutes. We extinguished the fire and during the search, liquor bottles were found inside



the vehicle. We immediately contacted police and excise of-

Meanwhile, Pernem Congress leader Jitendra Gaonkar alleged that such illegal activities are going on, on a regular basis and blamed the chief minister for it and demanded a crackdown of such activities.

Police crack down on tobacco sales near schools in South Goa

Shopkeepers warned against selling tobacco products within 100 yards of educational institutions; 1,474 COTPA cases booked in 2025 so far

MARGAO: Police stations across South Goa have been directed to visit shops selling tobacco products in their jurisdictions and strictly instruct them not to sell within a 100-yard radius of educational institutions, Sanguem PI Ditendra Naik confirmed that his beat staff have already begun informing local shopkeepers of this regulation.

This initiative comes under the enforcement of the Cigarettes and Other Tobacco Products Act (COTPA), 2003. The law prohibits the sale of tobacco near educational institutions and restricts smoking in public spaces, allowing it only in

designated smoking areas at and colleges to discourage hotels, restaurants, airports, and select open areas.

City advocate Vinay Patker highlighted that the Act clearly prohibits smoking in places such as auditoriums, theatres, hospitals, public transport, restaurants, hotels, government and private offices, courts, markets, and educational institutions. "The person selling tobacco is required to verify that the buyer is not a minor, but such checks are rarely done. This negligence is making smoking increasingly common among underage children," he said.

According to Patker, Section 6(b) of the Act specifically restricts tobacco sales within 100 yards of schools

access by youth.

Police in South Goa have actively enforced COTPA, registering 1,474 cases until April 20, 2025. In 2024, a total of 5,480 cases were booked. The Vasco Railway Police recorded the highest number of violations this year with 194 cases, followed by Margao Police Station with 183 and Dabolim Airport with 170. Retired teacher Michal

> Fernandes supported the initiative, noting that schools are doing their part by advising students on the dangers of tobacco. He also reiterated the law's stipulation under Section 6(a) and 6(b) of COTPA, which prohibits the sale of tobacco to

and by minors, and within 100 yards of schools.

Milind Raiker, a concerned parent, stressed the need for sustained awareness campaigns to educate the public on the health hazards of tobacco. "Public Health is a State subject. It is the duty of authorities to ensure the effective implementation of COTPA," he said.

Another parent, Sandeep Pednekar, emphasised the role of families in preventing tobacco use. "Parents must communicate openly, educate children on the dangers of tobacco, and set a positive example," he said, adding that family influence can significantly shape children's attitudes toward

Utilise CSR funding for child welfare, **HC** asks govt

PANJIM: The High Court of Bombay at Goa has directed the government authorities to look into the pragmatic suggestions for the utilisation of CSR funding for child welfare and rehabilitation of children forced into street begging.

Adv Moses Pinto, who had filed a public interest litigation (PIL) writ petition submitted pragmatic suggestions for the utilisation of CSR funding for child welfare and rehabilitation.

The Court took these suggestions on record and asked the State government to make its stand clear as to which of these suggestions were feasible and which can be implemented by the government either in its entirety or in its modified form.

The Court has also asked the additional government advocate to apprise the respondents namely the Department of Women and Child Development, the Goa State Commission for Protection of Child Rights, the Directorate of Education and the Directorate of Transport, of these suggestions and also, on his own, can advise the State government on the issue.

The matter has now been posted for further hearing on June 30.

HC quashes lookout circulars against directors of Idyllic Goan Gateways

PANJIM: The High Court of Bombay at Goa quashed and set aside the Lookout Circulars (LOCs) issued against the directors of Idyllic Goan Gateways in connection with an alleged investment fraud case involving Myron Rodrigues and Deepali Parab.

The petitioners Nolan Antao, Joaquim Pires, Vijay Joil, Navnik Pereira and Sushant Ghodge had approached the High Court after police issued LOCs against them despite the fact that their names were not included in the charge sheet filed by the Crime Branch.

Arguing on behalf of the petitioners, senior advocate Nitin Sardessai stated that the names of the Petitioners do not feature either in the complaint or in the subject FIR.

Govt to begin sluice gate repairs from Oct

PANJIM: The Water Resources Department (WRD) will begin repairing sluice gates from October this year, and the government will also provide support for cleaning salt pans. Chief Minister Pramod Sawant assured salt farmers from Sant Andre constituency on Monday.

Timely action averts major tragedy as fire breaks out in school bus

MARGAO: A major tragedy was narrowly averted on Monday morning after a minor fire broke out in a Balrath school bus near a secondary high school in Margao. Fire and Emergency Services were promptly alerted and swiftly brought the situation under control.

The incident occurred at approximately 11.30 am, shortly after the schoolchildren had been dropped off for the day. No one was inside the vehicle at the time and no injuries were reported.

"It was a scary experience," said one parent who happened to be passing by the roadside as the fire broke out.

According to Station Fire Officer (SFO) Gil Souza of Margao Fire Station, the fire was first noticed by a passing scooter rider while the driver was manoeuvring the bus. The rider quickly alerted the driver, who then took immediate precautionary measures. SFO Souza stated, "At around 11.35 am, we received an emergency call informing us that a fire had broken out in a school



bus. Sub Officer R S Khutker, along with our team and one fire tender, rushed

to the site. Fortunately, no one was inside the bus at the time, and no injuries were reported."

He added, "In the morning, school children had already been brought to school. The incident occurred afterwards. Locals and other passers-by rushed to the spot upon hearing the news."

The fire was determined to have started due to a short circuit in the electrical wiring connected to the bus battery. However, the timely response by fire personnel prevented the flames

from reaching the engine or causing major damage to the bus.

"The driver did a wonderful job in restricting the fire by using a fire extinguisher before our team arrived," said SFO Souza.

While the estimated loss has been pegged at Rs 20,000, the quick action of the fire department saved property worth Rs 3,00,000.
