पेडणे, दि. १८ : पेडणे पालिका क्षेत्रातील कोटकर वाडा या ठिकाणी मुख्य रस्ता पेडणे मार्गे कोरगाव हरमल जाणाऱ्या मुख्य रस्त्यावर एक जुना मिनी साकव पूल आहे. त्या पुलाखालील माती दाग हळूहळू कोसळत असून हा पूल केव्हाही कोसळण्याची शक्यता आहे. त्यामुळे सार्वजनिक बांधकाम खात्याच्या वरिष्ठ अधिकार्यांनी याकडे लक्ष देऊन हा पूल लवकरात लवकर दुरुस्ती किंवा त्या ठिकाणी नवीन पूल उभारण्यासाठी प्रक्रिया सुरु करावी. अशी मागणी स्थानिक नागरिकांनी केली आहे.

हा पूल जर कोसळला तर पेडणे मार्गे कोरगाव हरमल जाणारा रस्ता पूर्णपणे बंद होणार असून, येता जाताना दुसरा पर्यायी रस्ता नसल्यामुळे लोकांना दूर ठिकाणाहून नियोजित स्थळी जावे लागणार आहे. त्यासाठी सरकारने यावर त्वरित

उपाययोजना करावी. अशी मागणी या भागातील स्थानिक नागरिकांबरोबरच वाहन चालक राजू नरसे यांनी केली आहे.

पेडणे पालिका क्षेत्रातील कोटकर वाड्यावरील हा पूल खूप जुना असून तो सहजासहजी कोणत्या लक्षात येत नाही.

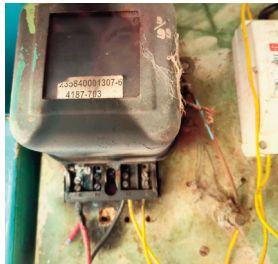
