Mumbai's Powai Lake overflows after heavy rains

MUMBAI: The scenic Powai Lake in Mumbai overflowed on Wednesday morning following heavy rains in its catchment areas for the last two days, a civic official said. Its water is not potable and is used only for industrial purposes. Having a storage capacity of 545 crore litres, the lake started overflowing at 6 am, the official said. "The lake has reached its capacity and started overflowing due to heavy rainfall in its catchment areas over the past two days," the official said, adding the water level was at 195.10 feet. The water body, a popular recreation spot surrounded by greenery and high-rises in Powai area, has started overflowing 20 days earlier compared to last year. When the lake is full, the water area is around 2.23 square kilometres, while the catchment area is 6.61 sq km. Located 27 km from the Brihanmumbai Municipal Corporation headquarters, the Powai Lake was built in 1890 at a cost of Rs 12.59 lakh.

Ahmedabad plane crash: 208 victims identified through DNA testing

Bodies of 35 foreigners among 170 handed over to kin

PTI, AHMEDABAD: At least 208 victims of the Air India plane crash in Ahmedabad have been so far identified through DNA testing and 170 bodies handed over to the families, an official said on Wednesday.

The London-bound Air India flight AI-171 carrying 242 passengers and crew members crashed soon after take-off in Ahmedabad on June 12. All but one passenger on board the plane died along with at least 29 on the ground when the aircraft smashed into the hostel complex of B J Medical College.

Authorities are carrying out DNA tests to establish the identity of the victims as many bodies were charred beyond recognition.

"Till Wednesday evening, 208 DNA samples have been matched, and 170 bodies have been handed over to the respective families," Ahmedabad Civil Hospital's medical superintendent Dr Rakesh Joshi told reporters.

The victims whose bodies were handed over included four Portuguese nationals, 30 British nationals and one Canadian.

Following the crash, 71 injured persons were admitted to the civil hospital, Dr Joshi said.

"Of these 71, only seven

are currently undergoing treatment here, while 12 other patients are admitted to private hospitals in Ahmedabad and Dahod. Three patients lost their lives during treatment," said Dr Joshi. The remaining patients were discharged after treatment.

GUJ GOVT TO SEEK RS 2.70 CR FROM AIR INDIA FOR LOSS OF RESIDENT DOCTORS' PROPERTIES

PTI, AHMEDABAD: The Gujarat government will seek Rs 2.70 crore from Air India for the loss of belongings of resident doctors after its London-bound flight crashed into the hostel of a medical college in Ahmedabad last week, a state minister said on Wednesday. Addressing a press conference in Gandhinagar, Gujarat Health Minister Rushikesh Patel, who is also the government spokesperson, said the state has not decided yet on the issue of providing compensation to those who were killed on the ground after the plane crash, including four MBBS students. The Boeing 787 Dreamliner (AI 171) flight with 242 passengers and crew members on board crashed into a hostel and canteen of the B J Medical College in Meghainagar area moments after taking off from the Sardar Vallabhbhai Patel International Airport in Ahmedabad in the afternoon on June 12. Apart from 241 persons on board the flight, 29 on the ground were killed in the incident. "As per our assessment, properties (personal belongings) of Rs 2.70 crore of resident doctors (who used to live in the hostel at the time of plane crash) were damaged. We will claim that from Air India," he said.

ples of 250 victims – persons on board the ill-fated flight as well as those killed on the ground -- were collected for identification.

The process of DNA matching of other victims is going on, officials said.

Air India cancels 3 international flights due to maintenance

PTI, MUMBAI: Air India has cancelled three of its international flights on Wednesday owing to various reasons, including maintenance and technical issues.

Two of these flights were cancelled after the passengers had already boarded the aircraft, the airline said.

The airline said it had to cancel its Toronto-Delhi flight AI188 of June 18 due to extended maintenance and consequently operating crew coming under regulatory flight duty time limitation norms.

Passengers, who had already boarded the aircraft, were disembarked following cancellation of the flight, it said.

Also, flight AI996 from Dubai to Delhi on June 18, 2025 was cancelled due to technical reasons and passengers were disembarked after boarding, as per Air India.

The flight safely landed back in Delhi and all passengers were disembarked.

Oil extraction from Liberian ship that sank to take more time

Monsoon conditions cause delay, says DGS

PTI, KOCHI: The Directorate General of Shipping (DGS) on Wednesday said that due to the prevailing peak monsoon conditions and associated operational risks, it will take more time

to extract oil from the Liberian-flagged ship that sank off the Kerala coast last month.

The DGS said that the present weather conditions provide only a "narrow and

fragmented working window", which is unsuitable for "stable and safe" oil extraction efforts.

"Further delay would provide a more reliable window to safely conduct hot tapping and oil recovery," it said.

It further said that the vessel Nand Saarthi – from where saturation diving operations for oil extraction were to be conducted – remains at Kochi port due to prevailing adverse sea conditions.

"Upon improvement in weather, it will sail to the wreck site. Oil recovery equipment onboard Nand Saarthi is to be transferred to Canara Megh for the next phase.

Navy inducts first anti-submarine warfare shallow water craft Arnala

PTI, VISAKHAPATNAM: INS Arnala, the first warship in the anti-submarine warfare shallow water craft series equipped to conduct subsurface surveillance, search and rescue missions and low-intensity maritime operations, was inducted into the Indian Navy on Wednesday.

The commissioning ceremony at the Naval Dockyard here was presided over by Chief of Defence Staff Gen Anil Chauhan.

The 77-metre long warship, with a gross tonnage of over 1490 tonnes, is the largest Indian naval warship to be propelled by a diesel engine-waterjet combination, the Navy said.

India launches Operation Sindhu to evacuate its nationals from Iran

PTI, NEW DELHI: India on Wednesday announced launching 'Operation Sindhu' to evacuate Indian nationals from Iran as the conflict between Iran and Israel showed no sign of letting up.

"India accords highest priority to the safety and security of Indian nationals abroad," the Ministry of External Affairs (MEA) said.

More than 4,000 Indian nationals are living in Iran and half of them are students.

The MEA said the Indian embassy in Tehran has evacuated 110 Indian students from northern Iran, assisting them in safely crossing over into Armenia on Tuesday.

The students have travelled by road to the Armenian capital, Yerevan, under the supervision of the Indian missions in Iran and Armenia.

"These students departed Yerevan on a special flight at 1455 hours on June 18 and will arrive in New Delhi in the early hours of June 19 as part of the initial stages of Operation Sindhu," the MEA said.

New Delhi said it is grateful to the governments of Iran and Armenia for the smooth facilitation of the evacuation process.

In view of the deteriorating situation as a result of the ongoing conflict between Iran and Israel, India has been taking various steps over the last several days for the safety and security of Indian nationals in Iran.

India's Shubhanshu's Axiom-4 mission put off to June 22

PTI, NEW DELHI: Indian astronaut Shubhanshu Shukla's Axiom-4 mission to the International Space Station has been postponed to June 22, to allow NASA to evaluate the operations on the orbital lab after the recent repairs in the Russian section, Axiom Space announced on Wednesday.

The Axiom-4 mission, which marks the return to space for India, Hungary, and Poland, was earlier scheduled for lift-off from NASA's Kennedy Space Centre in Florida on June 19 onboard SpaceX's Falcon 9 rocket.

3 militants arrested in Manipur

PTI, IMPHAL: Three militants were arrested from various parts of Manipur on charges of extortion, police said on Wednesday.

Two members of the Kangleipak Communist Party (PWG) were arrested from Ningthoukhong Kha Khunou in Bishnupur district.

They were identified as Khomdram Joy Singh (51) and Maibam Memcha Devi (49). They were involved in extorting local businesses, police said. A .32 pistol with an empty magazine was seized from them.

An active member of KCP (MFL) was arrested from Chingmeirong in Imphal East district. Identified as Yumnam Jenica (22), she was also accused of extorting small businesses in the area.

THREE MAOISTS KILLED IN ANDHRA PRADESH IN EXCHANGE OF FIRE WITH POLICE

PTI, RAMPACHODAVARAM: Three Maoists were killed in an exchange of fire with Police here during a combing operation in Alluri Sitharamaraju district on Wednesday morning, said a police official. According to the preliminary information, the combing operation was carried out based on prior intelligence inputs, while the identities of the deceased are yet to be ascertained, police said. "Three Maoists were killed in an exchange of fire with Police," Alluri Sitharamaraju district superintendent of police (SP) Amit Bardar told PTI. Rampachodavaram DSP GS Prasanth observed that the bodies of the Maoists are yet to be recovered. SC asks Bihar, Delhi senior cops to ensure safety of minor seeking annulment of marriage

PTI, NEW DELHI: The Supreme Court on Wednesday directed the Bihar director general of police and the Delhi police commissioner to provide adequate safety to a minor girl seeking annulment of her marriage.

A bench of Justices Ujjal Bhuyan and Manmohan said the girl and her friend feared threat to their lives and directed the authorities to get in touch with them and provide necessary assistance to them.

The girl, who claimed to be on the run with her friend, claimed being forcefully married off on December 9, 2024, at 16-and-a-half years of age, and now her husband and in-laws were coercing her to remain in the union, complaining about the money they spent on the wedding.

The bench agreed to hear the plea and sought the response of the Bihar administration and her husband and in-laws by July 15.

"She was not allowed to

return to her parental home by her in-laws who claimed to have given and spent a lot of money for the marriage and repeatedly told her that they wanted a baby. Her husband who is a civil contractor claimed that the petitioner's parents were indebted to them and she would have to continue in the marriage rather than go for further studies to pursue her dream of becoming a teacher or a lawyer," her plea said.

She claimed that she wanted

ed to study further but she was kept under confinement by her father-in-law despite the promise of allowing her to return to her parents.

"The present writ petition...has been filed through next friend by sixteen-and-a-half year-old minor petitioner who is facing threat to her life for protesting against continuing in a child marriage solemnised under coercion against her wish to continue her education," the plea said.
