# Pharma co. faces backlash over out-of-state interviews for Goa jobs

**REPEAT OFFENDER: Politicians, activists rage at Verna-based company for** advertising recruitment outside Goa; demand policy to mandate local hiring

MARGAO: A familiar battle has reignited in Goa as pharmaceutical company has once again advertised job interviews for Goa-based roles—but scheduled these crucial selection rounds outside the state.

This tactic has drawn sharp criticism from Goan activists, youth leaders, and now political representatives, who argue it systematically excludes local talent.

Fatorda MLA Vijai Sardesai strongly condemned the company's move, calling it an "outrageous betrayal of Goan vouth."

"The very fact that companies like Indoco feel bold enough to deny employment to Goans in their own state shows how indifferent this government is to its people," Sardesai said. "This is not just about one company—it's about a complete lack of will to safeguard Goan livelihoods." Sardesai warned that such practices have become a disturbing trend in the pharma sector and stressed the urgent need for policy intervention

In May 2024, a similar move by the company was met with mass protests. The pharma company had advertised walk -in interviews in Boisar-Mumbai, but was later forced to cancel the interviews. But despite this precedent, the company appears to be repeating the practice prompting renewed outrage.

#### **Ravindra Bhavan closure: CM** assures work timeline

MARGAO: Chief Minister Pramod Sawant on Friday assured that he would soon assess the situation surrounding the closure of the Ravindra Bhavan auditorium in Margao. However, he declined to comment on recent political developments in the state.

"I will take stock of the situation from the concerned department. Once I understand the issues, I can provide a timeline for the repair work," he told reporters during his visit to Margao.

The Chief Minister's assurance follows growing frustration among tiatrists and cultural stakeholders, as the main auditorium has remained shut for several days due to damage to its false ceiling. Sources said the closure was ordered as a safety precaution after structural issues were detected.

The delay in repair work and poor communication from authorities have left the tiatr fraternity in limbo. Several shows have been cancelled or relocated, leading to financial losses for performers, organisers, and local vendors who depend on cultural events for income.

# Monsoon wreaks havoc on roads left unrestored after digging in Gogol, Vidyanagar

MARGAO: Residents of Gogol and Vidyanagar have raised concerns over the poor condition of roads in their locality following sewerage and piped natural gas excavation works. Despite repeated complaints, many roads remain unrepaired and unhotmixed, causing serious inconvenience during the monsoon.

Locals allege that the Public Works Department (PWD) failed to repair or hotmix roads before the rains, as was expected. While a few stretches were temporarily covered with mud, these sections have now washed away, worsening the road condition due to heavy rainfall.

Roads in areas like Gogol Housing Board, Vidyanagar, Ramnagri, Davorlim, and Rawanfond have seen patchwork repairs that have not held up. Potholes waterlogging are now widespread, creating hazards for mo-



torists and pedestrians alike.

A retired PWD engineer said unseasonal rains severely impact road surfaces, leading to cracks, potholes, and overall deterioration. "Water penetration and poor maintenance accelerate damage," he

Milind Naik, a Ramnagri resident, blamed the situation on prolonged excavation work and incomplete trench restoration. "These roadworks have also caused frequent power cuts. Two-wheeler riders are particularly at risk due to the pothole-ridden

roads," he said. Another local, Akash Naik, said that even where digging was completed, trenches remain "Workers uncovered. are moving deeper into Gogol without restoring earlier sections. The roads are now dangerously narrow and unstable," he added.

Residents also pointed out that some roads hotmixed, but questioned the quality of the work. "If proper metal mix was used, these roads could have lasted longer," one said.

Locals are demanding immediate action from the authorities to complete the pending repairs and ensure better coordination for future civic works. "Basic amenities like safe roads shouldn't be a luxury," they said.

### 11 days on, defunct traffic signal at Gogol reactivated

MARGAO: The major traffic signal at the busy Gogal fourroad junction, under Fatorda police jurisdiction, was reactivated on Friday after remaining non-functional for 11 days. The issue was highlighted by O Heraldo, prompting swift action by the concerned authorities to address public complaints.



Fatorda Traffic Cell Police Inspector Filomena Costa said the signal was repaired and a trial run was conducted on Thursday night. It became fully operational by Friday morning, bringing much-needed relief to motorists and pedestrians. The faulty signal had caused significant inconvenience, especially during peak hours, with vehicles rushing in from all directions and no proper system to regulate traffic.

Suresh Naik, a bank employee, said the junction is one of the busiest in Fatorda and the signal's failure had made commuting dangerous, particularly for students and office-goers.

#### Rape-accused doc released on Rs 75k bail

MARGAO: Dr Samuel Arawattigi, arrested for the alleged sexual assault of a nurse employed at his clinic, has been granted conditional bail by South Goa Additional District and Sessions Judge Pooja Kavlekar.

The court released him on bail of Rs 75,000 with one surety and directed him not to tamper with witnesses or contact the victim. The alleged assault occurred on April 22 at Arawattigi's Benaulim residence under the pretext of a house visit.

The nurse's mother filed the complaint on April 25. Cuncolim Police registered the case under Section 64 of the Bharatiya Nyaya Sanhita. A forensic team visited the site, and the charge sheet has been filed. PSI Kishor Velip is the investigating officer.

MARGAO: The recently announced eligibility criteria for the upcoming Goa State Film Festival – 2025 have drawn sharp criticism from within the state's film fraternity, with former Entertainment Society of Goa (ESG) Governing Body Member Vishal Pai Cacode calling the guidelines 'disgraceful' and

"We are expected to call these 'Goan' films? This is not the promotion of Goan cinema — it's calculated exclusion dressed up as inclusivity," Cacode said in a strongly worded statement.

These rules require irrelevant documentation, such as censor certificates and production timelines that date back over ten vears. "Shockingly, the government is planning to conduct the 10th, 11th, and 12th editions of the festival simultaneously in August 2025, yet the framework guiding this
