**Fresh erosion reported at Khandepar river amid ongoing sand extraction**

**PONDA:** A fresh incident of soil erosion has been reported along the flood-prone Khandepar river, with locals expressing serious concern over the expanding riverbank collapse allegedly caused by illegal sand extraction.

According to residents, a 12-metre stretch of the riverbank at Baga had earlier collapsed, and a similar erosion event has now occurred on the opposite side at Galyer, Dhadyar Khandepar.

Locals allege that the river continues to erode by two to three metres annually, particularly at sand extraction points where the river basin has widened significantly. "This happens due to illegal sand extraction using suction pumps. If this is not

stopped, it may lead to major flooding," a local warned.

The monsoon season regularly brings flooding to the area, often affecting nearby houses. Residents noted that they had previously filed complaints with the authorities, resulting in inspections and the seizure of illegally stacked sand. However, the problem persists.

Locals estimate that approximately 500 metres of riverbank, especially along a sharp bend in the river, remains highly vulnerable to erosion. This stretch is known for the presence of high-quality sand and has become a hotspot for illegal extraction. Residents fear that continued erosion in this belt could significantly increase the risk of floods due to the widening of the river basin.

**Mapusa traders to go ahead with market bandh on June 23**  
Demand revision of sanitation fees

**MAPUSA:** The Mapusa Merchants Association has announced that it will proceed with its planned market bandh on Monday, 23 June, after talks mediated by Deputy Speaker Joshua D'Souza on Friday failed to resolve their grievances.

The meeting, held with Director of Municipal Administration Brijesh Manerkar, Deputy Director Nadia Shekole, and Mapusa Municipal Council Chief Officer Chandrakant Shetkar, was convened at the request of the Merchants Association, which had submitted a representation demanding D'Souza's intervention.

Calling the levy of sanitation fees "unjust", Association president Jitendra Falari said they had given the Council time until 22 June to act. If no resolution is reached, traders will voluntarily shut their shops the next day. Falari clarified that essential services would remain unaffected by the protest.

The traders are demanding a revision in the sanitation fees and objecting to retrospective charges for the past five years.

In 2021, the State government had issued a circular directing all municipal councils to implement the Garbage Management Rules and Bylaws in their respective jurisdictions.

Following the meeting, D'Souza stated that the sanitation fee for the financial year 2024-2025 would be charged as it is not being opposed by traders. However, the component for the years 2021-2024 will remain optional until further clarification is received from the Directorate of Municipal Administration (DMA).

He assured the traders that sanitation charges would no longer be linked to the renewal of trade licences. Regarding the demand to remove retrospective taxes, he said the DMA would seek legal opinion.

He also announced that shops and kiosks that have been wrongly categorised for fee calculation will be reviewed by the municipal accounts officer on a case-by-case basis. Traders who believe they have been mis-categorised can approach the municipal council, and necessary corrections will be made following a review.

**Cabinet status to ex-CM: Adv suggests appointment of Amicus Curiae**

**PANJIM:** In another letter on Friday to the Registrar (Judicial) of High Court of Bombay at Goa, Adv Aires Rodrigues has suggested that the Court could decide on appointing an Amicus Curiae or to take suo motu cognisance in the matter related to conferring upon the lifetime status of the rank of a Cabinet Minister with all consequential benefits to former Chief Minister Pratapsingh Rane, for his lifetime contribution to the State as the matter involves an unprecedented point of law.

Adv Rodrigues has also stated that the Central government on March 3 this year has accorded him the status of Overseas Citizen of India (OCI) after a long protracted legal battle.

Adv Rodrigues had written a similar letter to the Registrar (Judicial) in June last year leaving it to the Court to adopt an appropriate course of action as he would not be available in the country but that he could mark his appearance through video conferencing.

Adv Rodrigues has now stated that the Court can decide what should be done with his public interest litigation (PIL) Writ petition including appointing an Amicus Curiae or taking suo motu cognisance of the far-reaching and unprecedented point of law raised in the PIL writ petition.

After he was declared as a Portuguese national in March 2023, Adv Rodrigues opined that it was not proper for him to litigate against the government since he had ceased to be an Indian national. Meanwhile, the State government has sought time to produce documents to determine whether once a Petitioner is declared as foreign national, could litigate against the Goa government.
