DELHI-PUNE AIR INDIA FLIGHT SUFFERS BIRD HIT, RETURN JOURNEY CANCELLED

PTI, MUMBAI: Air India Pune-bound flight from Delhi suffered a bird hit on Friday, forcing the airline to cancel its return journey. The aircraft landed safely and the bird hit was detected after it touched down in Pune, the airline said in a statement. It has been grounded and extensive checks are being carried out by the engineering team, Air India said. "Flight Al2470 scheduled to operate from Pune to Delhi on June 20 has been cancelled due to a bird-hit which was detected after the incoming flight landed safely in Pune," it said. The airline also said it is making all arrangements, including providing accommodation for the stranded passengers. Refunds on cancellation or complimentary rescheduling is also being offered to passengers who opt for it, the airline said, adding that alternative arrangements are being made to fly the passengers to Delhi.

Air India cancels 8 flights, 4 of them int'l services

PTI, MUMBAI: Air India has cancelled eight flights, including four international services, on Friday due to enhanced maintenance and operational reasons, the airline said.

Air India said its teams on the ground are making alternative arrangements for the passengers to fly to their respective destinations at the earliest.

It has also offered full refunds on cancellation to passengers, the airline said.

The international flights to be cancelled were AI906 from Dubai to Chennai, AI308 from Delhi to Melbourne, AI309 from Melbourne to Delhi, and AI2204 from Dubai to Hyderabad.

Air India said four domestic flights - AI874 from Pune to Delhi, AI456 from Ahmedabad to Delhi, AI-2872 from Hyderabad to Mumbai, and AI571 from Chennai to Mumbai have been cancelled.

Not necessary for woman to get husband's signature for applying passport: HC

PTI, CHENNAI: The Madras High Court has held that it is not necessary for a woman to get the permission of her husband and take his signature before applying for a passport before the authority.

Justice N Anand Venkatesh gave the ruling in a recent order while disposing of a petition filed by Revathy. She sought a direction to the authorities to issue a fresh passport without insisting signature from her husband in a time bound manner.

The case of the petitioner was that she got married in the year 2023 and that there was a matrimonial dispute between the parties which resulted in her husband filing a petition before a local court, seeking for the dissolution of the marriage. This peti-

tion was pending. The petitioner, applied for a passport in April this year before the Regional Passport Office (RPO) in the city. It was not processed and when enquired, the petitioner was informed that she must obtain the signature of her husband in Form-J and only thereafter, the application will be pro-

cessed by RPO. The RPO also took into


