

## Cyber fraudster held in Rs 2.6 cr scam

**PANJIM**: In a significant breakthrough, the Cyber Crime Police have apprehended a key accused in a high-value cyber fraud case involving over Rs 2.6 crore, executed through impersonation and psychological intimidation.

The case was registered on June 9 at the Cyber Crime Police Station, Panjim, following a written complaint from a woman residing at Aquem Road, Margao. The complainant reported that between May 20 and June 2, 2025, she received several phone calls and WhatsApp messages from individuals posing as senior officials of the Telecom Regulatory Authority of India (TRAI) and the Central Bureau of Inves-

tigation (CBI), Mumbai. Using mobile number +91 90xxx85182 and WhatsApp numbers +91 967xxx2769 and +91 814xxx0910, the accused falsely informed the victim that a police complaint had been filed against her name and Aadhaar number. They further escalated the pressure by sending a forged order allegedly issued by the Supreme Court of India, coercing her into transferring a total of Rs 2,60,33,634 into various bank accounts.

Investigations revealed that on May 22, 2025, two transactions totalling Rs 76,35,760

(Rs 55 lakh and Rs 21.35.760) were credited to a bank account held by one Rijas K, a

resident of Kozhikode, Kerala. A Cyber Crime Police team comprising PSI Navin Naik and constables Shantaram Narse and Yash Kole, under the supervision of PI Deepak Pednekar, ASP Akshat Ayush, IPS, and SP (Cyber Crime) Rahul Gupta, IPS, travelled to Kozhikode. With assistance from the local police, Rijas K (35) was apprehended and placed under arrest.

During custodial interrogation, Rijas was found to be a habitual cyber fraudster, allegedly involved in at least 11 cyber crime cases across India. The total estimated fraud attributed to him amounts to Rs 22,77,93,773.

The case has been registered under Sections 318(4), 319(2), and 336(3) read with Section 3(5) of the Bharatiya Nyaya Sanhita (BNS), and Section 66-D of the Information Technology Act.

Reaffirming its commitment to combating cybercrime. Goa Police urged citizens to remain alert and avoid falling prey to fraudulent calls or messages impersonating government authorities. Any suspicious communication should be reported immediately to the Cyber Crime Helpline at 1930 or the nearest police station.

## Govt plans 'no-concrete zones' around trees following NGT directive

PANJIM: The Goa Government is preparing to implement 'no-concrete zones' around roadside trees in line with a National Green Tribunal (NGT) directive issued on May 21, 2025. The initiative aims to prevent damage to tree roots and facilitate water percolation, thus enhancing tree health and longevity.

The Forest Department has been tasked with examining Delhi's model, which mandates a one-metre radius around trees be kept free of concrete and filled with natural soil instead.

"The Chief Secretary, who also serves as Chairman of the Tree Authority, is actively looking into the issue," a senior official told the media. "Most roadside trees in Goa are encased in concrete or interlocking pavers, which suffocate the roots and prevent water absorption. This leads to diseases, pest infestations,

and in some cases, trees being uprooted," the official added.

The issue gained urgencv after several trees along Miramar Road were found diseased and uprooted, with inspections revealing compromised root systems caused by surrounding concrete.

Even prior to the NGT directive, the Forest Department had begun preparing a state-specific proposal based on the Delhi guidelines. Other states such as Delhi and Karnataka

have already adopted the one-metre clearance rule. The State Government is also expected to direct local bodies and the Public Works Department (PWD) to begin de-concretisation efforts around roadside and highway trees. Environmentalists have welcomed the initiative, citing it as a crucial step in mitigating urban tree stress and promoting eco-

logical sustainability.

### Vasco police register rape case against Curchorem man

VASCO: The Vasco Police have registered a case against Sarvar Khan, a resident of Curchorem, for allegedly raping and assaulting a woman at a resort in Bogmalo.

The case was initiated based on a Zero FIR received from the Curchorem Police, following a complaint lodged by the woman. She alleged that on June 9, 2025, the accused raped her at the resort and subsequently physically assaulted her by hitting her on the face. A case has been registered under Sections 64 and 115(2) of the Bharatiya Nyaya Sanhita, 2023.
