Talaulim youth booked for rape under pretext of marriage

PONDA: Ponda Police have registered an offence against a 22-year-old man from Talaulim for allegedly raping a 21-year-old woman from Borim under the false promise of marriage. The accused, identified as Rameshwar is alleged to have engaged in sexual relations with the complainant on multiple occasions between 2023 and May 2025 in Borim, Ponda. The case has been registered under Sections 376 and 420 of the Indian Penal Code. Police are in the process of submitting the FIR to the Judicial Magistrate First Class (JMFC), Ponda, and forwarding copies to concerned senior officials. Further investigation is underway.

Nigerian woman booked for illegal stay in Goa

ANJUNA: Anjuna Police have registered a case against Uche Joy Okafor, a 40-year-old Nigerian national residing in Morjim, for allegedly staying in Goa without valid travel documents. Police said Okafor has been served a notice under Section 35(3) of the Bharatiya Nagarik Suraksha Sanhita, 2023, and directed to produce valid documentation supporting her stay in India. Further investigation is ongoing.

Scooter rider injured in collision with car at Khareband junction

MARGAO: Minguelinha Oliveira, a resident of Sernabhati, Colva, sustained injuries after his scooter was struck by a car at the Three Road Junction in Khareband. According to Margao Town Police, the incident occurred when 39-year-old Merlyn Fernandes of Benaulim, driving a car, allegedly operated the vehicle in a rash and negligent manner, endangering human life. Upon reaching the junction, she collided with Oliveira's oncoming scooter, causing him to fall onto the tar road. Following a complaint filed by ASI Santosh Gaonkar, an offence has been registered under Sections 281 and 125 of the Bharatiya Nyaya Sanhita (BNS), 2023.

Pedestrian seriously injured in scooter accident near Shah Darbar Hotel

MARGAO: A pedestrian sustained grievous injuries after being struck by a speeding scooter near Shah Darbar Hotel on June 19. ASI Rosario Dias of Margao Town Police Station filed a complaint stating that the rider of a scooter, while travelling from Margao towards Brandel Hall, rode in a rash and negligent manner, hitting 57-year-old pedestrian Ramesh Naik, a native of Karwar residing in Margao. An offence has been registered under Sections 281 and 125(b) of BNS 2023.

Illegal land filling detected during site inspection in Sanguem

SANGUEM: Vrinda Phal Dessai, a Planning Department official from Quepem, has lodged a complaint with Sanguem police regarding illegal land filling at Cortali village. The offence was reportedly committed prior to April 4 by Joaquim Dias and Santo Antonio Cruz, both residents of Dando, Sanguem. During a site inspection, it was found that the duo carried out land filling activities without obtaining permission from the concerned authority. An offence under Section 17-A of the Town and Country Planning Act has been registered.

ASI Umesh Gaude of Margao Town Police Station filed a complaint stating that Yolan Aaron Fernandes of Chinchinim, riding as scooter from Navelim towards Chinchinim, rode in a rash and negligent manner. Illegal sand dune breach in Varca sparks restoration drive

Residents demand accountability as seawater enters paddy fields following suspected CRZ violation; panchayat assures action in line with coastal regulations

MARGAO: Restoration efforts have begun at the site of a sand dune breach in Pedda, Varca, with officials from the Village Panchayat, the Goa Coastal Zone Management Authority (GCZMA), Coastal Regulation Zone (CRZ) unit, and the Water Resources Department (WRD) conducting a follow-up inspection on Monday. The action comes two days after

an initial site visit by government officials and panchayat members, following complaints that a portion of the dune was illegally breached, allegedly to drain water from the nearby Handi into the sea. The panchayat had lodged a written complaint with the Tour-

ism Department, police, and GCZ-MA, flagging the matter as a violation of coastal regulations.

Deputy Collector Mohd Shabir, Mamlatdar Vimod Dalal, Talathi officials, tourism department's Frank Rodrigues, and Varca Sarpanch Flavia Barretto were among those who inspected the area over the weekend. Residents had raised concerns that the damage had allowed sea water to enter nearby low-lying paddy fields. At Monday's inspection, Deputy

Sarpanch Solon Furtado called for urgent restoration and suggested that geo-bags be placed on the seaward side of the dune to reduce further erosion. "Filling the breach and reinforcing the dune is necessary to stop sea water ingress," he said.

In a separate media briefing, Benaulim MLA Venzy Viegas, responding to the incident, said those responsible should be identified and held accountable, and that the sand dune should be environmentally restored. He also said the state lacks an effective mechanism to monitor and protect sand dunes, and called for a stronger institutional framework.

The Varca panchayat has said it will follow up the matter with the concerned departments and take appropriate action.

MARGAO: A 51-vear-old resident of Bamonsai, Bakar Shaikh, was cheated of Rs 3.32 lakh by fraudsters who promised him a job in Canada through a fake social media advertisement. According to the complaint lodged with Sanguem police, the incident occurred on November 12, 2024.

The accused contacted the complainant via Facebook, sent a fraudulent link, and later asked him to share his CV via WhatsApp. Believing the offer to be genuine, the complainant paid the amount in multiple instalments before realising it was a scam.

Decomposed body of mason found in locked room at Sanguem

MARGAO: Suresh Hirappa Khadakar, a mason and caretaker residing at Saudimol. Sanguem, was found dead in a highly decomposed state inside his locked rented room. Police said there were no visible injuries on the body, which has been sent for post-mortem to determine the exact cause of death. Upon receiving information, Sanguem Police visited the scene and found the door latched from inside. On peering through the window, a body was seen lying prone on the floor. Fire and Emergency Services assisted in breaking open the door. The deceased, originally from Siddhapur, Karnataka, had been staying at Saudimol alone for the past year. Room owner Melba Fernandes confirmed his identity. A scene of Unnatural Death Panchanama was conducted, and the body has been preserved at the District Hospital, Margao, for medico-legal formalities

Three held in separate ganja seizures in Bicholim and Calangute

BICHOLIM/CALANGUTE: In two separate operations, police arrested three individuals for possessing ganja in Bicholim and Calangute, seizing contraband worth a total of Rs 60,000 In Bicholim, two youths were arrested during a narcotic raid conducted near Moments Hall, under the bypass. The duo – identified as Rohit Parwar and Sandeep Kandolkar, both aged 24 and residents of Bicholim – were allegedly preparing to deliver the substance to potential customers when they were caught red-handed. Police seized suspected ganja worth Rs 5,000 from them. The accused were produced before the Judicial Magistrate First Class (JMFC), Bicholim, and remanded to 14 days' judicial custody.

Meanwhile, in Calangute, police arrested Vinay K, 33, a resident of New Arradi Waddo, Candolim, after seizing 555 grams of suspected ganja worth Rs 55,000 from his possession. Acting on a tip-off, Calangute police conducted a raid near Hotel Palmarinha between 1.40 pm and 4.45 pm on Friday. The ganja, concealed in a black polythene bag, was recovered from the accused, who was later booked under the NDPS Act, Section 20(b)(ii)(A).

PWD put on notice over removal of speed breakers

PANJIM: The Goa Human Rights Commission (GHRC) has issued a notice to the PWD principal chief engineer asking him to file a reply and to remain represent for the hearing on Tuesday, June 24, regarding a complaint over removal of speed breakers on highway.

Last month, the Dharbandora village panchayat had written a letter to the GHRC strongly objecting to its decision recommending removal of speed-breakers from the road in its jurisdiction.

Approximately 15 years ago, following a series of serious accidents and repeated appeals from the villagers, the concerned authorities had installed these speed breakers. The presence of speed-breakers ensured these

the safety a critical role in pedestrians, residents and commuters. Dharbandora sarpanch Vinayak 'Balaji' Gawas had stated in the letter.

The decision to remove them now, without any consultation with the local residents is deeply concerning and poses a serious threat to public safety. The traffic on this road has only increased over the years and speeding vehicles remain a constant hazard. Removing the speed breakers will undoubtedly increase the risk of accidents and put lives at risk, he stated in the letter addressed to the Commission.

The panchayat has now reauested the Commission to reconsider the decision and to instruct the concerned department to remain the existing speed breakers. Public safety must remain a top priority, it said.

Areal resident decries delay in hearing petition, issuing order

PANJIM: Expressing his resentment over the delay in hearing disqualification petition filed against the panchayat member and subsequent delay in giving certified copy of the order, Menino Santana Fernandes of Sao Jose de Areal has demanded action against the Director of Panchayats.

"Director of Panchayat Siddhi Halarnakar has no moral ground to continue in the office and conduct court proceedings but must resign immediately," Fernandes said.

According to Fernandes, he had filed disqualification petition in December 2022 against the then Sao Jose De Areal Sarpanch and current panchayat member Joyce Veyona Dias un-

5 of the Goa Panchayat Raj Act, for persistent remiss and misuse of powers.

The Director of Panchayats dismissed his disqualification petition on April 1, 2025. Fernandes said that the Director took almost two and half years, when the matter could have been decided within three to four months as there were several High Court orders in such matters to dispose them with

utmost dispatch. During the hearing of the petition, Dias was ousted as the sarpanch on January 20, 2023 by a no-confidence motion. As a result Fernandes amended his petition adding one more section 210-A of Goa Panchayat Raj Act.

After the Director pronounced the order, Fernandes applied for certified copy of the judgement and order and the Roznama entries on April 1, 2025 itself. As he was

der Section 50, sub-section 4 & not furnished the copy of the judgement, Fernandes sent five reminders to the Director of Panchayats.

"I sent five written reminders besides follow-ups in person and over the telephone. The answer I got from the office was that the order was not ready and the file is with Director of Panchayats and not in the office," he said.

When contacted, Director of Panchayats Sidhi Halarnakar said that the certified copy could not be issued to him as she was pre-occupied. "I was holding additional charge of other departments. I will inform my office to give him the certified copy immediately."

Halarnakar said that the aggrieved person has time to appeal against the order within 30 days from the date of the receipt of the copy of the order.

The copy of the order was finally issued to Fernandes on Iune 17.
