# YouTuber Jyoti Malhotra's judicial custody extended by two weeks

PTI, HISAR: A court here on Monday extended the judicial custody by 14 days of social media influencer **Jyoti Malhotra** arrested last month on the suspicion of espionage.

## ESPIONAGE CASE

The Hisar Police arrested Malhotra, who ran a YouTube channel 'Travel with JO', on the suspicion of espionage on May 16. Hailing from Hisar, the Youtuber was arrested at the New Aggarsain Extension and booked under provisions



of the Official Secrets Act and the Bharatiya Nyaya Sanhita (BNS). Malhotra's lawyer Kumar Mukesh said, "Her judicial remand has been further extended by 14 days and the

next date of hearing has been fixed by the court on July 7."

The 33-year-old Youtuber appeared before the court through video-conferencing, he said.

Earlier on June 9, another court here had rejected her regular bail plea.

Police had opposed the bail and argued that the investigation in this case was still going on.

After her arrest on May 16, Malhotra was remanded to five days of police custody by the court.

Following the completion of the remand, the court extended the custody by four more days after the

police sought to question her further.

On May 26, the court remanded her to judicial custody for 14 days, which was further extended later.

The Hisar Police previously said no evidence had emerged to indicate Malhotra had access to any military or defence-related information but claimed she was in contact with some people, aware that they were Pakistani intelligence operatives.

Police sources had previously said she was in touch with Ehsan-ur-Rahim alias Danish, a staffer at the Pakistani High Commission, since November 2023.

# Four PREPAK militants arrested in Manipur

PTI, IMPHAL: Four militants belonging to the proscribed outfit PREPAK (PRO) were arrested in Manipur's Imphal East district and a cache of arms and ammunition was seized from their possession, police said on Monday.

The arrested militants were identified as Thingbaijam Philip Singh, Lourembam Kumar Meitei, Laishram Haridas and Yumnam Akash Singh. They were arrested from different places in the district on Sunday, a police statement said.

Based on inputs provided by the arrested militants, a search operation was launched in the foothills of Kalika in the district and a

cache of arms and ammunition was seized, it said.

# CPI(M) leader Achuthanandan hospitalised after cardiac attack

PTI, THIRUVANANTHAPURAM: Former Kerala Chief Minister and veteran Communist Party of India (Marxist) leader V S Achuthanandan has been admitted to a private hospital here following a cardiac attack, hospital sources said here on Monday.

The 101-year-old leader is reported to be in stable condition and is under observation, they said.

CPI(M) state secretary M V Govindan, who visited Achuthanandan at the hospital, told reporters that a team of cardiologists is monitoring his health.

# SC deplores parties offering to deposit bail amount, later calling 'onerous'

PTI, NEW DELHI: The Supreme Court on Monday deplored the practice where parties voluntarily offer to deposit substantial amounts of money for bail but later seek relaxation of "onerous" conditions imposed higher courts.

A bench of Justices K V Viswanathan and N Kotiswar Singh said while the apex court was conscious of the rights of an individual under Article 21 of the Constitution, it had to be equally conscious of the "sanctity of the judicial process".

"There cannot be any dispute that excessive bail is no bail and onerous conditions ought not to be imposed while bail is granted," the bench said.

The top court, however, noted a onerous condition would depend on the facts and circumstances of individual cases.

The observations came when the bench was dealing with a plea stemming from a Madras High Court order.

The bench noted the petitioner was booked

# DGCA starts audit at Air India's main base in Gurugram

PTI, MUMBAI: Aviation regulator DGCA on Monday commenced the detailed audit at Air India's main base in Gurugram that will cover operations, flight scheduling, rostering and various other areas, according to a source.

The Tata Group-owned airline has come under intense scrutiny after its London-bound Boeing 787-8 Dreamliner plane crashed soon after take-off in Ahmedabad on June 12, killing 270 people, including 241 people onboard.

An eight-member team from the Directorate General of Civil Aviation (DGCA) has started the annual audit of Air India's main base. Generally, a three-member team carries out the yearly

audit, the source said. "DGCA has started the audit at Air India's main base at Gurugram. The annual exercise will cover all aspects, including operations, flight planning, scheduling, rostering and IOCC (Integrated Operations Control Centre)," the source said. Air India is headquartered in Gurugram, Haryana. The audit exercise also comes at a time when the regulator has taken action against some Air India officials for repeated safety lapses.

On June 21, DGCA sought details on the airline's planned and unplanned inspections, audit, cockpit/en route, station facility, ramp and cabin inspection, among others, from its

flight operations inspectors since 2024.

The communication was sent out a day after the regulator issued a show-cause notice to the airline for Flight Duty Time Limitation (FDTL) violation and also ordered the

removal of the airline's three senior officials from their respective roles for certain lapses.

These special audits will be over and above the regulatory audits carried out as per the Annual Surveillance Programme.

# Pahalgam terror attack: NIA gets 5-day remand of two accused

PTI, JAMMU: A local court on Monday granted the National Investigation Agency (NIA) five-day remand of two accused who were arrested for harbouring the Pakistani terrorists behind the deadly Pahalgam terror attack in April, officials said here.

The two men - Parvaiz Ahmad Jothar from Batkote, Pahalgam, and Bashir Ahmad Jothar of Hill Park, Pahalgam - were arrested by NIA on Sunday in the first major breakthrough in the investigations into the attack that left 26 persons, mostly tourists, dead and 16 others injured on April 22.

According to the NIA, the arrested accused have disclosed the identities of the three armed terrorists involved in the attack, and have also confirmed that they were Pakistani nationals affiliated to the banned terrorist outfit Lashkar-e-Taiba (LeT).

The two accused were produced in the court of Additional District and Sessions Judge, Jammu, Ritesh Kumar Dubey, and were sent to NIA custody for five days till June 27, a court official said.

Parvaiz and Bashir had knowingly harboured the three armed terrorists at a seasonal dhok (hut) at Hill Park before the attack, according to NIA investigations.

The two men had provided food, shelter and logistical support to the terrorists, who had, on the fateful afternoon, selectively killed the tourists on the basis of their religious identity, making it one of the most gruesome terrorist attacks ever, the agency said.
