# **SCRAPPED ODPs HELPED CONVERT 17 LAKH SQM**

High Court took note of findings indicting Michael Lobo, Francis Silveira; roads were widened to facilitate unauthorised land conversion

PANJIM: The Town and Country Planning (TCP) Department issued 141 technical clearances and 745 zoning certificates, resulting in the conversion of a total of 16,94,115 square metres of land from the Regional Plan 2021 to the final Outline Development Plan (ODP), based on a circular dated December 22, 2022, and an Ordinance promulgated in February last year.



On Monday, the High Court of Bombay at Goa quashed and set aside the circular dated December 15, 2022, and the

North Goa Planning and Development Authority (NGPDA).

The ODPs for these villages were earlier suspended on April 27, 2022, due to widespread irregularities in their preparation and finalisation. A high-level review committee was constituted to examine these alleged illegalities.

The High Court noted that the committee had indicted Michael Lobo and former Minister Francis Silveira, both of whom served as chairmen of the NGPDA. Lobo held the post between 2012 and 2019 and also during the time the ODP was prepared.

According to the committee, 8,04,224 sq m of land was changed from the Regional Plan to the draft ODP 2025, while 8,89,891 sq m was altered in the transition from draft to final ODP, making a total of 16,94,115 sqm. The report highlighted that Lobo

had taken a keen interest in the ODP and had facilitated changes in zoning based on personal discretion. It also found that road widths were significantly reduced without justification — from six to three metres, 15 to 10 metres, and 25 to 15 metres — primarily to legitimise existing unau-

thorised development.

## DGCA finds multiple safety lapses at airports, aircraft

PTI, NEW DELHI: Aviation watchdog DGCA has detected multiple violations related to airlines, airports, aircraft maintenance works, and repeated defects in multiple cases during its surveillance at major airports, an exercise carried out in less than two weeks after the Air India plane crash.

Without disclosing names of the airlines, airports and other entities in relation to the defects, the regulator on Tuesday said surveillance covered multiple critical areas such as flight operations, airworthiness, ramp safety, Air Traffic Control (ATC). Communication, Navigation and Surveillance (CNS) systems, and pre-flight medical evaluations.

The surveillance was done last week and DGCA is stepping up efforts to strength the overall safety oversight of the aviation ecosystem.

From a faded centre line marking of a runway at an airport to non-updation of obstruction limitation data for three years to a scheduled carrier's domestic flight

being held up due to worn tyres, the watchdog came across multiple defects in the aviation ecosystem.

### **DGCA FINDINGS**

Multiple violations

across airlines, airports and aircraft maintenance operations detected Surveillance covered flight operations, airworthiness, ramp safety, ATC, CNS systems and pre-flight medical evaluations Repeated appearance of certain defects indicated ineffective

Noting that the comprehensive surveillance will continue in future to detect hazards in the aviation ecosystem, the Directorate General of Civil Aviation (DGCA) said the findings have been communicated to the entities concerned for taking corrective actions within seven days.

#### PASSENGERS, **CREW FALL ILL ON LONDON-MUMBAI AIR INDIA FLIGHT**

**AGENCY, MUMBAI: A** suspected case of food poisoning disrupted Air India's flight Al130 from London's Heathrow to Mumbai on Monday, with at least five passengers and two crew members falling ill during the journey, according to reports. In a statement confirming the incident, Air India said, "On board flight AI-130 from London Heathrow to Mumbai, five passengers and two crew members reported feeling dizzy and nauseous during different phases of the flight. The flight landed safely in Mumbai where our medical teams were ready to provide immediate medical assistance."

### No immunity for participants in **Op Sindoor: SC**

PTI, NEW DELHI: Participating in Operation Sindoor doesn't give you immunity from committing atrocity at home, the Supreme Court on Tuesday said while refusing to exempt a convict from surrendering in a dowry death case of his wife.

A bench of Justices Ujjal Bhuyan and K Vinod Chandran made the observation while hearing an appeal filed against an order of the Punjab and Haryana High Court which dismissed the man's appeal and upheld his sentence.

The top court initially expressed disinclination to grant exemption to

Senior advocate Vikram Chaudhary, appearing for the petitioner, submitted that the man was a participant of Operation Sindoor.

'For the past 20 years I am a black cat commando posted in Rashtriya Rifles," he said.

The bench then remarked, "That doesn't give vou immunity from committing atrocity at home. This goes to show how physically fit you are, and the manner in which alone you could have killed your wife, strangulated your wife."

# Water pollution threatens the festive spirit of São João

**MARGAO:** The joyful plunge into village wells and other water bodies that marks Goa's São João festivities is facing a serious challenge - rising water pollution. A vibrant tradition tied to the Feast of St John the Baptist on June 24, the custom of leaping into natural water sources is now being overshadowed by growing environmental concerns.

In villages such as Benaulim, Raia and Nuvem, residents are increasingly steering clear of wells and ponds that have served as the centerpiece of the celebration for generations. The reason: deteriorating water quality.

Traditionally, young men don floral headgear called kopels and sing folk songs before diving into village wells, symbolising the biblical baptism of Jesus by John the Baptist in the River Jordan. Today, however, this symbolic act is often replaced with makeshift alternatives - plastic tanks, inflatable pools, and even artificial rain showers.

For Jeron Colaco of Raia, the change is deeply disheartening. "Our village well used to be the heart of São João," he said. "Now it's covered for most of the year and barely maintained. People are worried about infections and contamination."

Israel-Iran ceasefire

# deal initially faltered

AP, DUBAI: US President Donald Trump said a ceasefire between Iran and Israel was in effect Tuesday after the deal initially faltered, and the American leader expressed deep frustration with both sides.

Israel had earlier accused Iran of launching missiles into its airspace after the truce was supposed to take effect, and the Israeli finance minister vowed that "Tehran will tremble."

The Iranian military denied firing on Israel, state media reported, but explosions boomed and sirens sounded across northern Israel in the morning, and an Israeli military official said two Iranian missiles were intercepted.

Trump told reporters at the White House before departing for a NATO summit that, in his view, both sides had violated the nascent
