Suspend operation of Air India Boeing fleet pending safety audit: Plea in SC

PTI, NEW DELHI: A plea in the Supreme Court has sought suspending Air India Boeing aircraft operations pending a safety audit within two weeks in wake of the recent Ahmedabad air tragedy that claimed lives of 241 passengers and crew on board.

The London-bound Air India flight, Boeing Dreamliner 787-8, with 242 passengers and crew on board, crashed moments after taking off from the Sardar Vallabhbhai Patel International Airport in Ahmedabad on the afternoon of June 12.

The plea sought directions to the authorities, particularly the DGCA, to conduct unannounced audits of entire fleet of Air India and other air carriers operating in India, with public disclosure of findings and imposition of immediate corrective measures or penalties for non-compliance.

BLACK BOX OF CRASHED AI PLANE IS IN INDIA, BEING EXAMINED BY AAIB: MINISTER

PTL. PUNE: Civil Aviation Minister K Rammohan Naidu on Tuesday said the black box of the Air India plane which crashed in Ahmedabad earlier this month was being examined by the Aircraft Accident Investigation Bureau, and dismissed speculation that it would be sent abroad for an inquiry. The London-bound Air India flight crashed into a hostel complex in Ahmedabad moments after taking off from the Sardar Vallabhbhai Patel International Airport there on June 12 afternoon, killing 270 persons, including 241 on board. One passenger survived. The black box of Air India's Boeing 787-8 Dreamliner plane was recovered from the site on June 13. A black box is a small device that records information about an aircraft during its flight. It helps in the investigation of aviation accidents. Asked about some media reports suggesting the black box would be sent abroad for a probe into the incident, Naidu said, "...it is all speculation. The black box is very much in India and it it currently being investigated by the Aircraft Accident Investigation Bureau (AAIB)." To a guery on when is the black box data expected to be retrieved, the minister said it is a very technical matter. "Let the AAIB conduct the probe and go through the entire process," he added.Naidu was speaking here on the sidelines of the Helicopters & Small Aircraft Summit 2025, organised by FICCI jointly with the Ministry of Civil Aviation.

PTI , NEW DELHI: Flagging alleged irregularities in the Maharashtra assembly polls, Congress leader Rahul Gandhi on Tuesday claimed that there weren't isolated glitches but "vote theft" and demanded the immediate release of machine-readable digital voter rolls as well as CCTV footage.

The Leader of Opposition in the Lok Sabha shared on X a media report which claimed that in just six months between the 2024 Lok Sabha elections and the Maharashtra assembly polls, Nagpur South West – the seat held by BJP leader and Chief Minister Devendra Fadnavis - added 29,219 new voters.

"In Maharashtra CM's own constituency, the voter list grew by 8% in just 5 months. Some booths saw a 20-50% surge. BLOs reported unknown individuals casting votes," Gandhi said in his post.

India evacuates more Indians from Iran, Israel

PTI . NEW DELHI: India on Tuesday evacuated 292 citizens from Iran and 366 nationals from Israel amid escalating tensions between the two countries following the US bombing of three Iranian nuclear sites.

With the fresh batch of evacuees from Iran, India has brought back 2,295 Indians from the Persian Gulf nation so far.

India brought back 161 Indians in a chartered flight from Amman that landed at 8:20 am. The Indians were moved from Israel to Jordan through land border crossings.

Another group of 165 Indians were flown back to New Delhi from Amman in a C-17 military transport aircraft. They were received at the airport by Union Minister L Murugan.

Two-hundred-ninety-two Indian nationals were evacuated from Iran on a special flight that arrived in New Delhi from Mashhad at 3:30 am. External Affairs Ministry spokesperson Randhir Jaiswal said.

Omar Abdullah says ready to recommend dissolution of J-K Assembly if statehood is restored

PTI , SRINAGAR: Chief from here. Minister Omar Abdullah on Tuesday said he has no objections if the Legislative Assembly has to be dissolved and fresh elections are to be conducted after statehood is restored to Jammu and Kashmir.

"I have read in a newspaper that statehood will be restored but assembly elections would have to be held afresh. Let them do it, who has stopped them," Abdullah told reporters at Gulmarg, 52 kilometres

Abdullah, who was sworn in as the first chief minister of the Union Territory of Jammu and Kashmir in October last year, said that statehood is the right of the people of Jammu and Kashmir.

"I know where the story has come from. I know who planted the story in a newspaper here.... it was planted only to scare the MLAs. This statehood is not for any MLA or the government. This statehood is for

the people of Jammu and Kashmir and we MLAs will not be an obstacle in it.

"If the MLAs are being threatened with the dissolution of the Assembly for the restoration of statehood, then do it. The day the state is established again, the next day we will go to the governor and recommend the dissolution of the Assembly. Don't try to scare us ... statehood is our right and give it (back) to us. Stop planting stories in newspapers, it won't work," he added.

Ahmedabad plane crash: Shifting of wreckage underway

PTI, AHMEDABAD: The process of shifting the wreckage of the Air India plane, that crashed on June 12 on a medical college hostel in Ahmedabad, to the airport premises here was still on for the third day, officials said on Tuesday.

The Gujarat police on Sunday started moving the wreckage on trucks from the crash site in Meghaninagar to GUISAIL (Gujarat State Aviation Infrastructure Company Limited) building, which is in the airport premises. The ill-fated plane's tail fin, which got stuck on the medical college hostel premises, was shifted on a truck on Sunday

Emergency made part of school syllabus during UPA rule, 3 decades after imposition

PTI . NEW DELHI: It took three decades for the Emergency imposed by then-prime minister Indira Gandhi, a 21-month period marked by censorship and mass arrests of opposition leaders, to make an entry into NCERT political science textbooks.

Curiously, it happened under the Congress-led UPA rule in 2007.

While there are still complaints that school textbooks are yet to reflect the full excesses of the Emergency, several passages about the dark period got pruned as late as 2023 under the BJP as part of a curriculum rationalisation exercise following the COVID-19 pandemic.

According to Krishna

Kumar, former NCERT chairman, the Emergency was introduced in class 12 political science textbooks in 2007 after the revision of the National Curriculum Framework (NCF). He, however, did not

elaborate on the process of introducing the subject into the curriculum.

lished in 2007, 25 pages of a chapter, "the crisis of democratic order", detailed the nature of the crisis, the argument behind it, the supporters and the

opponents, and how the Emergency shaped the politics of the time. The Emergency and anti-Sikh riots were included in the textbooks

despite the Congress gov-

ernment being in power as academia was fully autonomous then, said Anita Rampal, who was the chairperson of some committees constituted

by the NCERT for the development of textbooks. "The textbook advisors had met then HRD Minister Arjun Singh to let him know what was being incorporated into textbooks and there was absolutely no government interference.

"NCERT or for that matter academics was fully autonomous then. The fact that Emergency or anti-Sikh riots could be included in the curriculum that too with cartoons critical of Indira Gandhi... it is unthinkable in today's

time," Rampal, also a former Dean of Delhi University's Faculty of Education, told PTI.

The chapter included excerpts from Indira Gandhi's speech to the nation on All Îndia Radio, critical cartoons by RK Laxman, details of the Shah Commission report on the excesses of the period, several newspaper clippings about the announcement of Emergency and subsequent defeat of the Congress in Lok Sabha polls, Amul's tongue-in-cheek take on forced sterilisation, clippings on power shutdown that stopped newspapers from printing and Telegram messages reflecting attempts to censor

the press.

India-US deal to produce F-414 jet engines to be sealed by March: HAL Chief Sunil

PTI , NEW DELHI: The Hindustan Aeronautics Ltd (HAL) will seal a deal with US defence major GE Aerospace by March to jointly produce a jet engine to power the next generation of India's combat aircraft, the aviation behemoth's chief DK Sunil has said.

The mega plan to jointly produce the F-414 engines in India was announced during Prime Minister Narendra Modi's visit to Washington DC in 2023, though the programme suffered from several slippages because of protracted negotiations on the sharing of advanced technologies.

National Institute of Virology develops portable 'point-of-care' test kit for detecting Nipah virus

PTI, NEW DELHI: India will now be able to detect the said. Nipah virus within minutes as the National Institute of

Virology (NIV) in Pune, under the Indian Council of Medical Research (ICMR), has developed a portable 'point-of-care' test kit for detecting the virus.

This kit can provide instant results even outside laboratory settings and will be deployed soon in highrisk areas like Kerala and West Bengal, Dr Naveen

Kumar, the director of NIV,

"We have developed a LAMP-based portable kit for quick and reliable detection of the Nipah virus. It provides results in just a few minutes without the need for a laboratory. The kit has also been patented," Dr Kumar said.

The Nipah virus primarily spreads through fruit bats and has caused several outbreaks in India. With a mortality rate

exceeding 50 per cent, it is one of the most lethal viral diseases.

In India, the capability to culture the Nipah virus exists only at NIV Pune, where genomic analysis, vaccine development, and drug testing are also carried out, said Dr Pragya Yadav, senior scientist at NIV.

The NIV is working with a pharma company and research partners to develop monoclonal antibodies to treat Nipah. Additionally, type M) is comparatively less infectious.

Over the past decade, most Nipah virus cases in India have been reported from Kerala and West Bengal, he said. The NIV has set up specialised labs and monitoring systems in these states to enable early detection and containment, Dr Kumar added.

From 1998 to 2018, more than 700 cases were reported across India, Malaysia, and Bangladesh.
