# **MP, MLA LOCKED IN WAR OF WORDS OVER GROUND DEVELOPMENT AT SADA**

Amonkar accuses Capt Viriato of trying to fool people with fake publicity; Parliamentarian accuses legislator of corruption

VASCO: A heated exchange erupted between Mormugao MLA Sankalp Amonkar and South Goa MP Capt Viriato Fernandes regarding the development of the Rose Circle ground at Sada, Mormugao.

The dispute began when Amonkar accused Capt Fernandes of misleading the public and engaging in a publicity stunt. Amonkar launched developmental works at the Rose Circle

ground on Tuesday, taking a dig at Capt. Fernandes, who had previously claimed to have secured a No Objection Certificate (NOC) to undertake the same project under the MPLAD scheme. Amonkar said, "I displayed the NOC on the very day I received the work

order. If he (MP) genuinely intended to develop the ground under MPLAD funds, why did he not begin the work earlier? What was he doing all this while? He is only trying to fool the

### Lucky escape for passengers in Yellapur bus accident

PANJIM: Several passengers escaped with minor injuries after a Goa-Bengaluru inter-State bus early Tuesday morning met with an accident near Yellapur and ended up dangerously hanging over the edge of a cliff. Those passengers who sustained minor injuries were shifted to a nearby medical facility. Eyewitnesses said the accident occurred on a sharp curve, and the situation could have turned fatal had the bus moved any further. The authorities rushed to the spot and began rescue operations. The authorities are yet to ascertain the cause of the accident, though preliminary reports suggest the driver may have lost control of the vehicle.

### Haryana native held for stealing two-wheeler, cash at Cortalim

VASCO: The Verna Police arrested a former employee on the charge of stealing a two-wheeler and cash from a fast food outlet at Cortalim. The police gave the name of the accused as Kapil Manish Kumar (26), a native of Sector 19, Panchkula, Haryana. He was arrested in Haryana and the stolen two-wheeler was recovered from him. The theft was reported in October last year and Sachin Bhimappa Padasalgi, a businessman from Zuarinagar, Sancoale had filed a police complaint in this regard. The accused was working as a cook in a fast food centre at Quelossim Additionally, the accused also stole cash of Rs 2,000 from the counter. The total value of stolen items was Rs 1,00,288. ## Salaulim dam overflows early Authorities urge caution near the spillway due to increased water discharge

**PANIIM:** The Salaulim Dam overflowed on Wednesday, marking the earliest such event in recent memory.

This year's overflow comes 12 days earlier than last year, when the dam began overflowing at 7.07 p.m. on July 7.

Known for its picturesque surroundings, the Salaulim Dam is a vital water source for South Goa, supplying both drinking and irrigation water. It is also a popular destination for tourists and locals alike. The dam features Asia's first duckbill spillway, which enables efficient water discharge during peri-

ods of heavy rainfall. In previous years, the dam overflowed on July 19 in 2023 and July 9 in 2022. across the State. This year's early overflow is attributed to the premature onset of the monsoon due to increased water in Goa. With rainfall condischarge. Speaking to re-

### **3** bank staffers booked for cheating Baina local of gold

VASCO: The Vasco Police registered a case against three persons including two employees of HDFC Bank, for allegedly cheating a Baina resident of gold ornaments valued at Rs 8.78 lakh under the pretext of offering a loan at a lower interest rate. Khwaja Hussain in his complaint has stated that the incident occurred on June 20, 2025, at Shantinagar, Vasco when the accused identified as Safhan Khan of Dabolim; Shazia Sayed, an employee of HDFC Bank and Sunil Chavan, manager of the same bank, with a common intention deceived Hussain. Police stated that Hussain had taken back his gold ornaments from Muthoot Finance by paying Rs 8,78,600, following which the accused allegedly convinced him to pledge the same ornaments with the HDFC Bank, promising a loan at a reduced rate of interest. The complainant handed over gold ornaments to Safhan Khan, believing it would be re-pledged. However, the accused failed to produce the ornaments at the Bank and allegedly misappropriated them for personal gain. The Vasco police have registered a case against the three under Bharatiya Nyaya Sanhita, 2023. PSI Mayur Sawant is conducting an investigation.

#### Fatorda resident files scooter theft complaint

MARGAO: Jayson D'Silva, a resident of Fatorda, filed a complaint with the Fatorda Police regarding the theft of his scooter. According to the Fatorda Police, D'Silva reported that on June 20, he had parked his scooter in an open parking area near his residence. An unknown individual then stole the scooter, resulting in an approximate loss of Rs 1,11,987. Fatorda Police visited the scene and conducted a panchanama. An offense under Section 303(2) of the BNS has been registered.

#### Karnataka native found dead at Sancorda

MARGAO: The body of Pandurang Mirashi, 24, a native of Karnataka, was found hanging in his room at Bolkanem, Sancorda. Upon receiving the information, the Collem Police visited the scene and found the body hanging from a wooden rafter on the back verandah of the house with a cotton rope. Following an inquiry, the police conducted the panchanama. The post mortem examination confirmed that the cause of death was due to "asphyxia as a result of hanging". The body has been handed over to the family. PSI Sadanand Dessai is investigating the case.

of Mardol has stepped up its efforts to preserve the unique and fragrant Zayo (jasmine flowers) that are on the verge of extinction in the region. A meeting was recently held at the Veling-Priol-Cuncoliem Panchayat office, where

over 70 Mollekars (traditional jasmine cultivators) gathered alongside officials from the Goa State Biodiversity Board to appeal for the protection of Jayache Molle (jasmine plantations) by declaring them a heritage site.

The initiative was spearheaded by Pratap Naik, President of Fulkar Samaj Mardol, who emphasised the historical and cultural importance of the plantations. According to him, the Mollekars have been cultivating jasmine in Mardol for over a hundred years,

making it a vital part of their livelihood and Goan floral heritage.

However, a dispute over land ownership has emerged as a major obstacle in officially recognising the plantations as a herit-

age site. Despite their longstanding association with the land, the Fulkar Samaj has faced difficulties in securing its legal status. In recent years, there have also been several suspicious fire incidents—allegedly caused by unknown individuals-that have dam-

aged large portions of the century-old jasmine plantations.

The Fulkar Samaj, deeply concerned about losing both a revered tradition and their source of income, has reiterated their plea to the State Biodiversity Board. "The Mardol Zayo is renowned across Goa for its exceptional fragrance and is highly sought after," said a member of the Fulkar Samai. "But now we are not just losing a flower, we are losing our identity and livelihood.

**PONDA:** Many residents of Bhoma, who have been steadfastly agitating against the current National Highway (NH) widening project and demanding a bypass at Bhoma, believe their unwavering efforts and prayers to local deities are yielding "miracles".

For the past three years, the community has vehemently opposed the NH expansion. They interpret recent political developments as divine intervention, particularly the removal of two ministers from the cabinet who had previously favoured the existing widening plan. Bhoma residents view the recent sacking of local MLA and Minister Govind Gaude, following the earlier removal of the PWD Minister Nilesh Cabral from the cabinet, as further evidence of these

"miracles".

Saniav Naik, a leader of the Bhoma residents, stated that these developments have strengthened their faith in their local deities, to whom they offered 'gharanes' (prayers) in opposition to the NH expansion. He emphasised that the community's top priority is to safeguard their culture and

temples, which they fear will

be affected by the widening. Naik added that the Bhomkars will continue their agitation, intensifying it if the government

PONDA: The much-anticipated trekking season to the world-renowned Dudhsagar Waterfall officially began yesterday, with Goa Tourism Development Corporation (GTDC) Chairman Dr Ganesh Gaonkar flagging off an eco-tourism initiative promoting sustainable and adventure tourism in the region. With the arrival of the

monsoon, trekkers have started venturing through the lush forest trails to witness the majestic Dudhsagar Waterfall in its full gushing glory. While jeeps ferry tourists to the base of the falls from October
