Rain onslaught triggers flood fears in Wayanad

PTI, WAYANAD: Heavy rains over the past 24 hours have raised fears of fresh flooding and landslides in Wayanad's Munda-kkai-Chooralmala region, just a year after deadly landslides claimed over 200 lives there.

A YEAR AFTER TRAGEDY

District officials reported on Wednesday that the Chooralmalariver is in strong spate, with muddy water flowing forcefully and breaching the banks near the Bailey bridge.

Soil stored along both riverbanks for renovation work has been washed away, causing water to spill onto the Attamala road and surrounding areas.

Local residents say they believe new landslides have occurred in the hills, particularly uphill near Panchirimattam inside forested areas. However, officials say there has been no confirmation so far.

"We have no confirmation of new landslides inside the forest, uphill Panchirimattam," the District Disaster Management Authority (DDMA) said.

"The loose debris from previous events is coming down with the rain. This will likely continue for some time until all eroded materials are washed off," it said.

Residents remain anxious, remembering the July 2024 disaster that flattened homes, injured dozens, and left hundreds without shelter.

District administration officials say the flash flooding is a result of widespread rain in the hills.

However, they maintain that there is no immediate danger and are monitoring the situation closely.

Further downstream, the Kabaniriver has also seen rising water levels at Mananthavady and Panamaram.

With the Banasura dam nearing full capacity, a red alert remains in place for nearby regions.

SC grants 3-month furlough to Sukhdev Yadav in Nitish Katara murder case

PTI, NEW DELHI: The Supreme Court on Wednesday granted three months furlough to Sukhdev Yadav alias Pehalwan in the 2002 NitishKatara murder case.

A bench of Justices Ujjal Bhuyan and K Vinod Chandran noted that Yadav has undergone 20 years of uninterrupted incarceration without remission.

The top court directed that Yadav be produced before the trial court within seven days and appropriate conditions be imposed on him by the trial court before grant of furlough.

Furlough is a temporary release from prison, not a suspension or remission of the entire sentence, and is typically granted to long-term inmates who have served a portion of their sentence.

Yadav's plea challenged a November 2024 order of the Delhi High Court, which dismissed his petition for

releasing him on furlough for three weeks.

On October 3, 2016, the Supreme Court awarded a 25-year jail term without the benefit of remission to Vikas Yadav and his cousin Vishal Yadav for their role in the sensational kidnapping and killing of Katara.

Co-convict Sukhdev Yadav was given a 20-year jail term in the case.

They were convicted and sentenced for kidnapping Katara from a marriage party on the intervening night of February 16 and 17, 2002 and then killing him for his alleged affair with Vikas' sister Bharti Yadav.

Bharti is the daughter of Uttar Pradesh politician D P Yadav.

The trial court observed Katara was murdered as Vishal and Vikas Yadav did not approve of his affair with Bharti as they were from different castes.

Bank loan fraud: ED raids in Delhi-NCR, Punjab

PTI, NEW DELHI: The Enforcement Directorate on Wednesday conducted fresh searches as part of a money laundering investigation against the former promoters of a Delhi registered insolvent company in an alleged Rs 989 crore worth bank loan fraud case, official sources said.

The case is against Delhi-based Shilpi Cables Technologies Ltd (SCTL) which designed and manufactured wires and cables for the automobile and telecom sector. Insolvency proceedings were initiated against the said company in 2017.

Nine premises in the national capital region (NCR) and one in Jalandhar (Punjab) were covered during the latest raids carried out under the Prevention

of Money Laundering Act (PMLA), the sources said.

The ED had carried out the first round of searches in this case in December, 2024.

The money laundering case stems from a 2021 CBI FIR that alleged that the promoters of the company and their associates cheated a consortium of banks led by the IDBI Bank to the tune of Rs 989 crore, the sources said.

"The CBI FIR alleged that the said entity took loans from banks for business purposes and diverted the bank funds for purposes not intended by the loans."

"Thereafter, the promoters defaulted on repayment of loans causing wrongful loss to the banks amounting to Rs 989 crore," the ED had said in a statement issued last year.

Ambani, Adani join hands for fuel biz

PTI, NEW DELHI: MukeshAmbani and GautamAdani have partnered to sell automotive fuels by leveraging each other's fuel retail networks - marking the second business collaboration between the two billionaire industrialists.

Ambani's fuel venture with UK's BP, Jio-bp, will set up petrol and diesel dispensers at CNG retail outlets of Adani Total Gas Ltd (ATGL). Alongside, ATGL - the equal city gas joint venture of Adani Group and TotalEnergies of France - will put up CNG dispensing units at

Jio-bp's fuel pumps, according to a joint statement on Wednesday.

The partnership will cover both group's existing as well as future outlets.

Jio-bp owns 1,972 petrol pumps across the country while ATGL operates a network of 650 CNG stations in 34 geographical areas.

This is the second time in recent months that the rival billionaires have come together. In March last year, the two had signed the pact for their first-ever collaboration for a power project in Madhya Pradesh.
