India face Bumrah question ahead of 2nd Test

PTI. NEW DELHI: Will Jasprit Bumrah play in the second Test at Edgbaston? That is the biggest question facing the Indian team management as it looks to draw parity against England after losing the series opener from a commanding position at Leeds.

In his media interaction post the five-wicket loss on day five, Head Coach Gautam Gambhir made it clear that there will be no change in the workload of injury-prone pace spearhead Bumrah, who is slated to play three out of five Tests in the English summer. With the first Test ending on June 24 and the next beginning on July 2, there is enough time for Bumrah to recover but only he knows best about his body. Bumrah, the only bowler who consist-

ently posed a challenge for the English batters, took a five-wicket haul in the first innings and delivered an overall 44.4 overs in the match.

A pace attack without Bumrah makes the opposition's task significantly easier and increases the Indian team's headache, over deciding which of the two remaining Tests its trump card could be a part of.

The management, thus, would have had a much easier decision to make had Shubman Gill and Co gone to Birmingham 1-0 up.

"That is a tough call indeed for the team management. He should ideally play when the series is alive but the management knows best on how to manage his workload," former India chief selector MSK Prasad told PTI.

A BCCI source added: "Bumrah has close to a week's gap between first and second Test. So the decision rests with chief selector Ajit Agarkar, Gautam Gambhir and Shubman Gill. They might assess him a day before the Test, and take a final call."

There is only a three-day gap between second and third Test, scheduled at Lord's from July 10-14, and therefore, Bumrah is certain to not feature in both the games.

"We won't change the plans," said Gambhir on Tuesday when asked whether the team management will push Bumrah to play four Tests.

Nissanka ton puts Sri Lanka on top

AFP, COLOMBO: In-form opener Pathum Nissanka scored an unbeaten 146 as Sri Lanka tightened their grip on the second Test against Bangladesh on day two in Colombo on Thursday. The hosts were 290-2 at stumps, a lead of 43 on the back of Nissanka's sparkling innings off 238 balls.

It follows his career-best score of 187 in the first Test in Galle, which ended in a draw.

Nissanka found an able partner in former skipper Dinesh Chandimal, who scored a fluent 93 before a lapse in judgement saw him lose his wicket minutes before stumps. The two put on 194 runs together.

Earlier, debutant Sonal Dinusha took 3-22 as Sri Lanka bowled out the visitors for 247.

Borussia Dortmund defeated Ulsan HD 1-0 to claim top spot in Group F and the Germans will face Sergio Ramos' Monterrey, who thrashed Urawa Red Diamonds 4-0. powerhouses Argentine River Plate were eliminated after their defeat by Inter, who will take on more South American opposition on Monday in Charlotte, in the shape of Fluminense.

The Brazilian side could only draw 0-0 against South Africa's Mamelodi Sundowns but it was enough to claim second place behind Dortmund.

Champions League runners-up Inter faced a battle in Seattle against an aggressive River Plate side who had Lucas Martinez and Gonzalo Montiel sent off in front of 45,000 fans at Lu-


