Five drivers booked for pilferage

THANE: The Navi Mumbai Police registered a case against five drivers of a truck for allegedly stealing goods valued at Rs 16 lakh from consignments destined for JNPT for export, an official said on Saturday. The accused persons allegedly pilfered consignments of red chilli and rice by switching off the GPS in the truck between November 2024 and January 2025, an official said, adding that an FIR was registered on June 23 under various sections of the Bharatiya Nyay Sanhita (BNS). Police are conducting an investigation and nobody has been arrested yet.

Heroin worth over Rs 5 crore seized in Assam's Cachar

GUWAHATI: A suspected peddler has been arrested and heroin worth over Rs 5 crore seized from him in Assam's Cachar district, Chief Minister Himanta Biswa Sarma said. The arrest and recovery were made during an operation on Friday. "Acting on credible intelligence, @cacharpolice conducted a decisive anti-narcotics operation in Silchar," Sarma said in a post on X. He said that 1.109 kg of heroin worth Rs 5.55 crore was seized.

Woman arrested for killing six month old son in Bengal

KOLKATA: The police on Saturday arrested a 25-year-old woman in West Bengal's Nadia district on the charge of smothering her six-month-old son and dumping the body in a septic tank, an official said. The incident occurred in Kalyani police station area of the district. The woman raised an alarm on Friday evening that her son had gone missing, following which the family and neighbours started searching for the baby, the officer said. The police were informed and they also joined the search. The child's body was found in a nearby septic tank. During questioning, the police found inconsistencies in the statement of the woman who later admitted that she killed her son. The motive of the crime is not yet clear, the police said.

Delhi: Man kills father over front seat dispute in tempo

DELHI: A 26-year-old man allegedly shot dead his father in north Delhi's Timarpur area after being denied the front seat in a tempo that the family had hired to shift to their native place in Uttarakhand, police sources said on Friday. The accused, identified as Deepak, was arrested from the spot and the gun used in the crime along with 11 live cartridges was recovered, they said. The incident took place around 7.30 pm on Thursday near MS Block, Timarpur, where staff patrolling heard a gunshot and rushed to the spot.

Additional Superintendent of Police held for bribery in Rajasthan

JAIPUR: The Anti-Corruption Bureau (ACB) has caught an additional superintendent of police for alleged bribe money of Rs 9.35 lakh, an official statement issued here on Friday said. Jagaram Meena, the accused additional superintendent of police (ASP), was coming to Jaipur from Jhalawar in a car on Friday evening. The ACB team stopped the car at Shivdaspora toll post and found Rs 9.35 lakh during search. The ACB later searched the house of Meena in Kesar Nagar, Jagatpura. About Rs 30 lakh were found in the house.

Four die as car rams into truck in Rajasthan's Dausa

JAIPUR: Four persons, including three women, were killed when their car ramed into a truck in Dausa district of Rajasthan, police said on Saturday. Police said the truck stopped suddenly on a highway late on Friday night, and the Haryana-registered car, following closely, collided with it, a police official said. "All four persons died on the spot. The bodies have been shifted to the mortuary of the district hospital," the police said, adding the identity of the deceased was being ascertained. According to preliminary information, the car was coming from Rohtak, Haryana.

Man held for 'raping' woman friend

THANE: An optician from Bhiwandi in Thane district has been arrested for allegedly raping a 27-year-old woman friend, police said on Saturday. An official said the accused and the woman shared a romantic relationship. He allegedly raped her repeatedly between April and June after threatening to harm himself, the complainant stated in FIR. Further investigation is underway.

Govt urged to brief Opposition on Trump's 'opening up' India claims: Anand Sharma

PTI, NEW DELHI: Senior Congress leader Anand Sharma asked the government to clarify and take opposition leaders into confidence regarding US President Donald Trump's claim that a "very big" trade deal will be signed soon that will "open up" India.

Sharma, a former commerce minister, said an India-US trade deal should be mutually rewarding and not "suboptimal under pressure".

"President Trump's claim of sweeping Indian tariff concessions in the proposed trade deal and "opening up" India needs to be clarified by the government and leadership of opposition parties be taken in confidence," Sharma, the Congress' senior spokesperson, said in a post on X.

Sharma said India's national interests must be protected, and it must also continue to uphold and strengthen a rules-based multilateral trade regime and honour WTO

agreements.

"It is equally important that India engages the partner countries and major trading blocs and regions: EU, ASEAN, Africa Union, GCC and LAC to deepen market access and trade," he said.

Trump has said that America is going to have a "very big" trade deal with India, hinting at significant progress in the negotiation process of a long-awaited bilateral trade agreement between the two countries.

"We're having some great deals. We have one coming up, maybe with India, a very big one, where we're going to open up India," Trump said during an event at the White House promoting the passage of the GOP's tax and spending cuts legislation on Thursday.

Congress general secretary Jairam Ramesh earlier took a swipe at the government, saying it seems that India gets to know decisions of great importance to it from the

White House.

"He calls it a 'very big deal.' It better be - given that it led to the abrupt end of Operation Sindoor," Ramesh said on X.

"As is now becoming evident, India has to get to know decisions of great

importance to it from the White House in Wash-

ington DC," the Congress leader said.

Efforts on to form popular govt in Manipur: Ex CM Biren

PTI, IMPHAL: Former Manipur chief minister N Biren Singh on Saturday said efforts are underway for setting up of a popular government in the state which is now under President's rule.

Speaking at the sidelines of a programme at BJP state headquarters, Singh expressed hope that a new government will be formed in Manipur soon.

"We are working to form a government at the earliest. We are a national party. After looking into the ground situation, I have faith that a government will be formed soon. BJP and its allies want a popular government as well. We are working for restoration of popular govt," he said.

"We, BJP, haven't criticised anybody. We are

concentrating only on the present crisis. We are approaching the Central government and concerned persons to bring an amicable solution and peace in the state. In the meantime, we are also working to restore a popular government with frequent gatherings of MLAs. Everybody wants restoration of peace. Peace is compulsory. In the last seven or eight months, there have been no reports of fighting between communities," the former CM said.

Singh said the central government is trying to restore peace in the state.

To a media query, Singh said "I have said earlier that illegal immigrants and drug cartels have affected the entire North East as well as the whole nation..

Himachal flash floods: Death toll rises to seven

PTI, SHIMLA: The death toll in the flash flood that wreaked havoc in Himachal Pradesh's Kangra and Kullu on Wednesday has gone up to seven after the recovery of another body, officials said.

The body of a minor girl, identified as Murti Devi, was recovered near the river side in Bakshahal village in Kullu district, they said.

Murti, her father and

aunt were swept away in flash floods caused by cloudburst at Jeeva Nallah in Saini area on Wednesday. The girl's father and aunt have not been located yet.

Three people including Nand Lal, his daughter and sister were washed away in the deluge while trying to take away valuables from their homes at Rehla Bihal in Kullu district on Wednesday.

Police raid spas in TN, 18 women rescued
