PANJIM: The Enforcement Directorate (ED), Panjim Zonal Office, has provisionally attached immovable properties worth Rs 60.05 crore in connection with its ongoing investigation against Estevan D'Souza and others, under the provisions of the Prevention of Money Laundering Act (PMLA), 2002.

According to a statement from ED, the properties are held in the name of Rosa Maria D'Souza, grandmother of Estevan D'Souza. The attachment is in addition to an earlier Provisional Attachment Order (PAO) dated 8.11.2023, vide which properties worth Rs 11.82 crore

OAccording to a ED statement, it has attached properties in the name of Rosa Maria D'Souza, Estevan's grandmother

This attachment supplements a Provisional Attachment Order from November 8, 2023, which attached properties worth Rs 11.82 cr and was confirmed by the Adjudicating Authority on April 8, 2024

The newly attached assets include land parcels in Pilerne, allegedly acquired using forged sale deeds and fabricated affidavit-cum-NOCs

The ED probe stems from multiple FIRs filed by the Goa Police against Estevan and others for cheating and forgery related to illegal property transfers using fraudulent documents

fabricated affidavit-cum-No Objection Certificates (NOCs). ED initiated its probe on the basis of multiple FIRs registered by the Goa Police against Estevan D'Souza and others, under various sections of the Indian Penal Code, 1860, for offences including cheating and forgerv involving illegal transfer of property ownership using fake documentation.

ED investigation revealed that Estevan D'Souza played a key role in the alleged land scam, in collusion with Md Suhail and others. They are alleged to have orchestrated a systematic scheme involving the forgery and manipulation of land-re-

using forged sale deeds and lated documents, including sale deeds, to fraudulently acquire multiple high-value properties. These documents were then misrepresented as genuine to lend a façade of legitimacy to the

illegal transactions. In April this year, the Directorate of Enforcement (ED) had filed a prosecution complaint (PC) against Estevan D'Souza and others under the provisions of the Prevention of Money Laundering Act (PMLA), 2002, before the Special Court (PMLA), Mapusa , which had taken cognisance and later ED initiated investigation on the basis of chargesheet filed by Goa Police under various sections of IPC, 1860.

PANJIM: In a joint operation, the Old Goa Police along with Anti-Human Trafficking Unit (AHTU) of Kalimpong have arrested a native of Assam wanted in a human trafficking case in West Bengal.

West Bengal

According to police, the accused identified as Pinku Roy, was residing and working at a restaurant in Old Goa.

According to police, a woman from Kalimpong District filed a complaint stating Roy had entered into a contractual marriage with her in Bengaluru in 2023. The couple later shifted to Kalimpong, where they signed a simple marriage agreement, before moving to Kerala and then Karnataka.

On August 6, 2024, Roy, along with co-accused Prakash Shetty Arun (currently absconding), allegedly attempted to traffic her and her newborn child by trying to relocate them to an unknown destination without her knowledge. However, she managed to escape and filed a police complaint.

Based on the complaint, LSI Shanti Lama of AHTU Kalimpong, West Bengal, along with her team came to Goa, kept surveillance along with the Old Goa Police Station team. Later they nabbed the above accused in the case.

The accused was produced for transit remand before Judicial Magistrate First Class (JMFC), Merces, was remanded to seven-day transit custody.

The AHTU Kalimpong team will escort him back to West Bengal today for further investigation.

The petition's primary cause of action arises from a judgment of the Bombay High Court dated 24.07.2023, which directed the State government to notify the sanctuary and adjacent sanctuaries as a Tiger Reserve, following a recommendation from the National Tiger Conservation Authority (NTCA) under the Wildlife Protection Act. 1972.
