Expressing strong disapproval, they cited the heavy rains in July as an inappropriate time to begin such work. Residents confronted

the contractor, expressing their frustration that the digging began without prior intimation.

### Widows with minor kid eligible for Griha Aadhar, & pension scheme

PANJIM: The Social Welfare Minister Subhash Phal Dessai on Wednesday announced that widows with a child below 21 years are now eligible for both Griha Aadhar and Widow Pension Scheme.

Earlier, the widows had to cancel their Griha Aadhar benefits to avail Widow Pension Scheme but now they can receive both benefits by producing the birth certificate of their child.

Speaking to reporters at Mantralaya at Porvorim, he said the social welfare de-

partment has decided to give financial assistance to widows having child below 21 years under Griha Aadhar and Widow Pension Scheme.

"Widows will not have to cancel the Griha Aadhar as it will automatically stop on the day of sanction for the widow support scheme. She can directly apply for a pension of Rs 2,500 with the social welfare department and if she has a child, then additional support under Griha Aadhar will be given till the child reaches the age of 21. So in total, they will get Rs 4,000 per month," he said.
