Siddaramaiah says he will be Karnataka CM for 5 years

PTI, CHIKKABALLAPURA: Karnataka Chief Minister Siddaramaiah on Wednesday asserted that he will be in office for a full five-year term.

He said that the Congress party was united and the party's government will be in power 'solid as a rock' for five years.

'Yes, I will be. Why do you have the doubts?' Siddaramaiah said in response to a question by reporters whether he will be the CM for five years.

There has been speculation within political circles, especially within the ruling Congress, for some time now about the Chief Minister change later this year, citing power-sharing agreement involving Siddaramaiah and Deputy Chief Minister D K Shivakumar.

However, Shivakumar on Tuesday said there is no discussion on leadership change and stressed on strengthening the hands of CM Siddaramaiah and the party's government in the state.

Responding to a question on claims by the BJP and JD(S) leaders that the CM will be replaced, Siddaramaiah shot back, 'Are they our high command?'

WB BAR COUNCIL EXPELS GANG RAPE ACCUSED MONOJIT MISHRA

PTI, KOLKATA: The Bar Council of West Bengal on Wednesday decided to expel Monojit Mishra, the prime accused in the gang rape case, from its membership and struck off his name from its rolls. The state bar council, in a special general meeting, decided to strike off Mishra's name from its rolls of advocates in view of the allegation of the heinous crime against him, its chairman Ashok Deb told reporters here.

No linkages between Covid vaccine and heart-related deaths: Govt

PTI, NEW DELHI: In the wake of Karnataka Chief Minister Siddaramaiah linking heart-related deaths in Hassan district to Covid vaccine, the Union Health Ministry on Wednesday said extensive studies by ICMR and AIIMS have conclusively established no linkages between coronavirus vaccines and sudden deaths.

Siddaramaiah had on Tuesday said 'hasty approval and distribution' of the Covid vaccine to the public could also be a reason for these deaths.

He urged everyone to visit the nearest health centre immediately for a check-up if they have symptoms

such as chest pain or difficulty breathing, and not to ignore these signs.

The ministry said the matter of sudden unexplained deaths has been investigated through several agencies in the country and these studies have conclusively established that there is no direct link between COVID-19 vaccination and reports of sudden deaths.

Studies by the Indian Council of Medical Research (ICMR) and National Centre for Disease Control (NCDC) affirm that COVID-19 vaccines in India are safe and effective, with extremely rare instances of serious side effects, it said.

Punjab: Mohali court extends SAD leader Majithia's remand by four days

PTI, CHANDIGARH: A Mohali court on Wednesday extended by four days the vigilance custody remand of Shiromani Akali Dal leader Bikram Singh Majithia, who was arrested in a disproportionate assets (DA) case.

Majithia was produced before the court amid tight security after his seven-day vigilance remand ended on Wednesday.

Speaking to the media after a three-hour hearing, public prosecutor Ferry Sofat said the court extended Majithia's remand by four more days after the Vigilance Bureau (VB) filed an application.

Shubhanshu Shukla studies muscle loss in microgravity on board ISS

PTI, NEW DELHI: Astronaut Shubhanshu Shukla is conducting scientific experiments on board the International Space Station (ISS) to understand muscle loss under microgravity conditions, a study that could help create medicines to treat immobility among a section of the elderly.

Shukla is part of the Axiom-4 private space mission to the ISS as part of a joint ISRO-NASA initiative and docked at the orbital laboratory on Thursday last week along with three other astronauts.

'Shux (Shukla's call sign) performed operations in the Life Sciences Glovebox (LSG) for the myogenesis study, which could uncover how microgravity contributes to muscle loss,' Axiom Space said in a statement.

It said that by identifying the molecular pathways behind skeletal muscle dysfunction, the research could lead to targeted therapies to prevent atrophy during long-duration spaceflight.

These insights may also translate to improved treatments for muscle-wasting conditions on Earth, including those linked to ageing and immobility, Axiom Space said.

Shukla filmed a video targeted at young Indian students discussing how the digestive system adapts to space.

The crew documented activities for the Astronaut Mental Health study, contributing to research on cognitive well-being in space. Mission commander Peggy Whitson posted a photograph with Shukla and Hungarian astronaut Tibor Kapu in the space station on her social media handle.

Delaying financial support to spouse, kid akin to denying dignity: Delhi HC

PTI, NEW DELHI: Saying the delay in extending financial support to an estranged spouse and child was akin to denying dignity, the Delhi High Court has ordered a man to pay interim maintenance in a matrimonial case.

Justice Swarnan Kanta Sharma was hearing the man's plea against the family court's direction to pay a monthly sum of Rs 45,000 (Rs 22,500 each towards the interim maintenance of his estranged wife and minor daughter).

'Financial support delayed is dignity denied, and this court is conscious of the fact that timely maintenance is integral to safeguarding not only subsistence but the basic dignity of those who are legally entitled to such support,' the July 1 verdict read.
