#### Minor boy pushes teen to death from Mumbai building

MUMBAI: Police have registered a murder case against a minor boy after he allegedly pushed to death a 15-yearold girl from the terrace of a building in Mumbai and tried to pass it off as a suicide, an official said. The 16-yearold accused and the victim were friends. The girl was a student of an international school and resided with her mother in Mulund area. On June 24, the girl arrived at a housing society in Bhandup (West) area to meet the boy and discussed her academic stress with him, the Bhandup police official said on Tuesday. The boy then took her atop a water tank on the terrace of the building's D-wing. While they were chatting, their conversation turned into a heated argument about dating, the official said.

#### Medical college student beaten up by seniors, video goes viral

BHOPAL: A case has been registered here after a video showing some students of a private medical college here thrashing a junior student went viral on social media, police said on Wednesday. The incident took place on Monday evening, said Nishatpura police station in-charge Rupesh Dubey, adding that no arrest has been made yet. The complainant, a third year student of People's Medical College, was allegedly beaten up by Paras Jain and two others after Jain accused the complainant of sending objectionable messages to his family, the official said. While a First Information Report (FIR) was registered under relevant sections of the Bharatiya Nyaya Sanhita for assault, the accused also filed a counter-complaint of assault against the victim, he said.

#### Bengaluru: Infosys employee held for 'filming' woman in office washroom

**BENGALURU**: A 30-year-old Infosys employee was arrested on Wednesday for allegedly "filming" a female colleague inside the women's washroom at the company's Electronic City campus, police said. The accused, identified as Swapnil Nagesh Mali, a Senior Associate Consultant from Sangli, Maharashtra, was caught by HR personnel and handed over to the police. There was no immediate response from Infosvs on the incident. According to police, the incident occurred on Monday morning when the woman noticed a suspicious reflection and movement from an adjacent cubicle while using the washroom.

#### Tripura govt transfers Gomati, Dhalai DMs

AGARTALA: The Tripura government has transferred the district magistrates of Gomati and Dhalai, an official notification said. Gomati district magistrate Tarit Kanti Chakma will be the new chief executive officer (CEO) of Tripura Rural Livelihood Mission (TRML), it said. The Tipra Motha, an ally of the BJP government in the state has been demanding the transfer of Chakma as he had refused the meet the Tipra Motha supremo Pradyot Kishore Debbarama on May 30 when he visited his official residence. Rinku Lather additional district magistrate of Sepahijala will replace Chakma as the DM of Gomati district, the notification said.

BHUBANESWAR: A youth was killed by his childhood friend over a triangular love affair in Odisha's Bolangir district, police said. The deceased has been identified as Kunja Majhi, a resident of Dumerchuan village in Kantabanji area of the district. Two persons have been apprehended in this connection, they said. According to police, Kunja was killed by his childhood friend Satya Nag and his (Satya's) associate Shankar Gharsel on June 20 night following a dispute among them. Satya was using Kunja's mobile phone to talk to his girlfriend.

There were no known health issues, and the cause of death will be confirmed only after a post-mortem examination, sources further said. Kochayappan's playful nature and adorable mannerisms had made him a favourite, especially among children visiting the shelter.

# Siddaramaiah says he will be Karnataka CM for 5 years

PTI, CHIKKABALLAPU-RA: Karnataka Chief Minister Siddaramaiah on Wednesday asserted that he will be in office for a full five-vear term.

He said that the Congress party was united and the party's government will be in power 'solid as a rock' for five years.

'Yes, I will be. Why do you have the doubts?' Siddaramaiah said in response to a question by reporters whether he will be the CM for five years.

There has been speculation within political circles, especially within the ruling Congress, for some time now about the Chief Minister change later this year, citing power-sharing agreement involving Siddaramaiah and Deputy Chief Minister D K Shiva-
