

# Oppn MPs protest on Adani issue in Parl premises with 'jholas'

**PTI, NEW DELHI:** Several Opposition MPs on Tuesday demonstrated over the Adani issue in Parliament premises, carrying 'jholas' (bags) with caricatures of Prime Minister Narendra Modi and billionaire Gautam Adani printed on it and 'Modi Adani Bhai Bhai' written on the obverse side.

This is the latest in the series of unusual protests led by the Congress daily ahead of the sitting of Parliament in the morning.

Leader of Opposition in the Lok Sabha Rahul Gandhi, Congress general secretary Priyanka Gandhi Vadra, MPs from the Congress, DMK, JMM, Left, among others, protested in front of the Makar Dwar steps.

They were carrying dark blue 'jholas' with caricatures of Modi and Adani printed on one side and 'Modi Adani Bhai Bhai' written on the obverse side.

of the bag.

They raised slogans against alleged collusion between Modi and Adani and demanded a Joint Parliamentary Committee probe into the matter.

Earlier, Gandhi chaired a meeting of Congress MPs in the Lok Sabha to take stock of the party's stance on various issues and the way forward in Parliament.

The protest comes a day after leaders of some INDIA bloc parties protested

in Parliament complex over the Adani row, with Rahul Gandhi conducting a mock 'interview' over the issue with Congress members

wearing masks of Prime Minister Modi and industrialist Gautam Adani.

Standing in front of the Makar Dwar steps in Parliament premises, Leader of Opposition in the Lok Sabha Gandhi and Congress president Mallikarjun Kharge along with MPs of other opposition parties had on Monday raised slogans of "Modi, Adani ek hain" and "we want justice".

The opposition protests on the Adani issue have been taking place inside Parliament complex ever since the start of the winter session.

# Punjab Youth Congress holds protest over farmers' issues, unemployment

**PTI, CHANDIGARH:** Punjab Youth Congress held a protest here on Tuesday on issues related to farmers, unemployment and drugs, and targeted both the state and the central govts.

The Youth Congress leaders and workers were briefly detained by police when they tried to march towards the residence of Punjab Chief Minister Bhagwant Mann to gherao it.

Indian Youth Congress president Udai Bhanu Chib led the protest.

He said farmers are fighting for their rights and seeking a legal guarantee to MSP, but the Centre is not paying heed to their demands.

Targeting the Mann dispensation, he said, "We are also raising issues of unemployment and drugs." Punjab Youth Congress president Mohit Mohindra claimed there is great anger among the youth as

they are not getting jobs while the drug menace is increasing.

The Youth Congress workers raised the slogan - "Give justice to farmers and

jobs to the youth, not drugs". Mohindra said the Aam Aadmi Party government has "completely failed" in the promises made to farmers and the youth.

# 7 killed in truck-pickup vehicle collision in UP

**PTI, HATHRAS:** Seven persons lost their lives and 14 others were injured in a head-on collision between a container truck and pickup vehicle here on Tuesday, a senior official said.

According to police, the accident took place at the Jaitpur village under the Hathras Junction police station.

Hathras District Magistrate Rahul Pandey told PTI, "Seven persons have died in the accident. This includes three men, three women and a child." He added that seven injured persons are undergoing treatment at the district hospital in Hathras, while seven others have been referred to a higher medical centre for treatment.

Speaking to reporters, the DM said the pickup vehicle was going towards Etah and it collided head-on with a container truck.
