CITIZENS PLEDGE TO SAVE **OLD GOA'S HERITAGE**

Protest against mall proposed at the world heritage site; agitators urge govt to stop the project; VP to issue a stop-work notice soon

OLD GOA: Calling upon the State government to listen to the people and stop the proposed mall project at the world heritage site near the Basilica of Bom Jesus, citizens from across the State on Sunday protested at Old Goa and pledged to sacrifice their lives to protect Goa from destruction.

Citizens comprising residents of Old Goa, members of Save Old Goa Action Committee (SOGAC), activists, environmentalists and others alleged that the mall is being developed by the Tourism Department in spite of the fact that construction cannot be permitted within 100 metres of the heritage site.

Addressing around 700 citizens, Jacqueline Fernandes, a member of the SOGAC said, "There were several trees, but now only a few are left. The notice board put up here mentions development for parking. My question to the government is that if only a parking facility is being developed here then why so many trees are be-

Curfew lifted in Nagpur: Maha CM

PTI, NAGPUR: Curfew has been lifted in Nagpur as the situation in the city is completely peaceful, Maharashtra Chief Minister Devendra Fadnavis said on Sunday.

The CM was speaking to the media in the Pimpri Chinchwad area of Pune where he attended an event organised by the non-profit Paani Foundation.

"The situation in Nagpur is completely peaceful. There is no tension anywhere. People of all religions are living together peacefully. Hence, the curfew has been lifted," said Fadnavis, who is a legislator from the city.

Officials said earlier in the day that curfew had been lifted from the remaining four areas of Nagpur, six days after violence rocked the city.

Following the violence on March 17, curfew was imposed in Kotwali, Ganeshpeth, Tehsil, Lakadgani, Pachpaoli, Shanti Nagar, Sakkardara, Nandanvan, Imambada, Yashodhara Nagar and Kapil Nagar police station areas.

Mobs went on a rampage in central Nagpur on Monday night amid rumours that a 'chadar' with holy inscriptions was burnt during protests led by VHP and Bajrang Dal demanding the removal of Mughal emperor Aurangzeb's tomb located in Chhatrapati Sambhajinagar district.

Curfew was lifted from localities within the jurisdictions of Nandanvan and Kapil Nagar police stations on March 20.

Pope back home after 5-week hospital stay for life-threatening double pneumonia

AP, VATICAN CITY: A weak and frail Pope Francis has returned home to the Vatican from the hospital after surviving a fiveweek, life-threatening double pneumonia.

The motorcade carrying the 88-year-old pope entered the Perugino gate entrance to Vatican City, and Francis was seen wearing the nasal tubes to give him supplemental oxygen.

During the trip home from the Gemelli hospital, Francis took a slight detour to bring him to the St Mary Major Basilica, where his favourite icon of the Madonna is located and where he always goes to pray after a foreign visit. But it wasn't clear if he got out of the car, a white Fiat 500.

The Argentine pope, who has chronic lung disease and had part of one lung removed as a papacy and the second longest after surviving a five-week,

PONTIFF CALLS FOR 'IMMEDIATE' END TO ISRAELI STRIKES ON GAZA

AFP, VATICAN CITY: Pope Francis called Sunday for an "immediate" end to Israeli strikes on the Gaza Strip, and for the resumption of dialogue for the release of hostages and a "definitive ceasefire". "I am saddened by the resumption of the intense Israeli bombardment of the Gaza Strip, with so many deaths and injuries," Francis wrote in his Angelus prayer, which was published Sunday. "I ask that the weapons be silenced immediately and that the courage be found to resume dialogue so that all the hostages can be

freed and a definitive ceasefire reached," said Francis. "The humanitarian situation in the Gaza Strip is once again very serious and requires the urgent commitment of the conflicting parties and the international community," he said.

Sushant Singh Rajput death: CBI files two closure reports

PTI, NEW DELHI: The CBI has filed two separate closure



of Sushant Singh Rajput, one in the abetment to suicide case filed by his father, and another by the actor's rumoured girlfriend Rhea Chakraborty against his sisters, officials said.

The CBI submitted its findings on Rajput's father K K Singh's complaint in a closure report before a special court in Patna, while the closure report in the second case was submitted before a special court in Mumbai.

The courts will now decide whether to accept the report or order further probe by the agency, the officials quoted above said.

Chakraborty's advocate Satish Maneshinde hailed the closure report and thanked the CBI for "having thoroughly investigated every aspect of the case from all angles".

Rajput was found hanging from the ceiling of his apartment in suburban Bandra in Mumbai on June 14, 2020. His postmortem conducted at Cooper Hospital had concluded that the actor died due to asphyxia.

The CBI investigated the two separate cases -- filed by K K Singh with Patna Police accusing Chakraborty of abetment to suicide and siphoning off Rs 15 crore from the actor's accounts; and the second filed by Chakraborty in Bandra accusing Rajput's sisters of giving medicines to him on the basis of bogus prescription issued by a Delhi doctor.
