NOW, CONSTABLE WHO HELPED SIDDIQUI FLEE SLIPS OUT ON BAIL

Cops left red-faced as court grants bail pointing out that all sections slapped on dismissed IRBn constable Amit Naik are bailable and bail is his right

PANIIM: He was caught on camera unlocking the Crime Branch lockup and helping landgrab accused Siddioui alias Suleman Khan flee. On Saturday, seven days after he was arrested for his involvement in the fugitive's escape, constable Amit Naik himself slipped out of the police's grasp, with the CJM court granting him conditional bail.

In its bail order, the chief judicial magistrate pointed out that the former Indian Reserve Battalion (IRBn) constable had been slapped with only bailable sections and bail was his right. In effect, this means that even while filing the chargesheet against him, police had known that the door would be open for him to get bail. This, in an investigation that has seen Goa Police face intense scrutiny over how

a wanted man like Siddiqui could walk out of lockup and vanish into thin air. Now, the man who helped him do that is also out. Naik was arrested on December 13 was first remanded

in four days police custody and was later sent to judicial custody for ten days. Naik has been referred to the Institute of Psychiatry and



Human Bambolim, for mental health assessment and treatment after he attempted to commit suicide in the lockup. He has

already been dismissed from the service. On Friday, the Court had adjourned the hearing of the bail

application to Saturday. The Old Goa police in their say had opposed the bail application and sought custody of Naik to carry out fair and clear investigation into the land grabbing accused Suleman Khan escaping case.

Investigating officer PSI Suden Redkar had submitted that if Naik was released on bail he may threaten prime witnesses and it will hamper the whole investigation. He may also contact Siddiqui, the lawyer contended.

The Court ordered that Naik be released on a bail of Rs 25,000. Adv Kautuk Raikar argued on behalf of Naik and submitted that all the sections that he was booked under were bailable.

Meanwhile, the police custody of Hajaratasabh Bavannavar alias Hazrat Ali of Old Hubbali, who allegedly harboured Suleman in his car at Hubbali, was extended by three more days on Friday. He was arrested on December 14.

GOA POLICE RESPONSIBLE FOR SIDDIQUI'S ESCAPE: TANAVADE

PANJIM: Bharatiya Janata Party (BJP) State president and Rajya Sabha MP Sadanand Shet Tanavade on Saturday held the Goa Police responsible for Siddigui alias Suleman Khan's escape from the Crime Branch lock-up.

Tanavade said, "Police are to be held cent per cent responsible for Suleman's escape from the lock-up. There were lapses and the police have to find out how he escaped. It was their responsibility (to guard him)."

Labourer dies in stone crusher accident at Chimbel **Team Herald**

PANJIM: A labourer working at a stone crusher unit at Chimbel died after part of a crusher machine fell on him on Saturday morning.

The deceased was identified as 48-yearold Parshuram. The tragedy occurred when one part of the crusher machine gave way and fell on his head injuring him grievously. He was immediately shifted to the Goa Medical College and Hospital (GMC), Bambolim but died on the way, the police said.

The Old Goa police conducted the panchanama and sent the body to the GMC morgue for post-mortem examination.
