

Narrow escape for Odisha minister after his vehicle collides with truck

BHUBANESWAR: Odisha Food, Supplies and Consumer Welfare Minister K C Patra had a narrow escape on Friday after his car collided head-on with a truck at Barang in Cuttack district, police said. The incident took place at Sandhapur Square on the Banki Main Road when Patra was on his way to Bhubaneswar, they said. Though no one was injured in the accident, Patra's car suffered damages on the front portion, Inspector-in-Charge of Barang police station, Debendra Biswal, said. "The minister and his driver are unhurt and safe. He used another vehicle and returned to Bhubaneswar," Biswal said. The police have impounded the truck and detained its driver, the officer added.

3 cow smugglers held after encounter in UP's Meerut

MEERUT: Three suspected cow smugglers were arrested after an overnight encounter with police in Meerut's Bhavanpur area, officials said on Friday. One of the accused, Shoaib, was injured in police firing and taken to a hospital. Bhavanpur Police Station SHO Kuldeep Kumar Singh said the operation was launched after two cow heads were found in a vacant plot near Gokuldhama Society on June 1. On the intervening night of June 5 and 6, police intercepted three suspects on a motorcycle near Ladpura village, but they opened fire. In self-defence, the police fired in retaliation, he said. "Shoaib and his accomplices, Abdul Ahad and Shajid alias Fasil, were taken into custody. During interrogation, they confessed to slaughtering stray cattle after sedating them and selling the meat," he said. The accused have prior cases under the Cow Slaughter Act, Arms Act, and Gangsters Act. A country-made pistol and a numberless Pulsar bike were recovered, he added.

Kashmir rail link melts political divide

PTI, SRINAGAR: Political parties, cutting across affiliations and ideologies, Friday welcomed the Kashmir rail link inaugurated by Prime Minister Narendra Modi, hoping for a boost in trade and tourism in the valley. The ruling National Conference (NC) termed the rail link a good start. "It is a good start for us. It will help ease the difficulties we have faced in transportation, and tourism and other sectors," NC leader and MLA Pampore, Justice Hasnain Masoodi (ret'd), told reporters here. He also at the same time said the rights and constitutional guarantees of the people of J-K must also be

honoured. "The train has chugged, but the promises also need to be kept. The old promises, made when we joined hands with them, should be honoured," the former Lok Sabha MP said, referring to the promises made with the people of J-K at the time of accession. "This vehicle can only move forward well when both of its tyres - development and political aspirations - run well. Then only can the whole nation benefit," he added. PDP president Mehbooba Mufti welcomed the train to Kashmir, terming the project a culmination of what so many governments worked

on and capped by the Modi government. "We welcome the train. The work had been on for the past 40 years, ever since Indira Gandhi started the Jammu-Udhampur railway link in 1983. All governments have worked on this project, and Modi has completed it. It was very difficult, but he has done it, and people are happy with it," Mufti said. Reacting to the prime minister's address in Katra, the former Jammu and Kashmir chief minister said she was happy that Modi acknowledged the people's categorical denunciation of terrorism in the aftermath of the April 22 Pahalgam terror attack.

PM Modi to attend G7 Summit in Canada

PTI, NEW DELHI: Prime Minister Narendra Modi on Friday said he will be attending the G7 Summit later this month in Canada and that he looked forward to meeting his newly elected Canadian counterpart Mark Carney. PM Modi thanked Carney for an invite to the Summit, scheduled between June 15-17 in Kananaskis, in a telephone call he received from the Canadian prime minister. Modi said on X, "Glad to receive a call from Prime Minister Mark Carney of Canada. Congratulated him on his recent election victory and thanked him for the invitation to the G7 Summit in Kananaskis later this month. "As vibrant democracies bound by deep people-to-people ties, India and Canada will work together with renewed vigour, guided by mutual respect and shared interests.

44 stranded tourists evacuated from landslide-hit Chaten in north Sikkim

PTI, GANGTOK: A total of 44 stranded tourists were evacuated from Chaten in north Sikkim on Friday, from where they will be taken to Gangtok by bus, he said. Arrangements will also be made to bring back local residents who may still be stranded in the area, the official said. The administration continues to monitor the situation and remains committed to extending all necessary support to the disaster-hit region and its people, he said. Altogether, 63 stranded people, mostly tourists, were on Thursday evacuated by helicopters from Chaten, which was hit by a landslide earlier this week, the officials said. The evacuation operation was called off due to inclement weather and challenging terrain on Thursday. Three army personnel were killed, six soldiers went missing and several

others were injured after a landslide hit a military camp at Chaten on the evening of June 1. Efforts are underway to locate the missing soldiers.



ASSAM FLOOD SITUATION REMAINS BLEAK, OVER 5.6 LAKH AFFECTED
PTI, GUWAHATI/MORIGAO: The flood situation in Assam continued to be critical with over 5.6 lakh people reeling under the deluge in 16 districts, an official bulletin said on Friday. The toll in this year's floods and landslides stands at 21, with two more deaths reported on Thursday. Wildlife has also been affected with nearly 70 per cent of the Pobitora Wildlife Sanctuary in Morigaon district facing inundation, an official said. The Regional Meteorological Centre, Guwahati, has forecast thunderstorms and lightning at isolated places in 18 districts of the state for Friday.

SC allows NBE to hold NEET-PG 2025 exam on Aug 3

PTI, NEW DELHI: The Supreme Court on Friday allowed the National Board of Examination (NBE) to conduct on August 3, the NEET-PG 2025 exam in one shift in line with the top court's directions. A bench of Justices Prashant Kumar Mishra and Augustine George

Masih, which initially questioned the over two-month window sought by the NBE for holding the examination, said the board's plea appeared to be "bonafide". The top court, however, clarified no further time would be granted to NBE for holding NEET-PG 2025 examination.

The NBE referred to the May 30 order of the top court and said for holding the simultaneous examinations all over in one shift required about 1,000 examination centres. The plea said it would hold the examination, scheduled on June 15 between 9 am and 12.30 pm on August 3.
