

ILLEGAL LPG DECANTING OPERATION BUSTED AT SANCOALE

Civil Supplies Department seizes seven vehicles and 1,000 gas cylinders; probe reveals several domestic cylinders were underweight, while commercial ones were unsealed

VASCO: In a surprise inspection at Peacock Valley, Sancoale, Department of Civil Supplies and Consumer Affairs busted a large-scale illegal LPG decanting operation and seized seven vehicles and 1,000 gas cylinders.

The action was initiated based on a complaint from Tulshidas Dhabholkar, Assistant Director, Civil Supplies and Consumer Affairs, Mormugao taluka. Verna Police have since registered a case against the proprietor of Kadesh Gas Service, Pilar, and other individuals involved. Of the seven vehicles seized, six belonged to

the prime accused and one to an unidentified person.

During the inspection, authorities discovered approximately 1,000 LPG cylinders, comprising both domestic and commercial types from BPCL and HPCL. Investigations revealed that

several BPCL domestic cylinders were underweight, while commercial cylinders were unsealed and found to weigh more than their standard tare weight.

The accused were reportedly conducting illegal LPG decanting without

proper authorization or safety protocols, which presented a significant risk to public safety. Additionally, LPG cylinders were being stored and loaded at the location without any valid documents or permissions, disrupting the regular supply of this essential commodity.

Verna Police have registered the case under Bharatiya Nyaya Sanhita (BNS) 2023, the Petroleum Act, the Essential Commodities Act, 1955, and Explosives Act, 1884.

Verna PI Anand Shirodkar is investigating the case under the supervision of Mormugao DySP Gurudas Kadam.

Curti colony locals protest gutter widening work

Claim it has blocked access to their flats; want access restored immediately

PONDA: Tensions escalated on Wednesday at the old housing board colony in Curti, Khandepar, as residents protested the commencement of gutter widening work by a contractor, claiming that it has severely impacted their daily lives by blocking access to their flats within the Housing Board and threatened further agitation if their access is not restored by Thursday morning.

Expressing strong disapproval, they cited the heavy rains in July as an inappropriate time to begin such work. Residents confronted the contractor, expressing their frustration that the digging began without prior intimation.

A primary concern for the residents is the one-meter-wide trench, which is overflowing with water from the surrounding hills. There is a significant risk of children or adults ac-



cidentally falling into the gutter and being swept into the main nullah. Additionally, residents are concerned that the drainage pipes provided are too small for the width of the newly dug gutter.

The sudden digging work has also blocked the main entry and exit route for residents. They have warned of filing a formal complaint against the contractor, citing obstruction of a vital access road, public nuisance, potential endangerment during medical emergencies, and the risk posed to children by the open trenches. They claimed

that the situation has hindered their ability to go to work and conduct other daily routines, affecting their livelihoods.

Injured woman rescued from Navelim flat

MARGAO: A 32-year-old woman was rescued from her locked flat on the 7th floor of D Block, Supreme Colmorod Apartments, near Easy Buy Mall, Navelim by the Margao Police.

The police forced open the door and took the injured and unconscious woman to the hospital.

In other incidents, a tree branch fell near Santosh Garage at Vidyanagar, Borda, obstructing traffic. Fire personnel cleared the branch. Additionally, a bathroom geyser

caught fire in Flat No S-6, 2nd Floor, Ferrara Garden Phase II Apartment, near Apollo Pharmacy, Gogol, Margao. Fire personnel extinguished the remaining fire and inspected the site.

Widows with minor kid eligible for Griha Aadhar, & pension scheme

PANJIM: The Social Welfare Minister Subhash Phal Dessai on Wednesday announced that widows with a child below 21 years are now eligible for both Griha Aadhar and Widow Pension Scheme.

Earlier, the widows had to cancel their Griha Aadhar benefits to avail Widow Pension Scheme but now they can receive both benefits by producing the birth certificate of their child.

Speaking to reporters at Mantralaya at Porvorim, he said the social welfare de-

partment has decided to give financial assistance to widows having child below 21 years under Griha Aadhar and Widow Pension Scheme.

"Widows will not have to cancel the Griha Aadhar as it will automatically stop on the day of sanction for the widow support scheme. She can directly apply for a pension of Rs 2,500 with the social welfare department and if she has a child, then additional support under Griha Aadhar will be given till the child reaches the age of 21. So in total, they will get Rs 4,000 per month," he said.
