Drones, lasers and gliders banned around Kochi airport over safety concerns

KOCHI: Authorities on Monday banned the use of drones, laser beams, and other aerial devices within a five-kilometre radius of Kochi International Airport, citing serious safety concerns. The order was issued by Ernakulam District Collector N S K Umesh, who said that devices such as microlight aircraft, paragliders, hot air balloons, and unmanned aerial systems (UAS) pose a threat to aircraft flying in and out of the airport at Nedumbassery. The decision follows reports from the airport director and Ernakulam rural police chief, who flagged unauthorised flying activity near the runway and approach paths. They warned that such activity could interfere with the safe take-off and landing of aircraft.

10-year-old girl raped by coaching centre operator in UP

CHANDAULI: A coaching centre operator in Sahabganj area has been booked for allegedly raping a 10-year-old girl, police said on Monday. They said the incident allegedly took place on Sunday evening, when the girl had gone for tuition. Upon returning home, the girl informed her family members about the incident. Her father and uncle reached the coaching centre, where they were allegedly beaten up by Singh. Station House Officer Arjun Singh said the girl's mother lodged a complaint, based on which an FIR was registered. He said the girl has been sent for medical examination and efforts are on to nab the accused.

TN ADGP arrested in kidnap case following court directive

CHENNAI: The Madras High Court on Monday orally directed the Tamil Nadu police to arrest an ADGP ranked official in connection with a kidnap case and he was secured minutes later. Justice P Velmurugan gave the directive while hearing an anticipatory bail application filed by MLA M Jagan Moorthy, who apprehended arrest in the case. He represents Kilvaithinankuppam (SC) and heads an outfit. Assistant Director General of Police (ADGP) HM Jayaram (Armed Police) was arrested after he came out of the court building.

Security wall of residential building collapses in Thane; none hurt

THANE: A security wall of a residential building collapsed in Maharashtra's Thane city on Monday afternoon, a civic official said. There were no reports of injuries in the incident that occurred in the Lokmanya Tilak Nagar area around 2 pm, said Yasin Tadv, chief of the civic disaster management cell. He said the wall, approximately 5 feet high, collapsed, and the remaining section of the structure has been deemed dangerous. The affected area has been barricaded to prevent access and minimise any potential risk, the official said.

Rapido rider caught slapping woman passenger on camera in Bengaluru

BENGALURU: A Rapido bike taxi rider was caught on camera for allegedly slapping a woman passenger following an argument between them over rash driving, police said on Monday. The incident occurred on June 13 when the woman, who works as a saleswoman at a jewellery shop in Jayanagar, was en route to her workplace, they said. Owing to his alleged rash driving, she got off mid-ride and confronted him, leading to a heated argument between them. The woman reportedly also refused to pay the fare and return the helmet, police said. When contacted, Rapido preferred not to comment on the matter, citing it as a police case.

Nino Iralu sworn in as new Lokayukta of Nagaland

KOHIMA: Retired judge Nino Iralu was sworn in as the new Lokayukta of Nagaland on Monday. Iralu is the third Lokayukta of the state and succeeded Banuo Z Jamir, the former chief secretary of the state, who was appointed to the post in December 2022. Jamir had taken over the post after a long vacancy following the resignation of the state's first Lokayukta, Justice Uma Nath Singh, in February 2021. During the interim period, Upa-Lokayukta Mayang Lima had handled the responsibilities. The oath of office to Nino Iralu was administered by Chief Secretary J Alam, while Home Commissioner Anoop Khinchi initiated the proceedings. Iralu is a retired district and sessions judge.

2 officials of chopper firm booked for negligence in Kedarnath crash

PTI, DEHRADUN: Two senior officials of helicopter service operating firm Aryan Aviation Private Ltd have been booked for alleged negligence leading to the chopper crash near Kedarnath that killed all seven on board, including a two-year-old and the pilot.

The Bell 407 helicopter that crashed on Sunday due to bad weather in the forests of Gauri Mai Khark between Gaurikund and Triyuginarayan belonged to Aryan Aviation Private Limited.

A case has been registered against Aryan Aviation's accountable manager Kaushik Pathak and manager Vikas Tomar at Sonprayag police station under Section 105 of the BNS (culpable homicide not amounting to murder) and Section 10 of the Aircraft Act 1934 which deals with penalties for violating rules made under the Act, particularly those related to

HC ASKS GOVT TO CLARIFY POSITION ON RISING NUMBER OF CHOPPER CRASHES ON YATRA ROUTE

PTI, NAINITAL: Taking suo motu cognisance of the chopper crash near Kedarnath which killed seven people on board on Sunday, the Uttarakhand High Court on Monday asked the state government to clarify its position on how safe it was for pilgrims to travel by helicopters deployed for Char Dham Yatra. The division bench of Chief Justice G Narendar and Justice Alok Mehra of the high court also expressed concern over the rise in chopper crashes on the pilgrimage route, saying on May 8, another helicopter had crashed in Uttarkashi district claiming the lives of six people including the pilot. Keeping in mind five helicopter crashes on the route in the past two months killing 13 people, the court asked the government to clarify its position and file a reply before the court. Raising concern over the issue, the high court posed questions to the state government regarding the safety of pilgrims on the route. The court asked whether the helicopters being used for the Yatra were operating according to schedule and whether the norms were being followed.

The case was registered on the basis of a complaint

lodged by Revenue Police Sub Inspector Rajiv Nakholia posted at Phata, a small town located near the Himalayan temple.

The complaint states that

Aryan Aviation was allotted the first slot from 6 am to 7 am for helicopter operations on June 15, while this accident happened before that at 5.30 am.

In addition, despite the sky being cloudy and foggy since morning, the weather conditions were not checked before the helicopter took off.

The complaint states that the standard operating procedure (SOP) issued by the Directorate General of Civil Aviation (DGCA) and the Uttarakhand Civil Aviation Development Authority (UCADA) was ignored while the company managers knew very well that doing so could cause loss of life and property.

The complaint said by doing so, Aryan Aviation Pvt Ltd and its managers showed gross negligence towards their responsibilities, due to which the crash occurred.

Fresh caste survey in K'taka: BJP says Cong always betrayed OBCs

PTI, NEW DELHI: The BJP on Monday accused the Congress of always deceiving and betraying the Other Backward Classes following the Karnataka government's decision to junk an earlier caste survey in favour of a fresh count.

Union minister and BJP leader Bhupendra Yadav asked for fixing accountability, noting that over Rs 165 crore of public money was spent in carrying out the now-dumped caste survey.

Yadav claimed that the Congress has a history of betraying the OBC interests as he recalled that its governments at the Centre had ignored the Kaka Kalelkar Commission report on empowering the backward classes.

The party also opposed the Mandal Commission recommendations, he said.

Honeymoon murder: Victim's kin demand narco test on Sonam's parents, brother

PTI, INDORE: The elder brother of Raja Raghuvanshi, an Indore-based transport businessman murdered while honeymooning in Meghalaya, on Monday demanded a narco-analysis test on prime accused Sonam's parents and said the family suspects the involvement of more people in the killing.

Police have arrested five people, including Raja Raghuvanshi's wife Sonam (25) and her alleged lover Raj Kushwaha (20), for their alleged involvement in the 29-year-old businessman's murder last month. They are in the Meghalaya police's custody, and an SIT is probing the case.

INVESTIGATION IN RAJA MURDER CASE NOT JUST CONFINED TO LOVE TRIANGLE: DGP

PTI, SHILLONG: Meghalaya DGP Idashisha Nongrang on Monday said the investigators probing the murder of Indore businessman Raja Raghuvanshi in Sohra were not treating the love triangle as the only motive, and they are looking into various other angles. Raja was hacked to death on May 23 while honeymooning in the Northeastern state. His wife Sonam, her boyfriend Raj and three hitmen were arrested in connection with the murder on June 9. "We are investigating whether there is anything more to this case. It is unusual that within a few days of marriage, she (Sonam) would develop so much animosity against her husband," Nongrang told PTI. "We are exploring all possible angles for this murder to have taken place. We have enough evidence, and loose ends are being tied up. We have a solid case," she added.

Govind and sister-in-law."

Sonam is accused of getting her husband killed during their honeymoon with the help of Kushwa-

ha and three others, in a case which has sent shockwaves across the country.

The other three accused, Vishal Chauhan, Akash Rajput and Anand Kurmi, were initially suspected to be hired killers, but the police later found they were friends of Kushwaha.

Vipin Raghuvanshi said, "New videos related to the murder are surfacing

one after the other. We believe more people might be involved in my younger brother's killing."

He also demanded that people who posted these videos on social media also be questioned and asked why they had not released the footage earlier.

He, however, expressed satisfaction with the Meghalaya police's probe.

Heavy rains lash Mumbai

local trains, metro services affected

PTI, MUMBAI: Incessant rains lashed Mumbai on Monday morning, inundating low-lying areas and disrupting road traffic, suburban trains and metro rail services, officials said.

The India Meteorological Department (IMD) has forecast cloudy skies with the possibility of heavy rainfall at a few places in the city and suburbs in the next 24 hours.

According to civic officials, the island city recorded an average rainfall of 95 mm, while the eastern and western suburbs recorded 58 and 75 mm rainfall, respectively, in 24 hours, ending at 8 am.

A high tide of 4.21 metres is expected at 3.31 pm, followed by another high tide of 3.44 metres at 3.31

am on Tuesday. A low tide of 1.86 metres will occur at 9.41 pm, while a low tide of 1.33 metres is forecast at 9.10 am on Tuesday.

The city and suburbs witnessed incessant rainfall, with intermittent spells of heavy showers that caused water-logging in several low-lying areas, officials said.

Suburban train services on the Central and Western Railway were also running late.

Some passengers claimed the Central Railway services were delayed by 20 to 30 minutes during the morning rush hour.

The metro service on the Ghatkopar-Andheri-Versova line was briefly disrupted in the afternoon after a plastic sheet fell on overhead wires at Azad Nagar station.
