"No fear of the law," say stakeholders; trafficking, kidnapping and rapes shock Goans; two rapes in two days in the middle of the poll campaign haven't been enough to make this a campaign issue

Amidst the din of day-to-day campaigning, speeches and allegations and counter allegations, during any elections, what gets missed out are the issues that people live with each day.

Some issues may be local and State issues, while others deserve national attention. But even the smallest of problems can get solved if they are magnified at the highest levels.
